INDEPENDENT AUDITORS' REPORT

To the Trustees of

Opinion

We have audited the accompanying financial statements of Citadel Care Centers Medical Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended April 30, 2025, and the related notes to the financial statements (the financial statements).

- 1. DESCRIPTION OF PLAN:** The following description of the Citadel Care Centers Medical Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan provides health benefits to eligible employees and covered dependents. Certain plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is available to regular full-time employees (with coverage beginning on the first day of the month following 60 days of full-time employment) of Citadel Care Centers and certain participating companies (collectively referred to as the Participating Companies) that are members of a controlled group pursuant to Section 414 of the Internal Revenue Code (IRC).

At each annual enrollment, provisions, such as participant contribution rates, coverage, deductibles, copays, and out-of-pocket maximums, may change.

Benefits

The Plan provides health benefits including coverage for medical and prescription drugs. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-Insured Benefits

All plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants using funds received from the Plan's trust or the general assets of the Participating Companies. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Participating Companies make contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Participating Companies on a pay-as-you-go basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by either the Participating Companies or the plan trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Plan obligations at year-end for health claims incurred by active participants but not reported at that date are reported in the accompanying statement of benefit obligations.

Stop-Loss

Premiums for stop-loss insurance are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Stop-loss reimbursements totaling \$388,029 have been netted against claims paid.

Rebates

Rebates due from the Plan's PBM are recorded when earned. Rebates due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid.

Subsequent Events

Management has evaluated subsequent events through January 28, 2026, the date which the financial statements were available to be issued.

3. CLAIMS INCURRED BUT NOT REPORTED:

Plan obligations at April 30 for claims incurred but not reported are estimated by the plan administrator based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. ADMINISTRATIVE EXPENSES:

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. Such transactions are party-in-interest transactions under ERISA. Administrative expenses paid by the Participating Companies on behalf of the Plan are excluded from these financial statements.

5. TAX STATUS:

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated May 15, 2020, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded during the year for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles general accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain tax position that more likely than not would not be sustained upon examination by the relevant taxing authorities.

6. TERMINATION OF THE PLAN: Although it has not expressed any intent to do so, the Participating Companies have the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Participating Companies or be used for purposes other than for the exclusive benefit of the Plan's participants.

7. RELATED-PARTY TRANSACTIONS: Citadel Consulting Group, LLC, a related party with common management and control, provides the Plan with certain accounting and administrative services. During the year ended April 30, 2025, the Plan paid \$272,946 in fees for these services.

Claims and premiums that have been processed and approved for payment at year-end but not paid and claims incurred but not reported are not considered liabilities under GAAP and, therefore, are not presented as liabilities or claims and premiums paid in the accompanying financial statements but are recorded on the Form 5500 as a liability.

9. CONCENTRATIONS: At times, the Plan maintains cash balances in excess of the Federal Deposit Insurance Corporation's insured limits. Financial instruments that subject the Plan to concentrations of credit risk include cash on deposit with a financial institution that is not federally insured or otherwise collateralized. Therefore, the Plan may be exposed to credit losses in the event of non-performance by the financial institution. The Plan has not experienced such losses.

10. RISKS AND UNCERTAINTIES: On occasion, the Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
