Opinion

We have audited the accompanying financial statements of the Eastern Missouri Concrete, LLC 401(k) Profit Sharing Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of January 31, 2024 and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to January 31, 2024, and the related notes to the financial statements.

NOTE 1 — DESCRIPTION OF PLAN

The following description of the Eastern Missouri Concrete, LLC 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Eastern Missouri Concrete, LLC (the Company). Generally, employees (excluding those covered by a collective-bargaining agreement) are eligible to participate in the Plan at age 21 and 12 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 8, 2024, the Plan was amended and restated to adopt the BMC Multiple Employer 401(k) Plan. Total assets of \$1,791,549 were transferred into the BMC Multiple Employer 401(k) Plan on January 17, 2024.

Contributions

Participants may contribute up to 92% of annual eligible compensation, as defined in the Plan, and may designate a portion or all of their elective deferrals as Pre-tax or Roth elective deferrals. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also transfer funds to the Plan from other qualified retirement plans (rollover).

The Company provides a safe harbor nonelective contributions of 3% of the participants' eligible compensation for the Plan year.

The Company may also make an annual discretionary profit sharing contribution to the Plan. Contributions are allocated to eligible participants' account based upon the ratio that each participant's eligible compensation bears to the total eligible compensation paid to all participants. Participant must have 500 hours of service and be actively employed at the end of the Plan year to receive the profit sharing contribution.

Contributions are subject to certain IRS limitations. Participants elect investment accounts in which their contributions, as well as employer contributions, are invested. The investment account options comprise various degrees of risk and return.

Participant Accounts

Each participant's account is credited with the participant's contribution and safe harbor matching contributions, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Loans

Participants may not borrow from their accounts.

Vesting

Participants are vested immediately in their elective deferral contributions, rollover contributions and safe harbor contributions. Vesting in the Company's profit sharing portions of their accounts, is based on years of service as follows:

Participants become fully vested upon death, total and permanent disability, and early retirement date.

Payment of Benefits

Participants or their designated beneficiaries are entitled to receive the vested amounts credited to their accounts upon normal retirement at age 65, cessation of employment, disability, or death. Benefits may be distributed in the form of cash or annuities. In-service distributions are permitted from all vested amounts when a participant has attained the age of 59 ½.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are subject to specific statutory and regulatory requirements.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from participants and the associated employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Plan expenses primarily consist of recordkeeping fees. Fees related to the administration of payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements.

Subsequent Events

Subsequent events were evaluated through February 7, 2026, which is the date the financial statements were available to be issued.

NOTE 3 — INFORMATION CERTIFIED BY TRUSTEE

Information related to investments held at December 31, 2023, disclosed in the accompanying financial statements, were obtained or derived from data provided to the plan administrator and certified to as complete and accurate by Mid Atlantic Trust Company, the trustee.

NOTE 4 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which level 1 inputs were not available. Level 3 inputs would only be used if level 1 or level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodology used at January 31, 2024 and December 31, 2023.

Mutual funds: Valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

NOTE 7 — TAX STATUS

As this Plan is a pre-approved defined contribution plan, the IRS issued an opinion letter dated December 31, 2018, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this plan document will be considered to have a plan qualified under code Section 401(a) of the Internal Revenue Code (IRC) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement.

The Plan is subject to examination by the Internal Revenue Service for the statutory period.

NOTE 8 — RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
