Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Griffin Ford, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Griffin Ford, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Notes to Financial Statements

Note 1: Description of Plan

The following description of the Griffin Ford, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all nonunion employees of Griffin Ford, Inc. and certain affiliated companies who have elected to participate in the Plan (collectively referred to as the "Company") who have completed one year of service, as defined by the plan document, and are age 21 or older. Participants enter the Plan semi-annually on January 1 or July 1 after meeting the service and age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Management of the Company is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

Participants may elect to have up to 100% of annual eligible compensation (as defined by the plan document) on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also allows participants to roll over distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary matching contribution to participants. In 2024, the discretionary matching contribution made by the Company equaled 25% of the first 4% or first 6% of eligible compensation contributed by the participant depending on the applicable company at which the participant is employed. Rollover contributions are not matched. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

The Plan also includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate rate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Automatically enrolled participants will have their deferrals automatically increased by 1% on the first day of each plan year up to a maximum deferral of 10%, unless a different election is made by the participant.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's discretionary matching contributions and allocations of (a) plan earnings (losses) and (b) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participant contributions (including rollover contributions), plus actual earnings thereon, are 100% vested at all times. Vesting in the Company's discretionary matching contributions and actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% each year beginning with the second year of service. Participants become fully vested after six years of continuous service. In the event of normal retirement at age 65 or thereafter, permanent disability, or death, participants' accounts become 100% vested.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are allowed to have one note outstanding at a time. Note terms shall not exceed five years unless the note proceeds are used to purchase a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the date of issuance. Interest rates on existing notes at December 31, 2024, ranged from 4.50% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Plan benefits are available at normal retirement (age 65), disability retirement, hardship withdrawal (if certain criteria are met), death, or termination of employment with vested interest. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time. Participants receive benefits in the form of a lump-sum payment. Terminated participants with balances less than \$1,000 are automatically cashed out in a lump-sum payment.

Forfeitures

Plan forfeitures arise as a result of participants terminating service with the Company before becoming 100% vested in Company contributions. Total forfeited nonvested accounts were \$20,322 and \$18,537 at December 31, 2024 and 2023, respectively. Forfeitures may be used to reduce Company discretionary matching contributions. During the year ended December 31, 2024, the Company used \$4,639 of forfeitures to reduce Company matching contributions.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

At December 31, 2024 and 2023, amounts payable to participants totaling \$31,389 and \$68,389, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The excess contributions were distributed to the applicable participants prior to March 15 of the subsequent year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Note 2: Summary of Significant Accounting Policies (Continued)

Administrative Expenses and Investment Advisory Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment advisory fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment income. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. All other expenses paid by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses. Certain investment-related expenses are allocated proportionately to plan participants based on their respective balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Subsequent Events

The Plan has evaluated subsequent events through November 6, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at NAV as determined by the issuer of the common collective trust based on the fair value of the underlying investments. The objective of the stable value fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive payments. The fund primarily invests in a variety of investment contracts, such as guaranteed investment contracts ("GICS"), synthetic GICS, and collective investment trusts issued by insurance companies and other financial institutions. Investments in the common collective trust can be purchased and sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments, and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC ("Ascensus"), as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, the custodian of the Plan.

Note 5: Party-In-Interest Transactions

Certain plan investments are managed by Vanguard Group, Inc. ("Vanguard"). Vanguard has subcontracted the recordkeeping and custodianship of the Plan to Ascensus and, therefore, transactions with Vanguard and Ascensus qualify as party-in-interest transactions. Fees paid to Vanguard for administrative expenses were \$23,981 for the year ended December 31, 2024. The 401k Investment Professionals, LLC provide investment advisory services to the Plan and, therefore, transactions with 401k Investment Professionals, LLC qualify as party-in-interest transactions. Fees paid to 401k Investment Professionals, LLC for investment advisory services were \$42,412 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020 which states the document, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan document has been amended since receiving the notification letter, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income tax has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
