We have performed an audit of the financial statements of Boston Proper, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The following brief description of the Boston Proper, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan was adopted by Boston Proper, LLC (the Company) effective January 1, 2019, and was restated effective June 15, 2022, to provide deferred tax benefits to eligible employees. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

All active employees of the Company are eligible to participate upon attainment of age 18 and 3 months of service; however, employees covered by a collective bargaining agreement and non-resident aliens are excluded from participating. The entry date is as soon as administratively feasible following satisfaction of the eligibility requirements.

Contributions

Each year, participants may elect to contribute, on a pre-tax basis or after-tax basis (Roth) contributions up to 100% of their eligible compensation to the Plan, as defined in the Plan document, up to the maximum limits of the IRC. In addition, eligible employees who have attained age 50 before the close of the Plan year are permitted to make catch-up contributions. Newly hired employees who become eligible to participate in the Plan are automatically enrolled at 6% of their compensation unless they elect not to participate in the Plan or elect a different percentage, with no annual automatic increases. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes a safe-harbor matching contribution determined and calculated at the end of the Plan year. During the period ended December 31, 2024, the Company's safe-harbor matching contribution was 100% up to 3% of the participant's deferrals, and 50% of the next 2% of the participant's deferrals. A true-up contribution will be owed to any participant who did not receive a safe-harbor match based on matched employee contributions or Plan compensation for the entire period selected. Also, the Company may, in its sole discretion, make a matching contribution and/or a non-elective contribution to the Plan. There were no matching or non-elective contributions made to the Plan during 2024 (collectively Company contributions).

Participant Accounts

Each participant's account is credited with the participant's elective deferrals, Company matching contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions, as well as all Company contributions, plus actual earnings (losses) thereon.

1. Description of the Plan (cont.)

Forfeitures

Forfeited balances are used to reduce future Company contributions and to offset Plan expenses. At December 31, 2024 and 2023, there was no forfeiture balance. During the year ended December 31, 2024, no forfeited funds were used to pay expenses and fund Company contributions.

Payment of Benefits

Participant accounts may be withdrawn upon retirement, death, disability, attainment of normal retirement age of 65, or termination of employment as a lump-sum. Account balances less than \$5,000 are distributed as a lump-sum payment or rolled over to an individual retirement plan designated by the Plan administrator. Hardship distributions are available from all accounts and rollover contributions may be distributed any time.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of Net Assets Available for Benefits and Changes therein. Actual results could differ from those estimates.

Investment Valuation and Income (Loss) Recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price).

Purchases and sales are recorded on a trade-date basis. Interest income (loss) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

Contributions

Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Plan Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan adoption agreement. Certain other administrative expenses of the Plan are paid by the Company. Investment fees are paid by the Plan in the form of reductions of net investment income (loss) earned by Plan participants.

2. Summary of Significant Accounting Policies (cont.)

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Inspira Financial Trust, LLC, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below.

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) sponsored by CCH Incorporated dba ftwilliam.com (ftwilliam.com). The Internal Revenue Service (IRS) has opined and informed ftwilliam.com by a letter dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. The recordkeeping and trustee functions for the underlying investments held by the Plan are performed by Betterment and Inspira Financial Trust, LLC, respectively. Usual and customary fees were paid for investment management services. These transactions, as defined by the Plan, qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules. Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

8. Risks, Uncertainties, and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants account balances, and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 21% and 24% of the Plan's investments were invested in the Vanguard FTSE Developed Markets Fund and Vanguard Total Stock Market ETF Fund, respectively. At December 31, 2023, approximately 21% and 26% of the Plan's investments were invested in the Vanguard FTSE Developed Markets Fund and Vanguard Total Stock Market ETF Fund, respectively.

9. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

10. Delinquent Participant Contributions

During 2023, 2022, and 2021, employee withholdings of \$15,556, \$88,909 and \$36,549, respectively, were not remitted within the appropriate time period by the Company. The Company remitted \$15,556 of the 2023 delinquent contributions to the Plan during 2023, \$88,909 of the 2022 delinquent contributions were remitted to the Plan during 2022, and \$36,549 of the 2021 delinquent contributions were remitted to the Plan during 2021. Lost earnings for all years were remitted during 2024. These transactions constituted prohibited transactions as defined by ERISA.

11. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through January 23, 2026, the date the financial statements were available to be issued, and has determined that, except for the matters noted below, no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.

Additionally, a loan provision was added to the Plan that allows a participant to borrow the lesser of \$50,000 or 50% of his or her vested account balance. Loans are repayable through payroll deductions and are secured by the Participant's account balance. The interest rate is determined by the Plan administrator based on prevailing market conditions and is fixed over the life of the note. Loans are repaid over a period not to exceed five years.
