To the Plan Administrator of the Wilbanks Trucking Services, LLC 401(k) Profit Sharing Plan:

## **1. Description of Plan**

The following description of Wilbanks Trucking Services, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established effective January 1, 2016, and restated July 24, 2023. The Plan covers all employees of Wilbanks Trucking Services, LLC (the Company or Employer), excluding leased employees, members of a collective bargaining agreement, non-resident aliens who receive no compensation from the Employer which constitutes U.S. source income. Employees must complete three months of service and attain age 18 or older to be eligible to participate in the Plan. Additionally, participants must complete 1,000 hours of service during the year and be employed, as of year end, to be eligible to receive discretionary Company match and profit sharing contributions. Long-term, part-time employees who met eligibility requirement under SECURE Act are also eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrative Committee is responsible for oversight of the Plan. The Plan Administrative Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective July 24, 2023, the Plan was amended and restated to allow in-service distributions of all or any portion of the participant's vested account balance after attaining the age of 59 1/2.

Effective October 31, 2024, the Plan was amended and frozen to new participants, employee contributions and any employer contributions. Under the amendment, participants with unvested employer contributions and matching contributions became fully and immediately vested.

### Contributions

Effective October 31, 2024, both participant and employer contributions were temporarily suspended. Prior to October 31, 2024, the following Plan provisions were in effect:

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employees may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover), even prior to meeting eligibility requirements. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan allows for the Company to contribute discretionary matching and profit sharing contributions, in amounts to be determined by the Company. There were no discretionary Company contributions for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Effective October 31, 2024, participants with unvested Company contributions became fully and immediately vested. Prior to October 31, 2024, the following Plan provisions were in effect:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after one year of credited service and continues to vest in increments of 20% until 100% vested after five years of credited service.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,375 and \$25,574, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, plan administrative expenses were reduced by \$13,766, from forfeited nonvested accounts, in accordance with plan provisions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loans bear an interest rate of the prime rate, plus 1%. Principal and interest are paid ratably through payroll deductions. Terms range up to 5 years, or 10 years for the purchase of a primary residence.

Benefits Paid to Participants

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum payment. In addition, the Plan allows a participant to request a withdrawal upon attainment of age 59 ½ and allows for hardship distributions, if certain criteria are met.

**2. Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

*Contributions*

Contributions from plan participants and employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

### Recent Accounting Standards

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective through the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 did not have material effect on the Plan's financial statements.

### Subsequent Events

Subsequent events were evaluated through February 10, 2026, the date the financial statements were available to be issued.

Effective March 30, 2025, the Plan was amended to unfreeze contributions and participant eligibility.

## **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, Fair Value Measurement, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investments measured at net asset value:* Consisting of a common-collective trust, valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the trustee reserves the right to temporarily delay withdrawals from the trust in order to ensure the securities liquidations will be carried out in an orderly business matter.

(a) The common collective trust consists primarily of a diversified portfolio of benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money market funds. The objective of this investment category is preservation of capital.

**4. Concentrations**

As of December 31, 2024 and 2023, the Plan had investments of \$1,225,674 and \$1,041,238, respectively, that were concentrated in four and three investments, respectively.

**5. Information Certified by Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Matrix Trust Company (Custodian), the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

#### ***6. Related-Party and Party In Interest Transactions***

The Plan paid expenses to certain service providers, related to Plan operations and investment activity. These transactions are party in interest transactions. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### ***7. Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### ***8. Tax Status***

The Plan adopted a pre-approved plan offered by Retirement Direct LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### ***9. Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### ***10. Delinquent Participant Contributions***

For the years ended December 31, 2017-2024, the Company did not remit certain participant contributions and loan repayments to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$1,248,263, were not corrected in 2024.

### ***11. Qualified Nonelective Contributions Receivable and Excess Contributions Payable***

The Plan failed nondiscrimination testing for the years 2018 through 2020. As a result, corrective distributions, to certain participants, for excess contributions were required for those years. Excess contributions for the 2020 testing were distributed, within IRS guidelines, by March 15, 2021. Corrective distributions for the, 2018 and 2019 testing, remain outstanding at December 31, 2024 and 2023. Accordingly, excess contributions payable in the amounts of \$105,748 are recorded as a liability in the accompanying Statements of Net Assets Available for Benefits, as of December 31, 2024 and 2023.

As excess contributions for the Plan years 2018 and 2019 were not distributed, within IRS guidelines, they are subject to further corrective measures. The Company elected to correct the delinquent excess contributions, utilizing the one-to-one corrections method, under the IRS Voluntary Correction Program. In utilizing the one-to-one method, the Company will make the required distributions and contribute the same dollar amount, in the form of a qualified nonelective contribution (QNEC), to be allocated to non-highly compensated employees. The Company is working to complete the corrections and has not funded the QNEC as of December 31, 2024. Accordingly, a qualified nonelective contributions receivable, in the amount of \$142,404, is recorded at December 31, 2024 and 2023.

### ***12. Department of Labor Correspondence***

On August 1, 2022, the Plan received written notification from the DOL indicating that the Form 5500 annual reports for the years ended December 31, 2019 and 2020 had been rejected due to the absence of an Independent Qualified Public Accountant report. Subsequent communications from the DOL in 2022 and 2023 addressed the assessment of penalties related to these incomplete filings.

The Plan Sponsor completed and submitted the corrected filings on:

- June 14, 2024, for the year ended December 31, 2019
- March 19, 2025, for the year ended December 31, 2020

Following these submissions, the Plan Sponsor received an Order of Dismissal from the DOL on May 9, 2025, formally resolving the matters related to the 2019 and 2020 filings.

In late 2024, the Plan Sponsor received additional communications from the DOL regarding proposed penalties for incomplete Form 5500 filings for the years ended December 31, 2021 and 2022. As of August 22, 2025, the Plan Sponsor obtained a grant of stay for these filings and intends to complete and submit the required documentation prior to the expiration of the stay period.

The Plan Sponsor completed and submitted the corrected filings on October 13, 2025, for the years ended December 31, 2021 and December 31, 2022, and are awaiting review of those filings by the Department of Labor.

On January 7, 2026, the Plan Sponsor completed and submitted the Form 5500 filing for the year ended December 31, 2023, through the DOL Delinquent Filer Voluntary Compliance Program.
