INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of [Ozarks Healthcare 403\(b\) Plan](#) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 and 5 to the financial statements, are complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. 1. Description of the Plan

The following description of the Ozarks Healthcare 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions, which is available from the plan administrator.

General

The Plan is a defined contribution plan covering employees of Ozarks Healthcare (the “Organization”). Employees who normally work more than 20 hours per week are immediately eligible to participate in the Plan upon commencement of employment with the Organization. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). AIG Federal Savings Bank and AIG Retirement Services Inc., which includes The Variable Annuity Life Insurance Organization, (collectively “AIG”) and Matrix Trust Company serve as plan custodians.

Contributions

Participants are permitted to contribute to the Plan by making an elective deferral up to the maximum percentage allowable by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution 403(b) plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization contributes 50 percent up to the first 6 percent of base compensation that a participant contributes to the Plan. In order to receive employer matching contributions, employees must be eligible to participate in the Plan and have completed one calendar year with the Organization and effective January 1, 2024, be an active employee on the last day of the plan year. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Organization’s matching contributions, as well as allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their employee contribution plus actual earnings thereon. Vesting in the Organization’s contribution portion of their accounts is based on the following schedule:

One year of service	20%	vested
Two years of service	40%	vested
Three years of service	60%	vested
Four years of service	80%	vested
Five years of service	100%	vested

Vesting (continued)

However, exceptions apply to participants who were hired prior to January 1, 2002, which follow a different vesting schedule, and those who reach normal retirement age prior to termination of employment, which become fully vested at that time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by a portion of their account balance, which represents 100 percent of the outstanding loan balance. The loan interest rates, determined quarterly, ranged between 4.25 percent and 9.5 percent as of December 31, 2024. Principal and interest are paid in equal monthly, bi-weekly, or quarterly payments. If the plan administrator determines a note to be in default, generally for nonpayment, the note will be considered a taxable deemed distribution under the terms of the Plan. The note will be offset in the participant's account upon the occurrence of a distributable event under the Plan. Pending final distribution of the note, the participant remains obligated for any unpaid principal and accrued interest.

Payment of Benefits

Upon termination of service, an employee's vested benefit which does not exceed \$5,000 may be distributed in a single lump-sum payment. Participants whose vested benefit exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of their account, installments over a period not more than the participant's assumed life expectancy (or assumed life expectancy of the participant and his beneficiary) or a different form of annuity.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested account balances were \$77,105 and \$23,160 respectively. These accounts were used to reduce future employer contributions in 2024 by \$47,715 and by \$160,825 in 2023.

Hardship withdrawals

The Plan permits distributions made on account of hardship only if the distribution both is made on account of an immediate and heavy financial need and is necessary to satisfy the financial need, as defined by the Plan. The hardship distribution may not exceed the amount of the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are presented in accordance with U.S. generally accepted accounting principles (U.S. GAAP), using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

3. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. Where quoted market prices are available in an active market, securities are classified within level 1 of the valuation hierarchy. Level 1 includes the registered separate accounts valued at the contract value of the shares owned by the Plan at year end based on the quoted market price of its underlying mutual fund investments, adjusted for dividends and separate account fees. Contract value is considered to be the same as fair value. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. These are considered level 2 investments. In certain cases where level 1 or level 2 inputs are not available, securities are classified within level 3 of the hierarchy. The Plan is not currently invested in any level 2 or 3 investments.

6. Fully Benefit-Responsive Investment Contracts

The Plan holds an unallocated annuity contract that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. This contract is considered a traditional investment contract since the Plan does not own the underlying assets. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 2 percent for December 31, 2024 and 2023. The crediting rate is declared monthly with interest credited on a daily basis at an annual effective rate.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code for the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contract.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on completing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contracted issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreement without consent of the issuer.

7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. The amounts pledged as collateral at December 31, 2024 and 2023, was \$671,250 and \$775,449, respectively. Of the amounts pledged as collateral, \$291,557 and \$373,624 was related to loans that are considered in default at December 31, 2024 and 2023, respectively. A participant will be considered to be in default with respect to a loan if any scheduled repayment with respect to such loan is not made or an automatic after-tax payroll deduction arrangement is not maintained. As the Plan still holds the assets of the participants associated with the defaulted notes, these amounts are considered to be plan assets. Any balance at the end of a loan term is considered a taxable distribution. This is also applicable sooner if loan is in default. A default will be considered a deemed distribution which is a taxable event under the terms of the Plan. At such time that the participant has a distributable event, the amount of the defaulted collateral balance plus any accrued interest will be deducted from their account prior to distribution.

8. Plan Termination

Although it has not expressed an intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. Plan Tax Status

The Plan adopted a Volume Submitter 403(b) Plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on April 5, 2018, which stated that an eligible employer that adopts this plan may rely on this letter with respect to the satisfaction of its plan under Code section 403(b) with certain exceptions. The Plan was restated by adopting the OneAmerica Financial Partners, Inc. 403(b) Volume Submitter Plan effective July 15, 2022, which received a favorable advisory letter from the IRS. The Plan is required to operate in conformity with the terms of the plan to maintain the tax-exempt status for plan participants under Section 403(b). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and therefore not subject to tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that is more likely that not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Party-In-Interest Transactions

Certain investments in the Plan are managed by Variable Annuity Life Insurance Company (VALIC), a custodian of the Plan, and therefore, the transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation/depreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Revenue sharing totaled \$15,805 in 2024 and \$21,690 during 2023.

Certain administrative functions of the Plan are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

The Plan sponsor reimbursed the plan for lost earnings during 2024 through 2026.

14. Separated Participants

At December 31, 2024, \$45,651 of the net assets available for benefits were for those participants who have separated from active service with the Plan sponsor with a balance of less than \$7,000 and are due for an automatic distribution in accordance with the plan document.
