Report on the Financial Statements

Opinion

We have audited the accompanying financial statements of Valley Fresh Foods, Inc. Welfare Benefits Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) and of benefit obligations (modified cash basis) as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits (modified cash basis) and of changes in benefit obligations (modified cash basis) for the years ended May 31, 2025 and 2024, and the related notes to the financial statements.

Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 DESCRIPTION OF PLAN

The following description of Valley Fresh Foods, Inc. (the Company) Welfare Benefits Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

General

The Plan was established in June of 1981 to provide group life insurance, long-term disability, group accidental death and dismemberment insurance, self-funded medical, dental and vision, and prescription benefits to eligible employees of the Company and their families. Full-time, non-union employees are eligible to participate in the Plan after 60 days of continuous service. An eligible employee's coverage is effective, subject to timely enrollment, upon the first of the month following completion of a waiting period of 60 days of continuous active employment in an eligible status. The Plan also provides health benefits to eligible dependents of each participant. As required by the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA), the Plan includes a continuation of coverage option to certain terminated, retired, and totally disabled participants and their covered dependents for a period not to exceed 18 months. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The Plan provides health benefits including medical, major medical, hospital, surgical, prescription, vision, and dental services to full-time employees of the Company and to their covered dependents. Claims for these benefits are subject to various deductible and co-payment amounts. The Plan provides these benefits on a self-funded basis, subject to a stop loss limit.

The Plan also provides group life insurance, group accidental death and dismemberment insurance, and long-term disability benefits to all full-time employees of the Company. The Plan purchases an annual insurance contract for insurance benefits. Premiums for these insured benefits are paid to the insurance company directly from the assets of the Plan.

Contributions

The Plan is a self-funded health and welfare plan. The Company makes weekly contributions to the Plan for claims, administrative fees, and insurance premiums. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

In addition to deductibles and copayments, active participants contribute monthly amounts, determined periodically by the Company's management, to extend coverage to themselves and to their eligible dependents. These contributions are deducted bi-weekly from the employees' wages.

Terminated, retired, and totally disabled participants electing continued coverage contribute monthly amounts as provided by the Plan.

Plan Administrator

A Plan administrator is engaged under a fee-based contract, which is based on the number of participants in the Plan. The contract may be cancelled with thirty days' notice by either the Plan administrator or the Plan trustees.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. That basis differs from generally accepted accounting principles in that contributions, benefit payments, expenses, and claims are recorded when received or paid rather than when earned or incurred.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the trustees to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein and disclosures in the financial statements. Actual results could differ from those estimates.

Concentration of Credit Risk

The Plan's cash balance is held at one financial institution located in California. Accounts at this institution are insured by a government agency up to \$250,000. At times the balance in this account may exceed the insured limit.

Payment of Benefits

Premiums and claims paid by the Plan are recorded as premium and claim payments, respectively, in the accompanying statements of changes in net assets available for benefits (modified cash basis). Benefits are recorded when paid. There were no refunds of amounts accrued from the third-party administrator for adjustments, denied claims, or other disallowable claims included in payments for medical or dental claims for the years ended May 31, 2025 and 2024.

Administrative Expenses

All administrative expenses are paid out of the Plan unless paid by the Company. During the years ended May 31, 2025 and 2024, the Plan paid for substantially all administrative expenses, which consisted of administrative fees paid to third-party administrators and provider access fees.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by Internal Revenue Code Section 512(e)(3)(E). Unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the Internal Revenue Code. The Plan administrator believes the Plan does not have any net taxable income for the years ended May 31, 2025 and 2024.

Subsequent Events

The Plan has evaluated subsequent events through January 21, 2026, the date the financial statements were available to be issued.

NOTE 3 FUTURE BENEFIT OBLIGATIONS

The Plan administrator estimated that future benefit obligations for active participants' existing health conditions covered by the Plan amounted to \$242,244 and \$171,301 as of May 31, 2025 and 2024, respectively. This amount was determined from the calculation of the incurred but not reported (IBNR) reserve performed by the Plan's third-party administrator subsequent to the Plan's year end using claims data by paid date and incurred date as of a specific date. The third-party administrator estimates the percent of claims incurred that are currently unpaid. The third-party administrator also projects the monthly claims incurred for the most recent months. These historical estimates are used to calculate the expected claims payments in the coming year. The ultimate cost to the Plan may be limited by certain factors, such as the maximum coverage specified in the Plan document and stop loss coverage.

There have been no changes in the methodology used at May 31, 2025 and 2024.

NOTE 4 TAX STATUS

The Plan administrator believes that the Plan is exempt from income taxes, although a determination letter on the Plan's tax status has not been requested.

In accordance with the modified cash basis of accounting, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS).

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 31, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, they are currently no audits for any tax periods in progress.

NOTE 5 STOP LOSS COVERAGE

During the years ended May 31, 2025 and 2024, the Plan maintained a stop loss insurance policy with Sun Life Financial. Benefit payments are paid directly from the Trust for any covered individual per year. The Plan contains excess loss insurance covering participants' claims in excess of \$145,000 per participant per Plan year are reimbursed to the Plan. There is no limit per Plan year or total lifetime coverage that is provided to participants. During the years ended May 31, 2025 and 2024, \$1,126,632 and \$1,054,311, respectively, was reimbursed for stop loss recoveries. The Plan received stop loss reimbursements of \$910,573 and \$22,405, respectively, after May 31, 2025 and 2024 for claims paid during the years ended May 31, 2025 and 2024, and has outstanding stop loss reimbursements of \$220,217 and \$22,405, respectively.

The amount of stop-loss reimbursements received by the Plan may vary from year to year. Such variation is primarily driven by the number and severity of participant claims exceeding the stop-loss threshold, as well as the overall health status of covered individuals. Accordingly, reimbursements reported for any given year should not be considered indicative of future amounts.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.
