Reasonable Cause Letter

To whom may concern:

This late filing was the result of a transition in payroll services from ADP Run to ADP TotalSource. Historically, ADP has handled all payroll tax filings on our behalf. We relied in good faith on our payroll provider to handle compliance. However, during the conversion process, responsibility for tax filing and payment was transferred, which caused confusion regarding filing obligations and deadlines.

This is our first occurrence of any filing penalty. Once the issue was identified, the return was filed promptly, and corrective steps were taken to ensure all future filings are handled timely. The late filing was not due to willful neglect. We respectfully request full abatement of the penalties based on reasonable causes.
