Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information. In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Plan Description

General

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan provisions.

The Plan was established as a defined contribution plan on February 1, 2022 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401 (k) of the Internal Revenue Code of 1986 (IRC). Substantially all employees of the company are eligible to participate in the Plan subject to the eligibility criteria discussed below.

Funding

The Plan is a defined contribution plan wherein participants elect to reduce their compensation and have such reductions contributed to the Plan on their behalf. Participants direct their investments in numerous investment options managed by ADP Retirement Services.

Participants may contribute a total of 1% to 90% of their base salary through payroll deductions to the maximum amount permitted under applicable Internal Revenue Service Provisions. Participants can split their contributions between their pre-tax and/or after-tax accounts. Participants who are age 50 or older may make a “catch-up” contribution in excess of Internal Revenue Code or plan limits.

Allocation

Each participant’s account is credited with the participant’s contribution. Investment income or loss is allocated daily based on the ratio of each participant’s account balance at the end of each day.

Eligibility and Contributions

Employees are eligible to participate in the Plan on the first day of the month following the completion of 1 month of service.

The following class of employees are excluded employees and are not entitled to participate in the plan:

- Union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, unless the collective bargaining agreement requires the employee to be included within the Plan.
- Certain nonresident aliens who have no earned income from sources within the United States
- Leased employees

Rollover contributions to the plan are allowed.

Vesting

Contributions, any amounts rolled into the plan, and company contributions are adjusted for gains and losses, and are always 100% vested.

Loans

Active participants may borrow from their savings with a maximum repayment period of five years, unless for the purchase of a primary residence, with interest rate Prime +1%. No loan in an amount less than \$1,000 will be granted to any Participant.

Termination

Although the Organization has not expressed any intent to do so, management may terminate the Plan at any time. Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or one of various installment payments available under the Plan.

Payment of Benefits

Upon retirement, disability, or termination of service, participants may receive a distribution of the vested portion of some or all of their accounts in the Plan.

If you die while still employed by the Employer, then your vested account balance will be used to provide your beneficiary with a death benefit.

Administrative Expenses

Fees and expenses of the Plan for legal, accounting, and other administrative services may be paid directly by the Company, or, at the Company's discretion, may be paid in whole or in part from Plan assets.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America (GAAP) and have been consistently applied in the preparation of the financial statements.

Estimates

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amount reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investments Valuation and Income Recognition

Investment contracts held by a defined contribution plan are required to be reported at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. If the participant fails to make payments when they are due under the terms of the loan, they will be considered to be "in default." The Administrator will consider the loan to be in default if any scheduled loan repayment is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due, in accordance with the Plan's administrative procedures. The Plan would then have authority to take all reasonable actions to collect the balance owed on the loan, including foreclosing on the security for the loan by offsetting the account balance. Under certain circumstances, a loan that is in default may be considered a distribution from the Plan and could be considered taxable income to the participant. The failure to repay the loan would reduce the benefit the participant would otherwise be entitled to from the Plan.

Note 3 - Income Tax Status

The Plan received a letter from the IRS identifying the Plan as acceptable under section 401 of the IRC. In the opinion of the plan administrator, the plan is currently being operated in accordance with the Plan agreement and in conformity with the applicable provisions of the IRC and therefore exempt from federal income taxes. Therefore, no provisions for income taxes has been included in the Plan's financial statements.

GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the organization has taken an uncertain position that more likely

than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable input (level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Unadjusted quoted prices available in active markets for identical investments as of reporting date.

Level 2: Observable inputs to the valuation methodology are other than Level 1 inputs, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.

Level 3: Inputs to the valuation methodology are unobservable inputs in situation where there is little or no market activity for the asset or liability, and the reporting entity makes estimates and assumptions related to the proving of the asset or liability including assumptions regarding risk.
