## **INDEPENDENT AUDITORS' REPORT**

To the Trustees of and Participants in the  
Coalition for Christian Outreach 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Coalition for Christian Outreach 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of August 31, 2025 and 2024, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of and for the years ended August 31, 2025 and 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP); and
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS

---

### 1. DESCRIPTION OF PLAN

The following description of Coalition for Christian Outreach 401(k) Profit Sharing Plan (the "Plan"), which was established on September 1, 1996 and amended and restated as of September 1, 2021, provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

*General* - The Plan is a defined contribution plan and covers substantially all employees of Coalition for Christian Outreach (CCO). The Plan is administered by CCO. Voya Retirement Insurance and Annuity Company (Voya) serves as the custodian of the assets of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions* - Participants may elect to contribute, commencing on the first day of the Plan quarter following employment from 1% to 100% of their pre-tax and/or after-tax compensation, including wages and bonuses, into the Plan; subject to Internal Revenue Code (IRC) limitations. Employee rollovers represent contributions from other plans and are not subject to the IRC contribution limits.

The Plan provides for a matching contribution, equal to a discretionary percentage of the employee's percentage of salary deferrals, which is determined each year, subject to Board approval and funded after the Plan's year end. The match for the years ended August 31, 2025 and 2024 was 40% of the qualified participant deferrals up to 6% of compensation. Employees are eligible for the match on the first day of the Plan quarter coincident with attaining age 21, provided they have completed 500 hours of service during the Plan year or are employed on the last day of the Plan year.

Additional discretionary contributions may be made to the accounts of those employees with 1,000 hours of service that are employed on the last day of the Plan year, at the option of CCO. CCO made no discretionary contributions to the Plan during 2025 or 2024.

*Participant Accounts* - Each participant's account is credited with the participant's contributions, CCO's contributions, and net appreciation of investments and reduced by net depreciation of investments, distributions and any specifically chargeable fees.

*Vesting* - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting of employer contributions and earnings thereon occurs according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0
2 but less than 3	20
3 but less than 4	40
4 but less than 5	60
5 but less than 6	80
6 or more	100

*Investment Options* - Participants may direct their contributions to a broad range of diversified investment options offered by the custodian.

*Benefits* - Participants may withdraw certain amounts from their accounts up to their entire vested interest when they attain the age of 59½. Participant vested amounts are payable upon retirement, death, or other termination of employment. Benefits are paid in defined intervals or in a lump sum.

*Plan Termination* - Although CCO has not expressed any intent to terminate the Plan, it reserves the right to do so at any time subject to the provisions of ERISA. In the event of termination, the interest of each participant with respect to CCO contributions will vest immediately.

*Forfeitures* - Forfeitures of nonvested accounts can be applied to offset administrative expenses of the Plan and reduce employer contributions to the Plan, as defined in the plan document. Forfeitures were not significant during the years ended August 31, 2025 or 2024.

*Administrative Expenses* - Administrative expenses include fees paid from participant accounts for withdrawals as well as certain plan expenses; other expenses are paid directly by CCO.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Investment Valuation and Income Recognition* - The Plan's investments are stated at fair value. Purchases and sales of shares are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

The unrealized appreciation (depreciation) of investments is determined by the change in current market value from the beginning of the year to the end of the year (if held for the entire year), or from the date of purchase to the end of the year. The realized appreciation (depreciation) of investments is determined from the date of purchase to the date of sale. Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Purchases and sales of securities are recorded on a trade-date basis.

*Use of Estimates* - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in assets during the reporting periods. Actual results could differ from those estimates.

*Fair Value Measurements* - U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan's investments are composed of pooled separate accounts, which are valued at their accumulation unit value, which is determined based on a combination of the net asset value of underlying shares and the separate account charges (level 2) at August 31, 2025 and 2024. There has been no change in the methodologies used at August 31, 2025 or 2024.

*Subsequent Events* - Management has evaluated subsequent events through January 12, 2026, the date upon which the financial statements were available to be issued.

### **3. INCOME TAX STATUS**

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing plan. In a letter from the Internal Revenue Service dated June 30, 2020, it was noted that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at August 31, 2025 or 2024. The Plan is no longer subject to tax examinations for the years prior to August 31, 2022.

**4. PARTY-IN-INTEREST AND OTHER TRANSACTIONS**

Plan investments are shares of pooled separate accounts held by Voya. Voya is the custodian as defined by the Plan and, therefore, the investments are with a party-in-interest. Administrative expenses paid to Voya by the Plan amounted to \$5,450 and \$6,050 for the plan years ended August 31, 2025 and 2024, respectively. Additionally, the pooled separate accounts have fees that are offset against the net appreciation in fair value of investments.

Northwestern Mutual Investment Services was paid investment advisory fees of \$32,865 and \$29,210 for the plan years ended August 31, 2025 and 2024, respectively, which are also netted against the net appreciation in fair value of investments.

Neither CCO or its employees involved in the administration of the Plan received compensation from the Plan.

**5. INFORMATION CERTIFIED BY CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance as required by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of assets available for benefits and supplemental schedule as well as the net appreciation in the fair value of investments reflected in the statements of changes in assets available for benefits.

**6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of assets available for benefits.
