1. Description of Plan

General. The following description of Eastern Aero Marine, Inc. (the “Company”) 401(k) Profit Sharing Plan and Trust (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan covering substantially all full-time employees of the Company who have completed one year of service and are of age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Date of eligible participation occurs monthly after the requirements have been met.

Contributions. Each year, participants may contribute an amount equal to a dollar amount or percentage on the contributing participant’s compensation not to exceed the limit contained in the applicable IRS code sections. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make qualified matching contributions and an annual profit sharing contribution, as determined by the Board of Directors of the Company. Profit sharing contributions are allocated at the end of the calendar year to participants employed at the end of the year and to participants who have retired, died or became disabled during the year. Such allocations are based on the proportion that each participant’s basic compensation bears to the total basic compensation for all participants. During 2021 and 2020, the Company made no matching or profit sharing contributions.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of the Plan’s earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in Company contributions based upon the following schedule:

Employee deferral and rollover account balances (balances resulting from transfers of benefits from another qualified plan) and earnings thereon are 100% vested at all times.

Payment of Benefits. Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or in installments as designated by the participant. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Investment Options. Upon enrollment in the Plan, participants may direct their contributions to any of the investment options selected by the Plan administrator.

Participants may change their investment options with the custodian in writing, via the Internet or by telephone. Changes are processed by the following day.

1. Description of Plan (Cont'd.)

Notes Receivable from Participants. Participants are immediately vested in their own contributions plus actual earnings thereon. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 5.00%, which is commensurate with local prevailing rates as determined periodically by the custodian. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Forfeited Amounts. At December 31, 2021 and 2020, there were \$9,785 and \$9,775 forfeited amounts, respectively. Forfeited non-vested amounts can be used to offset employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting. The financial statements are prepared using the accrual method of accounting.

Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Investments in registered investment companies are stated at estimated fair values, which have been determined based on the unit values of the registered investment company. Notes receivable from participants are valued at cost which approximates fair values. See Note 4 for discussion of fair value measurements.

Investment transactions are accounted for on a trade date basis. Realized gains or losses on sales of securities are determined on an average-cost basis. The Statement of Changes in Net Assets Available for Plan Benefits includes the net appreciation in fair value of its investments, which consists of the realized gains or losses and the change in unrealized appreciation on those investments.

The Plan is exposed to loss in the event of nonperformance by the investment manager for the funds in which the Trustee invests. However, the Plan does not anticipate nonperformance by the investment manager.

Benefits are recorded when paid.

Administrative Expenses. The employer bears most of the administrative expenses of implementing the Plan in accordance with the Plan document. Management fees paid to the Trustees are incurred by the participants.

Subsequent Events. The plan administrator has evaluated subsequent events through September 22, 2023, the date these financial statements were available to be issued.

4. Fair Value Measurements

The applicable guidance provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the applicable guidance are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Registered Investment Companies and Insurance Company General Account: Valued at fair value of shares held by the Plan at year end and categorized as a Level 1 fair value measurement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Income Tax Status

The Plan adopted the "Prototype Plan," which has obtained an IRS Favorable opinion letter on March 31, 2008 stating that the Prototype Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. As an adopter of this Prototype Plan, the Plan may rely on this favorable opinion letter with respect to the qualification. The Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan is operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes this or the predecessor plan is no longer subject to income tax examinations for years prior to 2018.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
