## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
the Webster's United Foods Services, Inc. Employee Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Webster's United Foods Services, Inc. Employee Retirement Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 23, 2025 (in liquidation) and October 31, 2024 (ongoing), and the related statement of changes in net assets in liquidation available for benefits for the period from November 1, 2024 to September 23, 2025 (short period, in liquidation) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Webster's United Foods Services, Inc. Employee Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 23, 2025 and October 31, 2024 and for the period from November 1, 2024 to September 23, 2025, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Webster's United Foods Services, Inc. Employee Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting**

As discussed in Note H to the financial statements, the governing body of Webster's United Foods Services, Inc. Employee Retirement Savings Plan approved a plan of liquidation on November 2, 2024, and management determined liquidation is imminent. As a result, Webster's United Foods Services, Inc. Employee Retirement Savings Plan changed its basis of accounting from the ongoing basis used in presenting the 2024 financial statements to the liquidation basis of accounting used in presenting the 2025 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Webster's United Foods Services, Inc. Employee Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE A – DESCRIPTION OF PLAN**

The following description of the Webster's United Foods Services, Inc. Employee Retirement Savings Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Webster's United Food Services, Inc. ("the Company"), unless identified as an excluded employee, who have one year of service and are age twenty one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Each employee shall become eligible for participation and Company matching contributions after one year of service on the quarterly entry date immediately following the completion of one year of service requirements (at least 1,000 hours of service). Following the Plan's termination effective December 9, 2024, no new employees became eligible to participate in the Plan.

**Employee Contributions**

Participant's contributions (deferrals) in any taxable year, may not exceed the lower of a dollar limit set by law (\$23,500 and \$23,000 for 2025 and 2024, respectively) or 100% of eligible compensation. Participants who are 50 years or older before the end of a calendar year are eligible to make catch-up contributions. Newly hired employees are auto enrolled and automatically defer 6% of the participants earnings, unless they elect otherwise. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers one stable value option investment and forty pooled separate accounts as investment options for the participants. Participants may elect to have any portion, or all, of their contributions designated as Roth 401(k) contributions. Contributions are subject to certain limitations.

**Company Contributions**

Safe harbor matching contribution – The Company will make matching contributions equal to 100% of the employee's deferrals that do not exceed 3% of the employee's eligible compensation plus 50% of the employee's deferrals that exceed 3% of the employee's eligible compensation but does not exceed 4.5% of the employee's eligible compensation.

Discretionary matching contribution – The Company may make matching contributions in an amount equal to a percentage, which will be determined annually, of eligible employee deferrals. Regardless of the preceding, the discretionary match contribution in any plan year cannot exceed 4% of the employee's eligible compensation.

Profit sharing contribution – The Company may make annual discretionary profit sharing contributions in an amount to be determined at plan year end. The employee must complete at least 1,000 hours of service during the plan year and be employed at the last day of the plan year end. The Company made a profit sharing contribution of \$0 and \$34,238 for the short year ended September 23, 2025 (in liquidation) and the year ended October 31, 2024 (ongoing), respectively.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, any withdrawals or distributions and an allocation of (a) the Company's contribution; and (b) plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Certain expenses that are specifically incurred by, or attributable to, a participant may be paid from their account. Plan administrative expenses are paid by the Company.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit sharing and matching contribution portion of their account plus actual earnings thereon is based on years of continuous service based on the following schedule:

Upon termination of the Plan effective December 9, 2024, all participants became fully vested in all employer contribution portions of their accounts, regardless of years of service.

**Payments of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. If the vested account balance does not exceed \$5,000, then the vested account balance will be distributed in a single lump-sum payment. Upon termination of the Plan effective December 9, 2024, participants' vested account balances were distributed as soon as administratively practicable following the termination date, in accordance with the provisions of the Plan.

**Forfeited Accounts**

When terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are used by the Company to either reduce administrative expenses or employer contributions to the Plan. Company contributions for the short year ended September 23, 2025 (in liquidation) and the year ended October 31, 2024 (ongoing) were reduced by \$4,479 and \$6,229, respectively, from forfeited nonvested accounts. Audit fees for the 2024 plan year end were paid using forfeitures of \$510 during 2025. During the short year ended September 23, 2025 (in liquidation) and the year ended October 31, 2024 (ongoing), forfeitures totaled \$470 and \$4,386, respectively. The Plan can accumulate these forfeitures, and the value of these forfeitures as of September 23, 2025 (in liquidation) and October 31, 2024 (ongoing) was \$0 and \$4,479, respectively.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements for the period ended September 23, 2025, are prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America, due to the plan's termination and imminent liquidation. The 2024 financial statements are prepared on the ongoing basis of accounting. The liquidation basis reflects management's estimates of amounts expected to be realized and costs to be incurred through the final distribution of plan assets.

**Investment Valuation and Income Recognition**

Investments are stated at fair value using methodologies described in Note E - Fair Value Measurement. The difference between fair value and the cost of investments is reflected in the statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. The realized gain (loss) on sale of investments is the difference between the proceeds received and the cost of investments sold. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investments in group annuity contracts are reported at contract value in accordance with Note F – Group Annuity Contracts.

**Risks and Uncertainties**

The Plan invests in various investment securities. These securities are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain values of investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying financial statements.

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the accounting standards are described as follows:

- Level 1 Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2 Inputs other than quoted prices within Level 1 that are observable for asset or liability, either directly or indirectly, such as:
  - a. Quoted prices for similar assets or liabilities in active markets
  - b. Quoted prices for identical or similar assets or liabilities in inactive markets
  - c. Inputs other than quoted prices that are observable for the asset or liability
  - d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs that are unobservable inputs for the asset or liability.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions from net assets during the reported period. Accordingly, actual results may differ from those estimates.

**Income Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualified under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

The termination of the Plan effective December 9, 2024 did not affect the Plan's qualified tax status under Section 401(a) of the IRC.

**Income Tax Status – Continued**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or state taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 23, 2025 (in liquidation) and October 31, 2024 (ongoing), there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. All years not closed by the statute of limitations remain open for examination by tax jurisdictions.

**NOTE C – CORRECTION OF AN ERROR**

During the short year ended September 23, 2025, an error was identified in the presentation of certain stable value investments reported on the statement of net assets available for benefits as of October 31, 2024. Investments previously reported at fair value totaling \$6,708,747 were corrected to reflect \$6,060,167 at fair value and \$648,580 at contract value, consisting of \$115,178 related to the Stable Value General Account and \$533,402 related to the YourPath Stable Value investment. This correction had no effect on total net assets available for benefits.

**NOTE D – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Lincoln Financial Group has certified that the following data included in the accompanying financial statements was complete and accurate:

**NOTE E – FAIR VALUE MEASUREMENT**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 23, 2025 (in liquidation) and October 31, 2024 (ongoing):

Registered investment company funds: These funds are valued based on the Net Asset Value (NAV) of the underlying mutual funds or securities that are publicly available.

**NOTE F – GROUP ANNUITY CONTRACT**

The Plan invests in a traditional fully benefit-responsive investment contract with Lincoln Financial Group totaling \$0 and \$648,580 as of September 23, 2025 (in liquidation) and October 31, 2024 (ongoing), respectively. Lincoln Financial Group maintains the Plan's contributions in the Lincoln Stable Value Account, backed by Lincoln's general account, in accordance with the terms of the applicable group fixed annuity contract. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The effective rate of interest is established quarterly by Lincoln. Quarterly "new money" rates and quarterly portfolio rates for Lincoln fixed annuity contracts are set at the discretion of a Lincoln executive committee, and for certain contracts, the interest rate is based on an external index. Interest is credited daily on an actual basis. Remove purple The guaranteed minimum interest rate is contractually defined (1.70%).

The contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts, because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln Financial Group, represents contributions made under the contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include amendments to the Plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Employer or other events that cause a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or premature termination of the contract. The Plan terminated during the short year ended September 23, 2025; however, this, nor any other events, did not limit the ability of the Plan to transact at contract value with the contract issuers or that limited the ability of participants to transact at contract value.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation or a material amendment to the agreement without consent of the issuer.

**NOTE G – PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of registered investment company funds managed by Lincoln Financial Group. Lincoln Financial Group is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for investment management services amounted to \$24,255 and \$29,910 for the short year ended September 23, 2025 (in liquidation) and the year ended October 31, 2024 (ongoing), respectively.

**NOTE H – PLAN TERMINATION**

On November 2, 2024, Webster's United Foods Services, Inc. ("the Company") was sold, and subsequently, on December 9, 2024, the Company adopted a resolution to terminate the Webster's United Foods Services, Inc. Employee Retirement Savings Plan. Effective with the Plan's termination, no employee or employer contributions were permitted for compensation earned after the termination date, and all participants became fully vested in their account balances regardless of years of service. In accordance with generally accepted accounting principles, the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis as of November 1, 2024.

All plan assets were distributed to participants during the period, and as of September 23, 2025, the Plan held no remaining assets or liabilities. The Company will pay any remaining administrative expenses, including Form 5500 and audit costs, outside of the Plan. The Plan will remain in existence only as long as necessary to complete the final administrative processes and filings.

**NOTE I – CONCENTRATIONS**

The Plan holds certain investments that represent 10% or more of the Plan's assets available for benefits. As of September 23, 2025 the Plan held no investments. As of October 31, 2024 the Plan held three investments totaling \$3,377,462 that were greater than 10% of the Plan's net assets available for benefits.

**NOTE J – RISK AND UNCERTAINTIES**

In January 2020, Congress enacted the Setting Every Community Up for Retirement Enhancement Act of 2019 (the "SECURE Act"), and in December 2022, the Consolidated Appropriations Act of 2023, which included provisions commonly referred to as "SECURE 2.0." These laws include changes to required minimum distribution ages and other optional and mandatory retirement plan provisions.

In connection with the Plan's termination, the Plan adopted amendments in December 2024 to comply with the SECURE Act and SECURE 2.0. These amendments included changes to required minimum distribution age rules and other plan provisions. The Plan was terminated effective December 9, 2024, and all plan assets were fully distributed prior to year-end. As a result, the adoption of these amendments did not affect the amounts reported in the Plan's financial statements.

**NOTE K – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through February 9, 2026, the date on which the financial statements were available to be issued.
