## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
**Gulf Copper & Manufacturing Corporation Profit Sharing Plan and Trust**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Gulf Copper & Manufacturing Corporation Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended April 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Gulf Copper & Manufacturing Corporation Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 30, 2025 and 2024, and for the year ended April 30, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Gulf Copper & Manufacturing Corporation Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of Gulf Copper & Manufacturing Corporation, Gulf Copper Ship Repair, Inc., and Sabine Surveyors, Ltd. (collectively, the “Company”). Employees are eligible to participate in the Plan on the completion of six months of service and enter the Plan on the first day of the month coinciding with or following the satisfaction of the service requirement. Prior service with SAI Gulf LLC (SAI) also qualifies for meeting the eligibility requirements of participants who transfer to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

John Hancock Retirement Plan Services LLC is the third-party administrator and custodian and John Hancock Trust Company LLC (John Hancock) is the Plan’s trustee.

**Contributions**

Participants may elect to make salary deferral (pre-tax and/or Roth) contributions to the Plan, subject to limits provided under the Internal Revenue Code (IRC) and a minimum of 1%. All participants automatically have 6% of eligible compensation deferred, as pre-tax contributions, unless the participant specifies a different amount or elects not to defer. The automatic salary deferral contribution increases 1% each year, on May 1, until a participant reaches a salary deferral contribution of 10%, unless opted out by the participant. Participants who have attained age 50 before the end of the calendar year within the plan year are eligible to make catch-up contributions. The Plan allows for participants in a former employer’s qualified plan to contribute direct rollovers to the Plan in accordance with Plan provisions.

The Company may make discretionary contributions. Participants must be eligible to participate in the Plan and be employed on the last day of the plan year to receive discretionary contributions. There were no discretionary contributions to the Plan during 2025. The Plan is participant directed. Participant contribution rates can be changed each payroll period. Investment options can be changed by participants at any time. In-Plan Roth rollover contributions and in-Plan Roth rollover transfers are allowed.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions, Plan earnings, and Plan administrative expenses. Allocations are based on participant earnings, account balance, or specific transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are at all times fully vested in their salary deferral and rollover contributions and the appreciation or depreciation thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant must be employed during a plan year to count toward vesting. Years of service with SAI also count toward vesting for participants who transfer to the Plan. Participants are 20% vested after two years of service and vest an additional 20% each year thereafter, becoming 100% vested after six years of service. A participant shall become immediately vested upon death, retirement, and total disability.

**Forfeited Accounts**

Forfeitures of nonvested Company discretionary contributions shall be used to pay Plan administrative expenses or reduce Company contributions. The forfeitures balance at April 30, 2025 and 2024 was \$3,538 and \$43, respectively. There were no forfeitures used to reduce Company contributions or pay Plan administrative expenses during 2025.

**Payment of Benefits**

Under the Plan, normal retirement age is 65, and early retirement age is 55 with the completion of six years of service. Upon a participant's termination, the vested funds in the participant's account may be distributed in a lump-sum payment. For death and retirement benefits, the vested funds may be distributed in an annuity. Participants are eligible to receive in-service distributions in accordance with the Plan document. The Plan also allows hardship withdrawals to all participants, limited to the participant's total salary deferral contributions and related earnings.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Investments**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on the trade date. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants are recorded in the plan year in which the participant contributions are withheld from compensation.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**

Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Third-party administrative service fees and fees related to withdrawals charged directly to the participant's account are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Federal Income Taxes**

The Plan has adopted a nonstandardized prototype plan, which obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service (IRS) stated that the prototype document satisfies the applicable provisions of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following investments valued at NAV per share (or its equivalent) practical expedient are excluded from presentation in the fair value hierarchy as described above.

*Collective Investment Trust:* Valued at the daily closing price as reported by the trust based on NAV. The trust strives to maintain a NAV of \$1. Underlying investments are composed primarily of fully benefit-responsive investment contracts. The trust's objectives are to preserve capital. Participants are permitted to make redemptions from the trust on a daily basis and there is no redemption notice period for participant transactions. Under certain conditions, the trust may delay redemptions for Plan or participant withdrawals for up to twelve months. There were no unfunded commitments or contractual obligations to further invest in the trust.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
