Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of The Arc Caddo-Bossier's Prototype 401(k) Profit-Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Responsibilities of Management

NOTE 1 - DESCRIPTION OF PLAN

The following description of The Arc Caddo-Bossier's Prototype 401(k) Profit-Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan was established July 1, 1988 to provide retirement income for the employees of The Arc Caddo-Bossier (Company), including those employees who were classified as consumers employed in the Frost Division of The Arc Caddo-Bossier (Frost Division). In 1999, the Plan added 401(k) provisions in which employees, other than those classified as consumers employed with the Frost Division, who have attained age 18 and have completed one year of service are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 1, 2008, the Company adopted the Mutual of America Life Insurance Company (Mutual of America) Prototype 401(k) Profit-Sharing Plan, and amended the Plan to be known as the The Arc Caddo-Bossier's Prototype 401(k) Profit-Sharing Plan. While not eligible to participate in contributions, Frost Division consumers are permitted to invest their existing account balances in the investment options offered by the Plan.

CONTRIBUTIONS

Each year, eligible participants may contribute up to 100% of their pre-tax annual compensation, as defined in the Plan, subject to the annual limits permitted by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified plans. The Company, at its sole discretion, has the option of providing matching and/or discretionary contributions. For the year ended June 30, 2025, the Company made matching contributions of 100% of the first 4% of compensation deferred. Contributions are subject to certain limitations.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and an allocation of: (1) the Company's contribution, (2) Plan earnings and (3) forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after two years of credited service.

NOTES RECEIVABLE FROM PARTICIPANTS

The Plan does not permit participants to borrow from their fund accounts.

PAYMENT OF BENEFITS

If employees terminate before rendering two years of service, they forfeit the right to receive some or all of the benefits they have accumulated based upon their percentage of vesting at the date of termination. Employees may elect to receive the current value of their accumulated benefits as a lump-sum distribution upon retirement or early termination, or they may elect to receive cash payments in annual or more frequent installments, over the life of the participant or beneficiary.

FORFEITED ACCOUNTS

Forfeited accounts are used to reduce future Company contributions. For the year ended June 30, 2025, \$751 was utilized by the Plan. The unallocated forfeiture balance was \$0 and \$751 as of June 30, 2025 and 2024 respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. generally accepted accounting principles ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value (except for the fully benefit-responsive contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. See Note 6 for further discussion of the fully benefit-responsive contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

OPERATING EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through January 30, 2026, the date the financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

Following is a description of the valuation methodologies used for assets measured at fair value at June 30, 2025 and 2024.

Mutual funds:

Valued at the daily closing price reported by the fund. Separate accounts held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds are deemed to be actively traded and are included in the fair value hierarchy table.

Interest accumulation account:

The Plan holds a guaranteed interest contract within Mutual of America's General Account. This investment is reported at contract value, which represents contributions plus interest credited, less participant withdrawals. Because this investment is not measured at fair value, it is excluded from the ASC 820 fair-value hierarchy.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Mutual of America Life Insurance Company. Mutual of America is the Custodian, as defined by the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan totaled \$3,862 for the year ended June 30, 2025.

NOTE 6 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan maintains a fully benefit-responsive investment contract with Mutual of America Life Insurance Company, who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Mutual of America is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3%. Such interest rates are reviewed on a quarterly basis for resetting. The declared interest rate earned by the group annuity contract was 3.00% for the years ending June 30, 2025 and 2024.

Certain events limit the Plan's ability to transact at contract value with Mutual of America. Such events include the following: all group variable funding agreements in this class of business are amended, changed, or altered due to changes in any applicable laws and it is determined that obligations under this Agreement or ability to maintain this class of business are thereby materially affected. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) the Plan or Plan trust fails to maintain its special tax qualified or exempt status under 401(a) of the Code, (b) Plan sponsor fails to provide information necessary to perform the agreement and fails to remedy the failure within 31 days from the date of notification, (c) the Plan trust is amended in a way that adversely affects our obligations under this Agreement, (d) the assets held or the Participants covered under the Agreement are less than the amount required for the Agreement to be a group funding agreement under any applicable insurance law, (e) the Plan sponsor changes in a manner that causes the Plan sponsor to no longer be considered an entity which is authorized or eligible to sponsor this Agreement, (f) no contributions are made to Mutual of America during any consecutive 12 month period, or (g) at any time the contributions or balances are less than the amount required for this class of business under the underwriting standards in effect as of the Agreement Effective Date.

The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 9 - TAX STATUS

The Plan Sponsor has adopted a prototype plan which received a favorable tax determination letter from the Internal Revenue Service (IRS) that it qualifies under Section 401(a) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
