Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Our 401(k) Plan, formerly the TrueCore Behavioral Solutions 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Our 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Principal Trust Company as of December 31, 2024 and for the period from February 14, 2024 to December 31, 2024, and from Matrix Trust Company for the period from January 1, 2024 to February 13, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 1. Description of Plan

The following description of Our 401(k) Plan, formerly the TrueCore Behavioral Solutions 401(k) Plan, (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of TrueCore Behavioral Solutions, LLC (the "Company") and participating employers who have completed three months of service, as defined, and are age 21 or older, excluding union members whose employment is governed by a collective bargaining agreement, leased employees, and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Company management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective February 14, 2024, all assets of the Plan are held and invested by Principal Trust Company. Prior to February 14, 2024, Matrix Trust Company served as the Plan's custodian. As of February 14, 2024, 100% of the Plan's assets approximating \$3,487,000 were transferred to Principal Trust Company.

The Company has entered into an agreement whereby, Principal Trust Company (the "Custodian", together with Matrix Trust Company the "Custodians") has been appointed the Custodian of the Plan's assets. Under the terms of the agreement, the Custodian holds and invests the funds of the Plan.

Plan Termination:

The Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Effective September 1, 2025, the Company exercised its right to terminate the plan, upon which all participants will be provided with immediate 100% vesting. All contributions to the Plan ceased on September 1, 2025. As of February 6, 2026, the date on which the financial statements were available to be issued, the net assets of the Plan have not been distributed. It is the intent of Plan management to distribute all assets of the Plan as soon as administratively possible following termination.

Contributions:

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollovers, amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may, at its discretion, contribute on behalf of each eligible participant a matching contribution based on a discretionary matching allocation formula relative to a participant's compensation contributed as an elective deferral contribution with respect to each Plan year. In addition, the Company may, at its discretion, make a non-elective contribution. The Company did not make a matching contribution or non-elective contribution with respect to the years ended December 31, 2024 and 2023. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's non-elective contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Company matching contributions vest immediately. Non-elective contributions vest after three years. Effective September 1, 2025, the Company exercised its right to terminate the plan. In accordance with Plan provisions, all participants are provided with immediate 100% vesting on the effective date of termination.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may have no more than two loans outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

For termination of service, a participant or their beneficiary may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution, partial non-periodic distributions, or installments. A participant may request an in-service distribution of all or a portion of his or her vested accounts upon the attainment of age 59^{1/2} or from his or her rollover account.

Forfeited accounts:

Forfeited accounts may be used to pay administrative expenses or reduce employer contributions. There were no nonvested forfeited account balances at either December 31, 2024 or 2023, nor were any forfeited account balances used during 2024 or 2023 to pay administrative expenses or reduce employer contributions.

SECURE Act 2.0:

On December 29, 2022, the Setting Every Community Up for Retirement Act ("SECURE") 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act, 2023. The SECURE 2.0 Act includes numerous reforms to retirement law intended to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and simplify and clarify retirement plan rules. As of December 31, 2024, and through February 6, 2026, the date the financial statements were available to be issued, Plan management believes Plan provisions conform with required SECURE 2.0 regulations, and it is the intent of Plan management to amend Plan provisions in the future, as needed.

2. Summary of Accounting Policies

Basis of accounting:

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Investment valuation and income recognition (continued):

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants is measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding refund of excess contributions. The Plan did not distribute the refund of 2023 excess contributions to the applicable participants prior to March 15, 2024, and as such, the Company is financially responsible for the related excise taxes.

Payment of benefits:

Benefits are recorded when paid. Plan management believes amounts allocated to accounts of persons who had elected to withdraw from the Plan, but had not yet been paid were not significant at December 31, 2024.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through February 6, 2026, the date the financial statements were available to be issued. See Note 10 for further discussion of subsequent events.

3. Information Certified by Custodians

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule of assets held at end of year, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodians.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under Accounting Standards Codification ("ASC") 820, "Fair Value Measurements", are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price and are deemed to be actively traded.

Money market funds – Money market funds are valued at the closing price as reported by the fund sponsor from an actively traded exchange. The money market funds are open-end mutual funds that invest in short-term debt securities and cash equivalents. These funds are required to publish their daily net asset value and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Pooled separate accounts – Pooled separate accounts are valued on a net unit basis on the last business day of the plan year. The fair values of these investments are determined by reference to the respective pooled separate account's underlying assets, with the Custodian specifying the source(s) used for underlying investment asset prices. In the event that a pooled separate account's initial valuation is not deemed reasonable, the Custodian may make adjustments to achieve a value believed to be more reflective of fair value.

Group annuity contract – The fair value of the investment is determined based on the market approach. Inputs to the valuation methodology are unobservable and significant to the fair value measurement. Any market value adjustments are based on formulas and schedules in the contract. The credited interest rate, account balance and formulas upon which payments may be based are defined in the contract.

Common collective trusts – Common collective trusts are valued based on the information reported by the investment advisor using the audited financial statements of the common collective trust at year-end. The Plan's investments in collective interest trusts are valued based upon the net asset value of units owned by the Plan at year-end. The fair value of the Plan's investments is based on the net asset values of the underlying open-end mutual funds.

5. Group Annuity Contract - Principal Fixed Income Guaranteed Option

The Plan's investment in the group annuity contract at fair value as of December 31, 2024 in the amount of \$3,686 reported in the accompanying Statement of net assets available for benefits is invested in the Principal Fixed Income Guaranteed Option ("PFIGO"), which is a guaranteed general account group annuity contract issued by Principal Life Insurance Company ("PLIC"). Under the group annuity contract, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes.

Under the contract, certain withdrawals and transfers may be restricted. Plan management does not consider the restrictions to be substantial in the context of the definition of a fully benefit-responsive insurance company contract under ASC 962, "Plan Accounting – Defined Contribution Plans" ("ASC 962") and therefore Plan management believes the contract meets the requirements for fully benefit-responsive contracts. As such, in accordance with ASC 962, the value of the contract would be reported at the contract value. Contract value represents the amount participants would normally receive if they were to initiate a benefit-responsive transaction under the terms of the ongoing Plan and is generally calculated as the sum of contributions made under the contract plus earnings at guaranteed crediting rates, less participant withdrawals and administrative expenses. However, due to the impending termination of the Plan (see Note 1) and the resulting planned liquidation of the investment, the PFIGO is reported in the accompanying Statement of net assets at fair market value, which approximates contract value at December 31, 2024.

Interest is credited at a declared interest rate. The net credit rate is after the deduction of fees for administrative and recordkeeping services. Interest crediting rates are reviewed on a semi-annual basis for resetting. The rate credited to accounts is a composite weighted average of underlying guarantees provided in the contract. The target average maturity of the underlying guarantees of the PFIGO is two to four years.

The guarantees are supported by the assets in PLIC's general account and are based on the financial strength of PLIC.

Transfers into or out of the contract, including for retirement, termination of employment, disability, plan termination, death, loans, and withdrawals, as allowed by the Plan, generally do not incur surrender charges. Termination of the Plan's interest is subject to a 12-month advance notice or a 5% surrender charge calculated using the 12-month average value of the Plan's interest in the contract. The authorized Plan representative chooses the termination provision for liquidation.

6. **Group Annuity Contract – CUNA Mutual Group Guaranteed Account**

The Plan's group annuity contract investment as of December 31, 2023 in the amount of \$187,872 is invested in the CUNA Mutual Group Guaranteed Account (the "Guaranteed Account") and is reported in the accompanying Statement of net assets available for benefits at fair value determined by the Custodian using the market approach based on market prices of similar funds, in accordance with ASC 962, which specifies the accounting for investment contracts issued by either an insurance enterprise or other entity.

The Guaranteed Account is a deposit administration group annuity contract. The contract is a fixed, deferred group annuity available to qualified retirement plans. It provides guaranteed protection of principal with a set rate of return. The fund seeks a high level of current income consistent with preservation of capital by investing primarily in corporate bonds, mortgage-backed securities, collateralized mortgage obligations, high quality commercial mortgage loans, municipal bonds and other high-grade fixed income securities. The Guaranteed Account is guaranteed by CMFG Life Insurance Company ("CMFG"). Any administrative or investment management fees are deducted from credited interest rates. Withdrawals (for other than plan benefit payments) are subject to a market value adjustment.

CMFG's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events may limit the ability of the Plan to transact at contract value with the issuer and/or allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Plan management believes the occurrence of such events are not probable.

Under the contract, certain withdrawals and transfers may be restricted, and therefore Plan management does not consider the group annuity contract fully benefit responsive. Accordingly, the Plan's investment in the group annuity contract is included in the Statements of net assets available for benefits at fair value as determined by the Trustee.

7. **Related Party Transactions**

Certain Plan investments and related transactions were in investment funds managed by the Plan's Custodian and, therefore, these investments and transactions qualify as party-in-interest transactions. The notes receivable from participants are also considered to be party-in-interest transactions. These transactions are not considered prohibited by statutory exemptions under ERISA.

8. Tax Status

The Company has adopted a preapproved plan document that has received a favorable tax determination letter from the IRS dated June 30, 2020, stating that the prototype plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan itself has not received a determination letter and the prototype plan has been amended since receiving that determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and is tax-exempt.

The Plan was not in compliance with certain IRS non-discrimination tests for the years ended December 31, 2024 and 2023. The noncompliance is corrected through a refund of excess 401(k) contributions contributed by "highly compensated" employees. Such refunds are reflected in the accompanying Statements of net assets available for benefits as Excess contributions payable.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of the IRS. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of net assets available for benefits.

The Plan filed the December 31, 2024 Form 5500 without the inclusion of the audited Plan financial statements. As a result, the Plan was not in compliance with the related filing requirements. Plan management has advised the Department of Labor ("DOL") that the Form 5500 will be amended to include the audited financial statements as soon as practicable. Plan management does not believe any potential penalties or resulting actions by the DOL will have a material effect on the financial condition of the Plan.

10. Subsequent Event

Effective September 1, 2025, the Company exercised its right to terminate the plan. See Note 1 for further discussion.
