As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Saint Therese and Affiliates Employee Benefit 403(b) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.



NOTE 1 DESCRIPTION OF PLAN

The following description of Saint Therese and Affiliates Employee Benefit 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective December 15, 1992. The Plan has been amended throughout the years to comply with tax legislation. The Plan was last restated effective January 1, 2023. The Plan covers all employees of Saint Therese (the Employer) and Saint Therese of Oxbow Lake, LLC, Ascend Rehab, LLC, Saint Therese of Woodbury, LLC, Saint Therese Collaborative, LLC, Saint Therese of New Hope, IHM, Senior Living Community, Inc. and Saint Therese of Corcoran, LLC (participating Employers). The Plan was amended effective October 1, 2024 to add Saint Therese Management Services, LLC as a participating Employer and to remove Saint Therese of New Hope as a participating Employer. Effective December 1, 2024, the Plan was also amended to add Saint Therese of Avon, LLC; DBA St. Mary of the Woods as a participating Employer. Employees are eligible upon date of hire for the cash or deferred arrangement and to receive employer contributions (as defined by the Plan). The Plan is subject to ERISA, as amended.

Contributions

The Plan includes a cash or deferred arrangement allowed under Section 403(b) of the Internal Revenue Code (IRC). Eligible participants are thereby permitted to elect to have a percentage of their eligible compensation contributed as pre-tax or Roth 403(b) deferral contributions to the Plan. The Plan allows participants age 50 and older to make catch-up contributions and participants with 15 years of service to make special catch-up contributions. Participants direct contributions into various investment options offered by the Plan. Effective January 1, 2016, the Plan added an automatic enrollment feature for new hires at 3%. Participants may also contribute amounts representing distributions from other qualified defined benefit or qualified contribution plans. Contributions are subject to certain limitations.

The Employer may make a matching contribution for eligible participants. The discretionary matching contribution is equal to 50% of the salary reduction contributions made by participant up to 8% of eligible compensation deferred. For those employees employed at Saint Therese of Avon, LLC, the discretionary matching contribution is equal to 25% of the salary reduction contributions made by participant up to 4% of eligible compensation deferred. The Plan also allows for the Employer to make a discretionary contribution for eligible participants. There were no Employer discretionary contributions for the years ended June 30, 2025 and 2024.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Effective January 1, 2023, participants are 100% vested in all Employer contributions plus actual earnings after one year of credited service. Prior to January 1, 2023, participants are immediately 100% vested in all Employer contributions plus actual earnings thereon. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death or permanent disability.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's matching and discretionary contribution, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest is paid ratably through payroll deductions. Note terms may not exceed five years, except for notes to fund the purchase of a principal residence, for which the Plan administrator may permit a longer repayment term. The notes are secured by the balance in the participant's account and bear interest at a rate available for similar notes from commercial lending institution. Participants may have three notes outstanding at a time.

Benefit Payments

Upon termination of service, death, disability, or normal retirement, the participant will receive the value of the vested interest in their account in the form of a lump sum distribution if the total balance does not exceed \$7,000. If a participant terminates employment and the participant's account balance exceeds \$7,000, the participant may receive the value of the vested interest in their account in either the form of a lump sum distribution or an annuity option. Prior to January 1, 2024, the threshold for automatic distributions was \$5,000. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan allows for in-service and hardship distributions, subject to Plan provisions.

Forfeited Accounts

Forfeited nonvested accounts can be used to pay administrative expenses or to reduce future Employer contributions. Forfeited nonvested accounts as of June 30, 2025 and 2024 and 2024, totaled \$199 and \$1,482, respectively. There were no forfeitures used to pay administrative expenses for the years ended June 30, 2025 and 2024. There were \$41,759 and \$26,217 forfeitures used to reduce Employer contributions for the years ended June 30, 2025 and 2024, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 or 2024. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain fees related to the administration of the Plan, notes receivable from participants, and benefit payments are charged directly to the participant accounts and are included in the administrative expenses. Investment-related expenses, including any revenue sharing credits, are included in the net appreciation of the fair value of investments.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through February 2, 2026, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of the notes receivable from participants and related interest income and all the investment information reflected on the accompanying statements of net assets available for benefits as of June 30, 2025 and 2024, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of June 30, 2025.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at June 30, 2025 and 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan entered into a group annuity contract with Principal Life Insurance Company (Principal). Principal maintains contributions in guaranteed investment contracts (GICs). The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Principal. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% or greater than 3%. The crediting rate is reviewed on a periodic basis. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer. The group annuity contract with Principal was terminated effective February 29, 2024, with a 12-month liquidation period, thus there is no balance in the general account as of June 30, 2025.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Employer contributions.

Effective July 31, 2024, the Plan experienced a partial plan termination due to the sale of a portion of the Plan sponsor. As of July 31, 2024, all affected plan participants are 100% vested in their plan accounts.

NOTE 8 PLAN TAX STATUS

The Plan is currently placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the volume submitter plan document indicating that the volume submitter plan document is qualified under Section 403(b) of the IRC and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, the qualified institution. Therefore, all the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment.
