Opinion

Note 1: Description of Plan

The following description of Graul's Market Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General: The Plan is a multiple-employer health and welfare plan covering all full-time employees of the participating employers who have been employed for at least two months. Graul's Benefit Trust, a Voluntary Employee Beneficiary Association (VEBA) under Internal Revenue Code Section 501(c)(9), is the funding vehicle for the Plan. Participating employers consist of various supermarkets owned by members of the Graul family. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits: The Plan provides medical benefits including prescriptions, dental and vision benefits for active employees and their qualified dependents. Medical, dental and vision benefits are provided through a fully-insured contract with Kaiser Permanente. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). The Plan does not provide for post-retirement benefits. In order to become eligible for benefits, participants must have been employed for two months and work at least thirty hours per week.

Employer Contributions: The Plan is fully insured by a third-party insurance carrier. Each participating employer makes contributions to the Plan based on monthly insurance premiums due, less any participant contributions.

Participant Contributions: Participants covered under the fully-insured plan are required to contribute a weekly amount based on the level of coverage they have elected.

Note 2: Summary of Significant Accounting Policies

Following is a description of the significant accounting and reporting policies of the Plan:

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Employer Contributions Receivable: Employer contributions receivable, if any, consist of Plan management's estimate of amounts due from participating employers necessary for payment of premiums. The Plan makes no provision for credit losses since all outstanding receivables are deemed to be collectible as insurance premiums are due by the Plan each month. Any non-payment of premiums would result in the suspension of coverage for that employer. For each of the years ended June 30, 2025 and 2024, there were no employer contributions receivable.

Participant Contributions Receivable: Participant contributions receivable consist of amounts withheld from employees by participating employers, through payroll deductions, for medical and dental coverage. No provision for credit losses has been established for participant contributions receivable, as the funds will be used to pay insurance premiums due in the following month. If the receivable is not remitted to the Plan, the premiums would not be paid, and the corresponding insurance coverage would lapse.

Note 2: Summary of Significant Accounting Policies (Continued)

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through January 30, 2026, the date the financial statements were available to be issued. During the period July 1, 2025 to January 30, 2026, there are no subsequent events that require recognition or disclosure.

Note 3: Income Tax Status

The Plan, and the related trust established under the Plan, qualify under Section 501(c)(9) of the Internal Revenue Code (the Code) and are therefore not subject to tax under present income tax law. The Plan and Trust are required to operate in conformity with the Code to maintain the tax-exempt status of the Trust. The Plan administrator believes the Plan and Trust are being operated in compliance with the applicable requirements of the Code, and therefore, continue to qualify as tax-exempt. The Plan's federal information returns are subject to examination by the IRS, generally for a period of three years after the returns are filed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 4: Plan Termination

Although the Plan sponsors have not expressed any intent to do so, they have the right to discontinue contributions and terminate the Plan, subject to the provisions of ERISA. In the event of termination, the Plan's assets are to be used for the payment of reasonable expenses incurred and other obligations of the Plan. The remaining assets, if any, are to be distributed in such a manner which, in the opinion of the trustees, will best effectuate the purposes of the Plan and remain in compliance with applicable law.

Note 5: Reconciliation of Financial Statements to Form 5500

The financial statements of the Plan for the years ended June 30, 2025 and 2024 did not differ from the amounts reported on Schedule H (Financial Information) of Form 5500 (Annual Return/Report of Employee Benefit Plan).

Note 6: Transactions with Parties-in-Interest

One of the participating employers provides certain accounting and administrative services to the Plan for which no fees are charged. Certain officers and employees of one of the employers are administrators of the Plan acting as fiduciaries and as trustees and are also participants in the Plan.

Note 7: Uninsured Balances

The Plan maintains its cash balances at one financial institution. Periodically during the year, the Plan's cash balances may exceed federally insured limits. The Plan has not experienced any losses in such accounts and believes it is not exposed to significant risk on cash balances.
