### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lutheran Family Services of Virginia, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

### Note 1 – Plan Description

---

The following description of the Lutheran Family Services of Virginia, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Lutheran Family Services of Virginia, Inc. and Stonebrook Community Services, LLC (the “Company”) who have completed two months of service and are age twenty-one or older. For a participant to be eligible to receive the discretionary Company match, they must complete one year of service. Employees are automatically enrolled in the Plan at 4% on the first day of the month after satisfying eligibility requirements, unless they elect otherwise. All employee deferrals will increase 1% each year, up to 10%, unless an employee elects otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Each year, participants may contribute any percentage up to 100% of annual compensation on a pre-tax or Roth basis, as defined by the Plan document, subject to *Internal Revenue Code (IRC)* limitations. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants may direct their contributions into various investments offered by the Plan. A safe harbor contribution is made on the participants’ behalf equal to 100% of elective deferrals up to 4% of compensation. A discretionary matching contribution may be contributed at the option of the Company’s Board of Directors. During the year ended June 30, 2025, the Company did not elect to make a discretionary matching contribution to eligible participants. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions, the Company’s safe harbor and discretionary contributions, and allocations of Plan earnings and is charged with administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their contributions and the Company’s safe harbor matching contribution plus earnings thereon. Vesting in the Company’s discretionary matching contributions plus earnings thereon is based on years of service. A participant is 100% vested after six years of credited service.

#### *Notes from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years unless the note is for purchase of a primary residence, in which case the term may exceed five years. Notes are secured by the balance in the participant’s account and bear interest at a rate of 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan originated. Interest rates on loans at June 30, 2025 ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

### *Payment of Benefits*

Upon attainment of normal retirement age of 55, termination of employment, or in the case of death or disability, a participant or their beneficiary will receive the vested portion of the amount credited to the participant's account. The participant may elect to receive either a lump-sum distribution or annual installments as defined in the Plan provisions. Hardship distributions, upon demonstration of financial hardship, and rollover distributions are allowed by the Plan. In-service distributions are permitted upon attaining age 59 ½, as defined.

### *Forfeitures*

At June 30, 2025 and 2024, forfeited non-vested accounts totaled \$2,238 and \$1, respectively. Forfeitures may be used to pay Plan expenses and reduce future employer contributions. During the year ended June 30, 2025, no forfeitures were used.

## **Note 2 – Summary of Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

### *Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Plan fees and administrative expenses are paid by the Plan or the Company, as provided by the Plan document. Expenses relating to specific participant transactions (distributions and loans) are charged directly to the participant's account.

### *Subsequent Events*

Evaluation of subsequent events was considered through February 2, 2026, the date the financial statements were available to be issued.

---

## **Note 3 – Fair Value Measurements**

---

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used only when Level 1 inputs are not available.

### *Level 1 Fair Value Measurements*

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

### *Level 2 Fair Value Measurements*

The fair value of the collective investment trust is based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The collective investment trust invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying assets values are quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

## **Note 4 – Investment Contracts**

A portion of the Plan's assets are invested in the Federated Capital Preservation Fund. Included in this fund are guaranteed investment contracts and certain wrapper contracts. These contracts are considered to be benefit-responsive. The average yield for the fund for the years ended December 31, 2024 and 2023 was approximately 3.32% and 3.69%, respectively. The percentage of contributions allocated to each fund is determined by the participants.

Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan.

Certain Plan investments are managed by Empower Trust Company, LLC (“Empower”). Empower is the Trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Empower Trust Company, LLC by the Plan for investment management and trust services amounted to \$81,122 for the year ended June 30, 2025.

Revenue sharing consists of 12b-1 fees, sub-transfer agency fees, shareholder servicing fees, or similar amounts, which the service provider receives from a source other than the Plan. In accordance with the Plan document, excess revenue sharing is deposited into an ERISA spending account, which is then used to pay Plan expenses. During the year ended June 30, 2025, revenue sharing of \$31,389 was received and used to pay Plan expenses to Pensionmark Financial Group, LLC for Plan advisory services. Administrative expenses are presented net of revenue credits.

---

### Note 6 – Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

---

### Note 7 – Tax Status

---

The Plan was restated effective August 24, 2021 to a non-standardized 401(k) plan sponsored by Great-West Trust Company, LLC to comply with new document standards. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *IRC*. Although the Plan has been restated, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
