Note 1 DESCRIPTION OF THE PLAN

The following description of Abhe & Svoboda, Inc. (the Company or Plan Sponsor) Health and Welfare Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan document for a more complete description of the Plan's provisions, copies of which may be obtained by the Plan Sponsor.

GENERAL

The Plan provides health and other benefits to eligible employees of the Company and covered dependents.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

BENEFITS

The plan provides health benefits (medical, dental, vision, and prescription drugs), group-term life insurance, short-term disability, critical illness and flexible spending and dependent care benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Employees covered by the Davis-Bacon Act are eligible for medical benefits upon accumulation of a dollar bank balance equal to the first month's premium. All other employees are eligible for medical benefits after 30 days of active employment with the Company, provided the employee is expected to work at least 20 hours per week. Eligibility for dental, vision, prescription drugs, group-term life insurance, short-term disability, critical illness, flexible spending and dependent care benefits begins after 30 days of active employment, provided the employee is expected to work at least 20 hours per week. Eligible employees and their covered dependents may participate on the first day of the month on or after meeting the eligibility requirements.

INSURED BENEFITS

The Plan provides certain fully insured benefits under its Component Benefit Programs. These insured benefits include the Hawaii medical plan, group-term life insurance, short-term disability, critical illness, and vision coverage. The Company purchases annual insurance contracts to provide these benefits. Premiums are paid through the assets of the VEBA trust. The insurance carriers are responsible for the payment of claims under these fully insured arrangements.

STOP LOSS COVERAGE

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

SELF-INSURED BENEFITS

The Plan self-funds certain health and welfare benefits, including the PPO medical plan, dental coverage, and the Consult-A-Doctor program. Claims under these self-funded Component Benefit Programs are paid directly to or on behalf of participants by third-party claims administrators and subsequently reimbursed by the VEBA trust or the general assets of the Company.

Although the Plan utilizes third-party claims processors, the Plan retains ultimate responsibility for benefit payments to providers and participants.

The Plan is funded through periodic assessments to the Company based on actual claims incurred. Any deficiency of the Plan's net assets available for benefits compared with benefit obligations is funded by the Company on a pay-as-you-go basis.

CONTRIBUTIONS

The Plan is funded through a combination of participant contributions, Company contributions, and periodic assessments based on actual claims incurred. Participants may elect pretax salary reductions, which may be applied toward group coverage, healthcare, or dependent care costs.

For employees working on prevailing wage projects subject to the Davis-Bacon Act, the Company contributes a fixed hourly fringe benefit rate to individual dollar bank accounts. Amounts credited to these accounts are accumulated and reflected in the financial statements as the dollar bank reserve. Dollar bank balances may accumulate up to a maximum of twelve months of medical premiums and are used to fund coverage in periods when monthly contributions or hours worked are insufficient to cover the required premium.

Dollar bank balances are forfeited if not used within twelve months after coverage ends, in accordance with the Plan's forfeiture provisions.

Employees contribute specified amounts toward coverage, determined periodically based on the level of coverage elected and the number of covered dependents. The Company makes additional contributions to the Plan as necessary to fund benefit claims and administrative costs in excess of participant cont.

Note 2 SUMMARY OF ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompany financial statements have been prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes, therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NON-INTEREST BEARING CASH

Non-interest bearing cash consists of demand deposits held at financial institutions. At April 30, 2025 and 2024, the Plan did not hold any cash equivalents. Cash is stated at cost, which approximates fair value. The Plan maintains cash balances at financial institutions that may, at times, exceed federally insured limits; however, management believes the risk of loss related to these balances is minimal.

BENEFIT OBLIGATIONS

As of April 30, 2025 and 2024, the Plan's benefit obligations consist of unpaid self-insured health and welfare claims, premiums payable, and the accumulated dollar bank reserve, all of which are presented in the statements of benefit obligations.

Benefit obligations for self-insured benefits include claims incurred but not reported ("IBNR") and claims payable. IBNR is estimated based on management's judgment and information available regarding claims incurred during the Plan year, including historical claims lag patterns and other relevant trend factors. Claims payable include amounts for claims that were adjudicated prior to April 30 but paid subsequent to that date.

Premiums payable represent amounts due to insurance carriers for coverage applicable to the Plan years ended April 30, 2025 and 2024, based on actual premium payments.

The accumulated dollar bank reserve represents Company contributions made prior to the measurement date that are attributable to eligible participants and designated for the purchase of future insurance coverage. The dollar bank reserve is measured based on participant account balances as of the measurement date and is adjusted for participant activity that has not yet been reflected in those balances.

The Plan does not provide post-retirement benefits.

PAYMENT OF BENEFITS

Premiums paid by the Plan are recorded as insurance premiums paid in the accompanying statement of changes in net assets available for benefits.

STOP LOSS

Premiums for stop-loss insurance are included in the insurance premiums paid reported in the statements of changes in benefit obligations and net assets available for benefits. Stop-loss refunds totaling \$164,763 have been netted against these insurance premiums paid.

ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, service providers and the Plan's broker. These expenses are reported on the statements of changes in benefit obligations and net assets available for benefits as administrative expenses. All other administrative expenses are paid by the Company on behalf of the Plan and therefore excluded from these financial statements.

SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through February 10, 2026, which is the date the financial statements were made available to be issued.

Note 3 PLAN TAX STATUS AND INCOME TAXES

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS dated December 16, 2010, stating that the trust is tax-exempt under the provision of Section 501(c)9 of the IRC. However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes. No federal or state income taxes have been recorded in the 2025 or 2024 Plan years for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 5 RISK AND UNCERTAINTIES

The estimate for claims incurred but not reported is based on assumptions related to claims lag and historical claims experience. The estimate for the accumulated dollar bank reserve is determined using participant dollar bank balances at a specific measurement date, adjusted for any additional participant activity that may not be reflected in those balances. Because these estimates rely on assumptions and involve inherent uncertainties, it is reasonably possible that changes in these assumptions in the near term could materially affect the financial statements.

Note 6 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.
