Opinion

INDEPENDENT AUDITORS' REPORT

Opinion

We have audited the accompanying financial statements of Sheet Metal Workers Local 33 Cleveland District Health Benefits Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of Sheet Metal Workers Local 33 Cleveland District Health Benefits Fund as of April 30, 2025 and 2024, and the changes in its net assets available for benefits and changes in plan benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

1. DESCRIPTION OF THE PLAN:

The following description of the Sheet Metal Workers Local 33 Cleveland District Health Benefits Fund (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a multiemployer health and welfare plan covering employees of those employers who have agreed to make the required contributions to the Plan per a collective bargaining agreement (CBA) between the International Association of Sheet Metal, Air, Rail and Transportation Workers Local Union No. 33 Cleveland District (Local 33) and the Cleveland Chapter of Sheet Metal and Air Conditioning Contractors National Association (SMACNA). The geographic territory includes Ashtabula, Cuyahoga, Geauga and Lake Counties of Ohio. Therefore, the Plan is affected by the economic conditions of the region. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The Plan provides medical, prescription, dental, vision, and short-term disability benefits to eligible participants (with at least one hour of work in the quarter preceding entry into the Plan). All benefits with the exception of short-term disability benefits, are provided to participants' beneficiaries and covered dependents. Retired employees who have attained age 65 are entitled to certain health benefits in excess of Medicare coverage. The Plan is not eligible to receive subsidies under Medicare Part D.

The Plan also provides health benefits to participants during periods of unemployment, provided they have accumulated from their previous work history, credit amounts (expressed in dollars) in excess of the premium charged by the Plan for current coverage. There is no limit on the amount of eligibility credits a member may accumulate. These credit amounts can also be used to offset the participant's deductibles or other medical expenses not covered by the Plan. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidate Omnibus Budget Reconciliation Act (COBRA).

Contributions

In accordance with the CBA, employers are required to make monthly contributions at a fixed dollar amount for each hour worked by participants. Participants and retirees may contribute to the Plan under self-pay or COBRA guidelines.

Claims processing

Health, medical reimbursement, self-insured, disability, and death claims of active participants, dependents and beneficiaries are processed by a third party administrator. The responsibility for payments to participants and providers is retained by the Plan.

Stop-loss coverage

The Plan has a stop-loss arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount). The deductible per plan participant for the plan years ending April 30, 2025 and 2024 was \$270,000. The Plan recognized stop-loss reimbursements and rebates of \$699,329 and \$- for the years ended April 30, 2025 and 2024, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Board of Trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and revenue recognition

Investments are reported at fair value. Fair value is a price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Reciprocity contributions

Participants of the Plan and participants of the benefit plans of other affiliated local unions may have temporary employment assignments outside the jurisdiction of their local union. Therefore, the Plan has entered into reciprocity agreements with other affiliated locals to ensure that employer contributions are forwarded to the benefit plans of the participant's local union. Reciprocal contributions received and reciprocal contributions paid are classified with employer contributions on the statements of changes in net assets available for benefits.

Payment of benefits

Medical claim payments are recorded when they are paid by the third-party claims processors. Short-term disability and dollar bank medical reimbursements are recorded when paid by the Plan. All claims are recorded as benefit claims paid in the accompanying statement of changes in net assets available for benefits.

Plan benefits

Obligations for claims payable and health claims incurred but not reported and postretirement benefit obligations are estimated by the Plan's actuary in accordance with accepted actuarial principles.

The Plan recognizes an obligation for future benefits arising from participants' accumulated eligibility credits. This obligation is based upon aggregate dollar bank balances accumulated from contributions made on behalf of participants in excess of the cost of coverage as determined by the Plan. The first \$6,000 of the dollar bank account is automatically used to pay the required premiums for the coverage selected by the participant.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Participants can utilize the balance in their individual accounts that exceeds \$6,000 for payment of eligible medical and related expenses and other non-covered benefits. The accounts may also be used for payment of disability benefits beyond the scheduled limits of the plan.

Employer contributions receivable

Employer contributions receivable represents amounts due from employers that were received subsequent to year end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected. In addition, it is impractical to estimate revenue recognition for amounts due but erroneously unreported by employers.

Subsequent events

The Plan has evaluated subsequent events through February 10, 2026, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS:

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

3. FAIR VALUE MEASUREMENTS (CONTINUED):

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Money market funds: Valued at cost, which approximates fair value.

Registered investment companies: Consists of mutual funds registered with the Securities and Exchange Commission. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds are required to publish their daily net asset value (NAV) and to transact at that price at the end of each trading day. Mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

(a) WTF - CTF Intermediate Bond Fund was established to invest in both domestic and foreign medium duration fixed income securities. The main objective is to achieve current income and capital appreciation.

4. BENEFIT OBLIGATIONS:

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to members' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated members and their beneficiaries and dependents, and (2) active members and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation is the amount that is to be funded by contributions from the Plan's participating employers, participating retirees, and from existing Plan assets. Prior to an active member's full eligibility date, the postretirement benefit obligation is the portion of the expected post-retirement benefit obligation that is attributed to that member's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an independent actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant, and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and expected date of payment.

Significant assumptions used in the actuarial evaluation are:

Discount rate: 5.00% for 2025 and 5.50% for 2024

Health trend rates:

- Non-Medicare and prescription drug: 9.6% graded to 4.5% over 17 years;
- Medicare medical and prescription drug: 9.6% graded to 4.5% over 13 years;
- Dental and vision: 4% & 3%, respectively.

4. BENEFIT OBLIGATIONS (CONTINUED):

Post-retirement Mortality Rates:

- Healthy: 95% of the Pri-2012 Headcount Weighted Blue Collar Healthy Retiree Mortality Table, projected generationally from 2012 with scale MP-2021
- Disabled: 95% of the Pri-2012 Headcount Weighted Disabled Retiree Mortality Table, projected generationally from 2012 with Scale MP-2021

Valuation assumption changes increased obligations by \$3,186,237. This was primarily the result of updating the valuation-year per capita health costs and trend rates on per capita health costs and retiree contribution rates. Other changes include updating contribution rates and decreasing the discount rate from 5.50% to 5.00%.

A postretirement benefit obligation has been recognized for the retiree medical benefits for eligible participants and their dependents upon retirement. The Plan's excess of benefit obligations over net assets available for benefits at April 30, 2025 and 2024 is primarily the result of the post-retirement benefit obligation, the funding of which is not fully covered by the contribution rate provided by the current collective bargaining agreement and current retiree self-payment rates. It is expected that the deficiency will be funded through future increases in the collectively bargained contribution rates and retiree self-payment rates.

The weighted-average health care cost-trend rate assumption has a significant effect on the post-retirement benefit obligation reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, that would increase the obligation at April 30, 2025 by \$321,840.

5. TAX STATUS:

The Plan has received an exemption letter from the Internal Revenue Service (IRS) stating that the VEBA trust established under the Plan was in compliance with the applicable requirements of the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). No federal or state income taxes have been recorded in 2025 or 2024 for unrelated business taxable income. The Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust was tax-exempt as of the financial statement date.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

The Plan pays all administrative expenses to operate the Plan and contracts with various service providers. These transactions are party-in-interest transactions under ERISA. Benesys, Inc., an unrelated party, provides benefit management services as well as claims administration. Payments to Benesys, Inc. for the years ended April 30, 2025 and 2024, totaled \$327,110 and \$312,759 respectively.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (CONTINUED):

The Plan pays administrative fees to the Local 33 Fringe Benefit Funds, Inc. for shared expenses. These expenses were allocated to the Plan on a fixed fee agreement. The amount reflected on the accompanying statements of changes in net assets for the years ended April 30, 2025 and 2024, totaled \$15,540 for each year.

KeyBank is the custodian of the Plan. The Plan contracts with independent investment managers for the management of the assets. The managers have been granted discretionary authority concerning purchases and sales of investments.

7. CONCENTRATION OF CREDIT RISK:

Checking accounts are maintained at local commercial banks. The Federal Deposit Insurance Corporation (FDIC) guarantees accounts against loss up to \$250,000. From time to time during the year, the balance in the Fund's checking accounting may exceed the FDIC limits.

9. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Plan's Board of Trustees has the right under the Plan to modify the benefits provided to participants and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward provision of benefits for or on account of the participants. No assets of the Plan may be used for purposes other than for the exclusive benefit of the Plan's participants.

10. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The determination of extended eligibility and claims incurred but not reported liabilities are based on certain assumptions with regard to health care costs and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
