To Whom It May Concern,

We are requesting a waiver of penalties related to the late filing of Form 5500 for the ADP 401k, Plan Number 215510, for the plan year ending 12/31/2024.

The filing was late due to circumstances beyond our control. On 8/6/2025, our office building was completely destroyed by a four-alarm fire. This event resulted in the loss of records, computer systems, and documents necessary to prepare and file the Form 5500 on time.

Following the fire, our immediate focus was on employee safety, restoring operations, and reconstructing records. Once sufficient information was recovered, we filed the Form 5500 as soon as reasonably possible.

The delay was not intentional, and we have taken steps to help ensure timely filings going forward. Given these extraordinary circumstances and our prompt corrective action, we respectfully request that all penalties be waived.
