**NOTE 1 - DESCRIPTION OF THE PLAN**

The Patagonia Works 401(k) Plan (the “Plan”) is a defined contribution plan with an optional cash or deferred arrangement. The Plan covers eligible employees, as defined in the Plan, of Patagonia Works (the “Company”). The Plan was effective July 1, 1988 and is subject to the provisions of the Employee Retirement Income Security of 1974 (“ERISA”).

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**A. Eligibility**

Regular and fixed term full-time and part-time employees of the Company are generally eligible to participate in the Plan after completing three months of service. Seasonal and temporary employees are excluded from participating in the Plan. Effective May 1, 2017, there is no age requirement to participate in the Plan.

**B. Contributions**

Participants may contribute, on a pre-tax basis, up to 50% of their compensation, as defined by the Plan, subject to Internal Revenue Code (“IRC”) limitations. Participants may also elect to make Roth 401(k) contributions. New participants are auto-enrolled in the Plan at 3% of compensation with a voluntary automatic escalation feature.

The Plan provides that the Company has the discretion to provide matching contributions to the Plan. During the most recent plan year (and currently), the Company matched participant’s contributions to the Plan in an amount equal to 50% of the first 5% of the participant’s compensation contributed to the Plan. The Company also makes a Safe Harbor matching contribution of 3% of compensation. The Company may also make, at management’s discretion, an additional contribution to the Plan in an amount to be determined each year. To receive an allocation of the discretionary contribution, an employee must be eligible and employed on the last day of the Plan year. For the Plan year ended April 30, 2025, the Company made employer matching contributions of \$4,088,292, employer Safe Harbor contributions of \$5,745,489 and a discretionary contribution equal to 3% of the employee’s compensation which totaled \$5,204,664. Catch-up contributions are permitted.

**C. Vesting**

Participants are immediately vested in their voluntary contributions, safe harbor contributions, rollover contributions and earnings thereon. Vesting in the Company’s matching and discretionary contributions and earnings thereon is based on years of service as follows:

**D. Participant Accounts**

Each participant’s account is credited with the participant’s contribution, rollover contributions, safe harbor matching contributions and allocations of (a) the Company’s matching and discretionary contributions and (b) the Plan’s earnings. Allocations of the Company’s matching and discretionary contributions to the different funds are based on the allocation percentages

that the participants choose. Allocations of the Plan's earnings are based on the different funds' earnings and the relative percentage of the funds the participants choose to hold. The benefit to which a participant is entitled is the benefit that can be provided from the vested amount in his or her account.

**E. Forfeitures**

Terminated participants' non-vested balances are forfeited and used to reduce future Company contributions. For the year ended April 30, 2025, forfeited non-vested accounts totaled \$319,595. As of April 30, 2025 and 2024, \$668,232 and \$324,807, respectively, was available to offset future Company contributions. Forfeitures totaling \$200,008 were applied to reduce employer contributions in the subsequent plan year.

**F. Notes Receivable from Participants**

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one year to a maximum of five years. The interest rate on loans is based on the prime rate plus 1% and is a fixed rate set for the term of the loan. Loans are secured by the participants' vested account balances.

**G. Benefits**

Benefits may be withdrawn upon termination of employment, becoming disabled, and/or attaining normal retirement age (age 59½). Upon termination, participants with a vested account balance in the Plan of no more than \$1,000 will have a lump sum payment paid directly to them. For participants with a vested account balance of more than \$1,000, but less than or equal to \$5,000, the balance will be rolled over to an Individual Retirement Account with Vanguard Fiduciary Trust Company if the participant does not elect a distribution or rollover to another account. Participants with a vested balance more than \$5,000 may elect to receive a lump sum payment, or equal installment payments over a period not to exceed the life expectancy of the participant or the joint life and last survivor expectancy of the participant and a designated beneficiary. In addition, participants having a vested balance greater than \$5,000 may choose to defer their payments until age 73 or normal retirement age per the Plan, whichever is later. Participants may withdraw their vested balances before normal retirement age in limited circumstances and subject to the Plan's provisions. Hardship withdrawals are permitted. Benefits are recorded when paid.

**H. Administrative Fees**

Plan administration and investment management expenses are permitted to be paid by the Plan. All other Plan expenses are paid by the Company.

**I. Fidelity Bond**

The Plan has coverage of \$10 million for Patagonia Works's fiduciary liability and coverage of \$2 million for crime related to ERISA plans. The \$2 million satisfies legal bond requirements.

**J. Risks and Uncertainties**

Investments are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**B. Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments of the Plan are held by Vanguard Fiduciary Trust Company and invested based solely upon instructions received from participants.

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are based on quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds and common stocks stated at fair value based on quoted market prices. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation of investments relates to mutual funds.

**D. Common/Collective Trust**

The Plan maintains a fully benefit-responsive Retirement Savings Trust III investment contract reported at contracted value. Contributions to the investment contracts are invested in a combination of synthetic and traditional investment contracts and cash and credited for interest and charged for participant withdrawals and administrative expenses. The trustee is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions within the terms of the Plan.

The Retirement Savings Trust has no unfunded commitments or redemption restrictions. The Retirement Savings Trust III is designed to preserve principal with returns comparable to short to intermediate-term fixed income securities. The average maturity range is 2 to 4 years.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan at any time. In the event the Company terminates the Plan, participants shall become 100% vested in the balance of their accounts and the Plan's assets shall be allocated as prescribed by ERISA and related regulations.

**NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS**

Vanguard Fiduciary Trust Company provides investment options offered under the Plan. Transactions in these funds, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 5 - INCOME TAX STATUS**

The Company adopted the Vanguard Group's Non-Standardized Pre-Approved Profit Sharing Plan with CODA. In June 2020, Vanguard received an opinion letter from the Internal Revenue Service that the Plan complies with applicable sections of the IRC. The plan administrator and tax counsel believe that the Plan is designed and is currently being operated in compliance with the qualification requirements of the IRC, and the related trust was tax-exempt as of the financial statement date.

**NOTE 5 - INCOME TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes the Plan has taken no uncertain tax positions that require adjustment to the financial statements.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at April 30, 2025 and 2024 and investment income for the year ended April 30, 2025 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan.

**NOTE 7 - PLAN AMENDMENT**

In March 2024, the Plan was amended to clarify certain eligibility provisions (including the non-eligibility of workers who work outside the U.S. and receive non-U.S. retirement benefits from the Company).

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through February 9, 2026, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
