Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Community Action Partnership of Lancaster and Saunders Counties 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Community Action Partnership of Lancaster and Saunders Counties 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Community Action Partnership of Lancaster and Saunders Counties (the "Employer") who have attained age 19 and have completed one month of service. The Plan excludes on-call and temporary employees, union employees and nonresident aliens. Plan entry dates are the first day of the month following meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The SECURE 2.0 act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022 makes significant changes to existing law for retirement plans by building upon provisions in the SECURE 2.0 act of 2019, SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to the other requirements of SECURE 2.0 by December 31, 2026.

Contributions

Participants may contribute up to 100% of annual compensation, as defined in the plan document, as pre-tax and/or after-tax Roth deferral contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows participants to roll over distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer can elect to contribute discretionary matching contributions. During the year ended December 31, 2024, the Employer made matching contributions equal to 100% of deferral contributions up to 3% of compensation. The Employer can also elect to contribute a nonelective discretionary contribution at the sole discretion of the Employer; however, no such contributions were made during the year ended December 31, 2024. Employer nonelective contributions are allocated pro rata based on participant compensation. The Plan includes an automatic enrollment feature, enrolling all newly eligible participants at a pre-tax deferral rate of 3%, unless the participant makes an affirmative election not to participate or makes an alternate deferral rate election. There is no annual automatic escalation feature within the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions, and allocations of (a) plan earnings (losses), (b) forfeitures of terminated participants' nonvested accounts, and (c) Employer's discretionary nonelective contributions. Participant accounts are reduced by withdrawals and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

A participant is fully and immediately vested in their deferral contributions and rollover contributions plus actual earnings thereon. A participant vests in Employer contributions and earnings thereon according to the following schedule:

Less than two years	0 %
Two	50 %
Three or more	100 %

In addition, there is full vesting upon death or disability of an employee.

Plan forfeitures arise as a result of participants who terminate service with the Employer before becoming 100% vested in Employer contributions. Forfeitures of nonvested participant balances are generally used to reduce Employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$23,360 and \$12,029.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum payment or installment payments equal to the value of the participant's vested interest in their account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The plan also allows for in-service distributions upon attaining age 65. Participants may withdraw their rollover contributions at any time. Hardship distributions are not allowed by the Plan.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Cash Equivalents

The Plan considers all highly liquid investments with original maturities of three months or less, including money market fund investments, to be cash equivalents.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to participant withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are allocated proportionately to plan participants based on their respective account balances and are reflected as investment expenses and included in total investment income. All other expenses are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through September 22, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid Atlantic Trust Company, the Custodian of the Plan as of December 31, 2024.

Note 5: Tax Status

The Employer has adopted a nonstandardized preapproved plan with an IRS notification letter dated November 30, 2020, which states the preapproved plan document, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receipt of the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6: Party-In-Interest Transactions

Administrative expenses included \$28,624 of fees paid to Mutual of America Life Insurance Company ("Mutual of America"). In addition, certain plan investments are managed by Mutual of America. Mutual of America was the recordkeeper during 2024, therefore, these transactions qualify as party-in-interest transactions.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the plan document to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
