We have performed an audit of the accompanying financial statements of Sunrise Community Health Center 401(k) Safe Harbor Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following is a brief description of the Plan and is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering substantially all employees of Sunrise Community Health (Sunrise). Employees of Sunrise who have one year of service, worked 1,000 hours and are age twenty-one or older are eligible to participate in the Plan. The primary purpose of the Plan is to provide participants with the opportunity to accumulate funds for their retirement, and to provide benefits in the event of disability or death. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration: The Plan is sponsored and administered by Sunrise. The appointed trustees are officers or employees of Sunrise. Sunrise has retained the services of Principal Life Insurance Company (Principal) as the Plan's contract administrator. Costs of administering the Plan are paid by the Plan.

Contributions: Each participant may elect to contribute up to 100% of the participant's compensation, not to exceed IRS limits, and have such amounts contributed to the Plan as pre-tax or Roth contributions. Pre-tax contributions are excluded from a participant's taxable compensation in accordance with the provisions of Section 401(k) of the Internal Revenue Code (IRC). The Internal Revenue Service (IRS) imposes certain restrictions on the amount of annual additions to an individual participant's accounts, as well as an aggregate limit on contributions, and requires compliance with certain nondiscrimination tests.

Participants who are age 50 or more may elect to make catch-up elective deferrals up to current limits. These elective deferrals are for eligible participants whose elective deferrals have been restricted by either a statutory ceiling or by a plan limit.

The Plan provides for the following types of contributions:

- **Employee Contributions:** Participants may make pre-tax or Roth contributions based upon a percentage of their eligible compensation, as defined by the Plan document. In addition, the Plan allows for voluntary employee contributions.
- **Safe Harbor Matching Contributions:** Effective January 1, 2010, Sunrise suspended the safe harbor matching contribution and continued the suspension through 2024.
- **Discretionary Contributions:** Sunrise may contribute a discretionary contribution each year. Effective May 1, 2010, Sunrise implemented a discretionary matching contribution equal to 100% of the participants' contributions up to a maximum contribution of 4% of eligible compensation, as defined by the Plan document, which continued through 2024. During the year ended December 31, 2024, Sunrise made total discretionary contributions of \$563,744.

NOTE 1 - DESCRIPTION OF THE PLAN

- **Rollover Contributions:** The Plan also allows rollover contributions, within IRS parameters, of part or all of a "qualified total distribution" received by a participant from a qualified plan of a previous employer. Rollover contributions into the Plan are 100% vested and non-forfeitable at all times.

Participant Accounts: Separate accounts are maintained for each participant and are credited with the participant's contributions, employer matching and profit sharing contributions, and rollover contributions, if any, including the allocations of earnings and losses to these accounts. Allocations are based on participant earnings or account balances, as defined. Participants direct the investment of their accounts by electing the percentages they wish to allocate between investment alternatives. Participants can change their investment allocations at their discretion by communicating directly with the Plan custodian.

Vesting: Participants are immediately vested 100% for all types of contributions.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a period of time not to exceed 10 years. Under the terms of the Plan Agreement, plan loans will bear a reasonable rate of interest determined by the plan administrator. Principal and interest is paid ratably through bi-monthly payroll deductions. As of December 31, 2024, the rate of interest on outstanding loans ranged from 5.25% to 10.50% with various maturities through September 2029.

Payment of benefits: If a participant's account balance at the time of the participant's retirement or termination is less than \$5,000, the participant is entitled to either a lump sum distribution, net of applicable taxes, or a rollover distribution for the full amount to another qualified plan. If the participant's account balance is greater than \$5,000, the participant is entitled to a lump sum distribution, net of applicable taxes, annuity payment option, rollover distribution or may leave the balance in the Plan. Hardship withdrawals are permitted by the Plan for certain allowable expenses only if all other means of withdrawals or loans have been utilized. Participants may not contribute to the Plan for six months following the hardship withdrawal.

NOTE 2 - ACCOUNTING POLICIES

Basis of accounting: The financial statements of the Plan are prepared using the accrual method of accounting.

NOTE 2 - ACCOUNTING POLICIES (continued)

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's management to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation: The investments are reported at fair value. The Plan's custodian, Principal, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition: Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants: Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payments of benefits: Benefits are recorded when paid.

Expenses: General plan administrative expenses may be paid out of the forfeiture account or paid by Sunrise. Investment management, distribution, and loan transaction fees are paid by the Plan participants.

Subsequent events: Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements and Disclosures* (ASC 820) provides a framework for measuring fair value under U.S. generally accepted accounting principles. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The following provides a general description of the three levels of inputs that may be used to measure fair value under ASC 820:

Level 1 - Inputs to the valuation methodology are based on quoted prices available in active markets for identical assets or liabilities on the reporting date.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology include significant inputs that are generally unobservable from objective sources. These inputs may be used with internally developed methodologies that result in management's best estimate of fair value including assumptions regarding risk. Level 3 instruments include those that may be more structured or otherwise tailored to the Plan's needs.

As required by ASC 820, financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – Level 1 classified securities. Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

NOTE 3 - FAIR VALUE MEASUREMENTS (continued)

Common Collective Trusts and Pooled Separate Accounts – Level 2 classified securities. Common collective trusts and pooled separate accounts are valued at net asset value (NAV) of units based upon the quoted market value of the underlying assets net of an investment management fee as estimated by Principal. NAV is a readily determinable fair value and is the basis for current transactions which may occur daily. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method are appropriate and consistent with other market participants, the use of different methodologies for assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – TAX STATUS

Sunrise adopted a Prototype Plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, stating that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since this favorable determination letter was received; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for federal or state income taxes is reflected in the Plan's financial statements.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 6 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation or depreciation in fair value of investments, and interest and dividend income for the year then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal, the trustee of the Plan.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments include an insurance interest account and registered investment company accounts managed by Principal. As Principal is the custodian of the Plan, transactions between the Plan and Principal qualify as exempt party-in-interest transactions.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intention to do so, Sunrise has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, the net assets will be distributed among the participants and beneficiaries of the Plan in accordance with the amount allocated to the account of each participating employee. Upon termination or partial termination of the Plan, all funds in each affected participant's account will be fully vested.
