### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Association to Benefit Children 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion*

### 1. Description of the Plan

The following description of the Association to Benefit Children 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement or summary plan description for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution 403(b) plan available to all employees of the Association to Benefit Children (the Employer, Plan Administrator, or Plan Sponsor). The Plan was established on March 1, 2000 and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) is the custodian and recordkeeper of the Plan. The plan was restated, and certain amendments were made to align with plan changes or legal requirements under the provisions of ERISA.

#### *Eligibility Requirements*

All employees are eligible to participate in the salary-reduction contribution portion of the Plan on the date of hire with the Employer. With respect to Employer contributions, participants become eligible upon completion of one year of service, with at least 1,000 hours of service.

#### *Contributions*

Participants may contribute a percentage of their salary, not to exceed certain limitations prescribed by the Internal Revenue Code (the Code). Participants who attain age 50 before the close of the Plan year are eligible to make catch-up contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Participants direct the investment of their contributions into various options offered by the Plan. The Plan offers the option to allow participants to have access to a self-directed brokerage account for mutual funds.

The Employer provides a non-elective discretionary contribution of 2% for all eligible participants employed at the end of each Plan year, regardless of their own contributions. Additionally, the Plan offers a matching contribution of 50% on the next 2%, resulting in a maximum total Employer contribution of 3% of eligible compensation. For the years ending June 30, 2025 and 2024, the Employer made non-elective discretionary and matching contributions of \$357,479 and \$335,419, respectively. To qualify for the employer contributions, a participant must complete one year of service and accumulate 1,000 hours of service.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Employer's contributions, and an allocation of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is equal to the value of the participant's vested account. Each participant has the authority to invest and reinvest the funds in various mutual funds, self-directed brokerage accounts, and a guaranteed interest contract.

### ***Vesting***

Participants are at all times 100% vested in their account balance, including any earnings thereon. Rollovers, employer matching contributions, and employer discretionary contributions are 100% vested at all times.

### ***Payment of Benefits***

Employees may elect to receive the value of their account as either a lump-sum distribution upon retirement, death, disability, financial hardship, upon reaching age 59½, or termination of services, or in installment payments, as defined in the Plan documents.

### ***Notes Receivable from Participants***

Participants are eligible to borrow from their vested accounts, in accordance with the Plan provisions. The minimum amount that may be borrowed is \$1,000. The participant loans are secured by the balance in the participant's account and bear interest at a fixed rate determined at the time of borrowing and fixed for the life of the loan. \$50,000 reduced by the highest outstanding loan balance of loans during the one-year period ending on the day before the new loan is made or the greater of one-half of the Participant's vested account or \$10,000, reduced by any outstanding loan balance on the date of the new loan is made, whichever is less. There is no limit on the number of outstanding loans. The loan is repaid through payroll deductions over a 20-year period if the loan is for the purchase of a home, or over a five-year period for all other reasons. Interest rates on loans shall be the prime rate plus 1% at the time the loan is granted.

## **2. Summary of Accounting Policies**

### ***Basis of Presentation***

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments, with the exception of the fully benefit-responsive contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Fully benefit-responsive investment contracts are valued at contract value. Contract value equals the sum of the contributions, earnings on the underlying investments, and a charge for participant withdrawals and administrative expenses. See Note 6 for the discussion on contract value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes are reclassified as a distribution based on the terms of the Plan document and recorded in benefits paid to participants in the statements of changes in net assets available for benefits. Fees charged by Principal and Prudential relating to notes receivable from participants are paid from the related participants' accounts.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain administrative expenses of the Plan are paid directly by the Employer and are excluded from these financial statements. Other administrative expenses, such as investment management, consulting fees, recordkeeping, and individual participant transaction fees, are paid for by the Plan.

## **3. Risks and Uncertainties**

The Plan provides for various investment options in any combination of funds offered by the Plan. These funds are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the valuation methodologies of these items held at June 30, 2025 and 2024.

*Mutual Funds* - The Plan's assets invested in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Account* - The Plan permits participants to establish a self-directed brokerage account under the *Schwab Personal Choice Retirement Account® (PCRA) - Mutual Fund Only investments*. The mutual funds held under the PCRA are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 5. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividend, and interest income on notes receivable from participants for the years ended June 30, 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

### 6. Fully Benefit-Responsive Guaranteed Interest Contract

At June 30, 2025 and 2024, the Plan has a fully benefit-responsive guaranteed interest contract with Principal Life Insurance Company. Because the guaranteed annuity contract held by Principal Life Insurance Company is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed annuity contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Generally, participants may withdraw all or a portion of their assets held in the guaranteed interest contracts without any fees or restrictions for benefit-responsive events (e.g., termination of employment, retirement, disability, death, etc.).

### 7. Party-in-Interest Transactions

Certain investments are issued and managed by Principal. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants also qualify as exempt party-in-interest transactions.

### 8. Late Remittances

During the Plan year ended June 30, 2025, employee salary deferral contributions and loan repayments totaling \$34,446 were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The Employer has remitted the lost earnings as of January 2026, and has implemented a procedure to ensure all future remittances are done within the prescribed time period.

### 9. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, each participant will continue to be 100% vested and the net assets of the Plan will be distributed, as prescribed by ERISA.

### 10. Tax Status

The Plan has adopted the Principal Life Insurance Company Prototype Non-Standardized 403(b) Plan. The Internal Revenue Service (IRS) has determined and informed Principal Life Insurance Company by a letter dated March 31, 2017, that the Plan is designed in accordance with the applicable sections of the Code. Accordingly, the Plan is permitted to rely on the opinion letter. Although the Plan has been amended since receiving the opinion letter, the Plan Sponsor believes that the Plan currently is designed and is being operated in compliance with the applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 11. Subsequent Events

The Plan's management has performed subsequent events procedures through February 12, 2026, which is the date the financial statements were available to be issued. There were no subsequent events requiring disclosure or adjustment to the financial statements.
