Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Work & Co. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of May 13, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period ended May 13, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

1. Plan Description

The following description of the Work & Co. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan was established effective July 1, 2015, as the Work & Co. 401(k) Plan.

The Plan was a participant-directed defined contribution plan covering substantially all employees of WorkAndCo International Inc. d/b/a Work & Co. (the Company or the Employer) who had attained at least 21 years of age. There was no service requirement for participation. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective January 22, 2024 Accenture LLP acquired the Company. In connection with that acquisition, effective May 13, 2025, the Plan merged into the Accenture United States 401(k) Match Savings Plan (the Accenture Plan). On May 14, 2025, assets totaling \$35,167,765, including \$80,738 in outstanding participant loans, were transferred to the Accenture Plan. On July 31, 2025, the remaining Plan assets held in the Principal Stable Value Z Fund totaling \$940,035 were transferred to Northern Trust, the custodian of the Accenture Plan.

Custodian and Administration of the Plan

The Plan sponsor was the Company. Principal Life Insurance Company (Principal) served as the Plan's custodian and recordkeeper since the establishment of the Plan. Principal held all assets of the Plan in accordance with the service provider contract with the Plan. The Investment Committee determined the appropriateness of the Plan's investment offerings and monitors investment performance.

Participant and Employer Contributions

Participants could contribute up to 100% of annual eligible compensation, as defined in the Plan, in the form of pre-tax or Roth deferrals through salary deductions. Participants could also contribute amounts representing distributions from other qualified plans (rollovers). Contributions were subject to certain annual dollar limitations as imposed by the Internal Revenue Service (IRS). Participants who had attained or were expected to attain age 50 before the close of the taxable year were permitted to make Catch-Up Contributions, as defined in the Plan document, but not in excess of Internal Revenue Code (Code) limitations.

The Company made a safe harbor contribution equal to 3% of the employee's compensation. The safe harbor contribution for the period ended May 13, 2025 was \$355,713. The Company could also make a discretionary matching and/or discretionary profit-sharing contribution. No discretionary contributions were made by the Company for the period ended May 13, 2025.

Participant Accounts

Each participant's account was credited with the participant's contributions, Company contributions, and allocation of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based upon the participant

earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Participants were also 100% vested in the Company's contributions.

Notes Receivable from Participants

Participants could borrow against their account balances subject to certain requirements as defined in the Plan document. Loans could not exceed a maximum of \$50,000 or 50% of the participant's vested interest in the Plan. The loans were generally repaid through payroll deductions. The loan repayment period was no longer than five years, except in limited circumstances, such as the purchase of a principal residence. Interest was to be charged at a rate to be fixed by the Plan administrator and, in determining the interest rate, the Plan administrator would take into consideration interest rates currently being charged on similar commercial loans by persons in the business of lending money. No more than one note was allowed at any time and repayment of the entire balance is permitted at any time.

Payment of Benefits

Participants' benefits under the Plan were payable to participants or their beneficiaries upon termination of employment, normal retirement, disability, financial hardship, or death. Benefits were payable in one lump-sum payment. Partial or installment payments were permitted only to satisfy required minimum distribution rules. Hardship withdrawals were available, as were in-service distributions to participants who had attained the age of 65. If a participant's employment was terminated with the Company, the Plan permitted distribution of the participant's account, not in excess of \$7,000, to be cashed out or transferred to an individual retirement account (IRA) without the participant's consent.

Forfeited Accounts

Participants were immediately vested in any employee and Employer contributions. Participants were not subject to forfeiture of any contributed amounts.

2. Summary of Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the Plan's financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for a discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's realized and unrealized gains (losses) on investments bought, sold, and held during the year.

Contributions Receivable

Participant contributions and any related Employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Discretionary contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Direct compensation paid by the Plan as administrative expenses totaled \$6,646 for the period ended May 13, 2025, which consisted of third-party administrative fees.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements related to investments and notes receivable from participants held as of May 13, 2025 and December 31, 2024, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the period ended May 13, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

4. Fair Value Measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and reflect management's best estimate of what market participants would use as fair value.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of May 13, 2025 and 2024.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded. Management believes that the most appropriate classification for these mutual funds is Level 1.

Common Collective Trusts - Common collective trusts (CCTs) are valued using the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. The bank collective trusts in which the Plan invests are direct-filing entities.

Pooled Separate Account - The pooled separate account is valued at its accumulation unit value (AUV), which approximates fair value. The AUV is determined daily based on the NAV of shares of the underlying fund, and the separate account may be redeemed daily. The separate account is not applicable to the leveling table. This investment is a direct-filing entity.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

Investments for which fair value is estimated using reported NAV or the equivalent are able to be redeemed on a daily basis. There were no unfunded commitments as of May 13, 2025 and December 31, 2024.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments were managed by Principal; therefore, the transactions related to these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules under ERISA. Associated Pension Consultants (Associated) was the outside third party administrator. Fees paid to Principal and Associated for contract administration were \$6,646 for the period ended May 13, 2025. Loans to participants also qualified as party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their employer contributions.

As discussed in Note 1, effective May 13, 2025, the assets of this Plan were transferred to the Accenture Plan.

7. Income Tax Status

The Plan used a pre-approved volume-submitter plan document sponsored by CCH Incorporated (CCH). CCH obtained the latest opinion letter on June 30, 2020, in which the IRS stated that the volume-submitter plan was in compliance with the applicable requirements of the Code. The Plan had been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and was operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Prohibited Transactions and Contingencies

During the years ended December 31, 2018 and December 31, 2022, the Company did not remit employee salary deferral contributions and loan payments totaling \$135,556 in a timely manner as required by DOL regulations. Management has calculated lost earnings, totaling \$185, related to these late remittances and deposited this amount in November 2023 to the affected participants.

The Company is responsible for any fines, excise taxes, and/or penalties or actions brought by the affected participants or regulatory authorities.

10. Subsequent Events

The Plan's management evaluated subsequent events through February 12, 2026, the date these financial statements were available to be issued. There were no subsequent events requiring adjustments to the financial statements or disclosures as stated herein.
