**Note 1 - Description of Plan**

The following description of the LifeSouth 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General**

The Plan, effective June 1, 2023, is a defined contribution plan covering substantially all employees of LifeSouth Community Blood Centers, Inc. (LifeSouth). Employees are eligible to participate as of their employment commencement date. There are no minimum age or service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Merger**

Effective February 8, 2024, the LifeSouth Community Blood Centers, Inc. 403(b) Plan merged into the Plan and, as a result, all of the assets of the LifeSouth Community Blood Centers, Inc. 403(b) Plan were transferred into the Plan. The LifeSouth Community Blood Centers, Inc. 403(b) Plan no longer exists as a separate plan. The assets that were transferred to the Plan included investments totaling \$8,775,744.

**Contributions**

Each participant can elect to contribute pre-tax and after-tax Roth deferrals, up to 100% of annual compensation, as defined by the Plan, subject to Internal Revenue Code limitations. Elective deferrals to the Plan commenced effective November 17, 2023. The Plan provides for the automatic enrollment of eligible participants at a pre-tax deferral rate of 3% of eligible compensation, unless the participant elects a contrary salary deferral election. Thereafter, employee contributions will automatically increase every year by 1% up to a maximum of 15%. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions, as defined by the Plan, subject to Internal Revenue Code limitations. Participants are also permitted to rollover amounts into the Plan from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. LifeSouth offers employer-only contributions through a separate defined contribution plan, the LifeSouth Retirement Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of investment earnings and charged with benefit payments and an allocation of investment losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. Participants are permitted to change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The \$50,000 maximum loan amount is reduced by the participant's highest loan balance during the past 12 months. The loans are secured by the balances in the participants' accounts and bear interest at rates of prime plus 1% with terms not to exceed five years, unless for the purchase of the participant's principal residence. Principal and interest is paid ratably through biweekly payroll deductions.

**Payment of Benefits**

Upon termination of service, retirement, disability or death, participants may receive a distribution equal to their vested account balance. Distributions may be paid in the form of a lump-sum payment. The participant's contributions may also be withdrawn for certain hardship situations.

In-service distributions are permitted provided that the participant has reached age 59 ½. In-service distributions may be paid in the form of a lump-sum payment and as a continuous right of withdrawal pursuant to which a participant may withdraw such amounts at such times as elected.

**Administrative Expenses**

The Plan permits payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately, based on the value of account balances, or as an equal dollar amount, based on the number of participants in the Plan. However, certain operating expenses of the Plan are paid by LifeSouth and are excluded from the financial statements. Plan administration and investment management fees reduce the participants' account balances. Expenses relating to specific participant transactions (i.e., loan administration, distribution request, etc.) are charged directly against the appropriate participant's account. Investment-related expenses are included in net appreciation in the fair value of investments.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition**

The Plan's investments in mutual funds and money market funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received primarily through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through January 12, 2026, the date the financial statements were available to be issued. No material events have occurred since May 31, 2025, that require recognition or disclosure in the financial statements.

**Note 3 - Information Certified by Fidelity Management Trust Company (Fidelity) and Voya Retirement Insurance and Annuity Company (Voya)**

The following summary of financial information included in the Plan's financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Fidelity and Voya as of and for the years ended May 31, 2025 and 2024, as permitted by 29 CFR 2520.103 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's independent accountants did not perform auditing procedures with respect to the information certified by Fidelity and Voya, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

**Note 4 - Investments and Fair Value Measurements**

The fair value measurement accounting literature provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- **Level 2** – Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from, or corroborated by, observable market data by correlation of other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at May 31, 2025 and 2024.

- **Mutual Funds** – Valued at quoted market prices, which represents the net asset value of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.
- **Money Market Funds** – Valued at quoted net asset value of shares held by the Plan at year-end as they are actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment earnings for amounts held in mutual funds reflect a combination of interest income, dividend income, realized gains and losses, and unrealized gains and losses depending on the composition of the underlying investments.

**Note 5 - Guaranteed Investment Contract**

The Plan's investment in the Voya Fixed Account is a fully benefit-responsive guaranteed investment contract with Voya, whose primary objective is stability of principal. Voya maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value of this fund, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Voya may impose restrictions on the ability to move Plan assets into or out of this investment option or among investment options in general under the contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of the equity wash provision, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit Voya to terminate the agreement prior to the scheduled maturity date.

**Note 6 - Tax Status**

The Plan is based on a Volume Submitter 403(b) Plan (the Volume Submitter Plan). The Internal Revenue Service ruled on March 31, 2017, that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of section 403(b) of the IRC. The Plan became effective after the Internal Revenue Service ruling. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more-likely-than-not, based on the technical merits, to be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 31, 2025, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 - Parties-in-Interest**

A party-in-interest is defined as: (a) a fiduciary or his relative; (b) a person who provides services to the plan; (c) an employer whose employees are covered in the plan; (d) an employee organization whose members are covered by the plan; (e) a direct or indirect owner of 50% or more of the corporation's stock, a partnership's capital interest, or a trust or unincorporated enterprise that is an employer or employee organization; (f) a corporation, partnership, trust, or estate of or in which 50% or more of the voting power, capital interest, or beneficial interest is directly or indirectly owned by the persons in items a-e; (g) an employee, officer, or person with authority similar to an officer's or director's, or a 10% or more direct or indirect shareholder, or any persons in items b-f; (h) a 10% or more direct or indirect partner or joint venture of a person in items b-f. Fidelity and Voya are the custodians of the Plan, NFP Retirement, Inc. and Morningstar are the Plan's investment advisors, Purvis, Gray and Company, LLP is the Plan's accountant, and Economic Group Pension Services, Inc. is the recordkeeper of the Plan. Such parties qualify as a party-in-interest to the Plan. Accounts managed by the custodians totaled \$11,965,606 and \$10,074,600 at May 31, 2025 and 2024, respectively. Fees paid to the custodians and affiliated entities, which qualify as party-in-interest transactions, amounted to \$93,765 and \$7,193 for the years ended May 31, 2025 and 2024, respectively. Notes receivable from participants also qualify as exempt party-in-interest transactions.

**Note 9 - Plan Termination**

Although it has not expressed any intent to do so, LifeSouth has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
