Note 1 - Description of Plan

The following description of the LifeSouth Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan, originally effective June 1, 1980, and most recently amended effective November 1, 2023, is a defined contribution plan covering substantially all employees of LifeSouth Community Blood Centers, Inc. (LifeSouth) who have attained the age of twenty-one and have at least one year of service, as defined. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan allows for LifeSouth (the Employer) to make a discretionary profit-sharing contribution in an amount determined by the Employer. During 2025 and 2024, the Employer contributed for each eligible participant an amount ranging from 3 ⅓% to 10% (depending upon years of service) of the participant's annual compensation, as defined. A participant must complete 1,000 hours of service during the Plan year and must also be employed on the last day of the Plan year, unless terminated due to death, disability, or attainment of normal retirement age, in order to be eligible to share in the profit-sharing contribution. Though the Plan is currently a profit-sharing only plan, LifeSouth has no immediate plans to not fund each eligible participant's account. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts (rollovers). Contributions are subject to Internal Revenue Code (IRC) limitations.

Participant Accounts

Each participant's account is credited with LifeSouth's contribution for the benefit of the participant, and an allocation of the Plan's earnings, and charged with benefit payments and an allocation of the Plan's losses and expenses. Allocations are based on participant earnings or account balances, as defined. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their rollover contributions. Vesting in Employer contributions is based on years of service. A participant's vested balance accrues at a rate of 20% per year beginning with the second year of service, with full vesting after six years of service. Upon participant death, disability, or attainment of normal retirement age, Employer contributions vest immediately.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The \$50,000 maximum loan amount is reduced by the excess of the participant's highest loan balance during the past 12 months minus the loan balance on the date a new loan is made. The loans are secured by the balances in the participants' accounts and bear interest at rates of prime plus 1% with terms not to exceed five years, unless for the purchase of the participant's principal residence. Principal and interest is paid ratably through biweekly payroll deductions.

Payment of Benefits

Upon termination of service, retirement, disability, or death, a participant may elect to receive benefits to which he or she is entitled under the Plan in one or more of the following methods:

- (i) One lump-sum payment; or
- (ii) Payments in equal monthly, quarterly, semiannual, or annual cash installments over a period not to extend beyond the participant's life expectancy (or the life expectancy of the participant and the designated beneficiary); or
- (iii) Purchase of an annuity to provide payments over a period not to extend beyond either the life of the participant or the life expectancy of the participant (or the life expectancy of the participant and the designated beneficiary).

Effective November 1, 2023, the Plan allows for in-service hardship withdrawals which are payable in one lump-sum.

Revenue Sharing

The Plan participates in a revenue sharing arrangement with Voya Retirement Insurance and Annuity Company (Voya). Under the terms of the arrangement, the Plan earns revenue credits based upon the Plan's investment holdings, which are funded to the Plan quarterly. These funds may be used to pay reasonable Plan expenses. Funds not used to pay Plan expenses are allocated to the Plan's forfeiture account. For the 2025 and 2024 Plan years, Voya contributed \$40,034 and \$34,037, respectively, in revenue sharing credits to the Plan and the Plan used \$39,331 and \$33,232, respectively, to pay qualified expenses. Revenue sharing credits are reported as a reduction of administrative expenses on the accompanying statements of changes in net assets available for benefits.

Forfeited Accounts

At May 31, 2025 and 2024, forfeited non-vested accounts totaled \$71,119 and \$30,749, respectively. These accounts may be used to reduce future Employer contributions and offset Plan expenses. Employer contributions for the Plan years ended May 31, 2025 and 2024, were reduced by \$71,119 and \$30,000, respectively, from forfeited non-vested accounts.

Administrative Expenses

The Plan permits payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately, based on the value of account balances, or as an equal dollar amount, based on the number of participants in the Plan. However, certain operating expenses of the Plan are paid by LifeSouth and are excluded from the financial statements. Plan administration and investment management fees reduce the participants' account balances. Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant's account. Investment-related expenses are included in net appreciation in the fair value of investments.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received primarily through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through December 10, 2025, the date the financial statements were available to be issued. No material events have occurred since May 31, 2025, that require recognition or disclosure in the financial statements.

Note 3 - Information Certified by Voya Retirement Insurance and Annuity Company

The following is a summary of the Plan's financial information and data included in the Plan's financial statements and supplemental schedule, which was certified by Voya as of May 31, 2025 and 2024, and for the years then ended, as complete and accurate, as permitted by 29 CFR 2520.103 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's independent accountants did not perform auditing procedures with respect to the information certified by Voya, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

Note 4 - Investments and Fair Value Measurements

The fair value measurement accounting literature provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from, or corroborated by, observable market data by correlation of other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes to the methodology used at May 31, 2025 and 2024.

Pooled Separate Accounts – Invest directly in designated actively traded mutual funds, which are valued daily at their net asset values. The Plan holds units of participation in the separate accounts, which are valued daily at their accumulation unit value. Accumulation unit value is determined based on the net asset value of the shares of the underlying mutual funds, the funds' dividends, and the contract's separate account charges. There are no redemption restrictions or unfunded commitments on these investments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment earnings for amounts held in pooled separate accounts reflect a combination of interest income, dividend income, realized gains and losses, and unrealized gains and losses, depending on the composition of the underlying investments.

Note 5 - Guaranteed Investment Contract

For the Plan years ended May 31, 2025 and 2024:

The Plan's investment in the Voya Fixed Account is a fully benefit-responsive guaranteed investment contract with Voya, whose primary objective is stability of principal. Voya maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value of this fund, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Voya may impose restrictions on the ability to move Plan assets into or out of this investment option or among investment options in general under the contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or

deletion of the equity wash provision, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit Voya to terminate the agreement prior to the scheduled maturity date.

Note 6 - Tax Status

The Plan is based on a non-standardized, defined contribution pre-approved plan, which received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the pre-approved Plan document was in compliance with applicable requirements of the IRC, and that the related trust is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the ruling. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 31, 2025, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Parties-in-Interest

A party-in-interest is defined as: (a) a fiduciary or his relative; (b) a person who provides services to the Plan; (c) an employer whose employees are covered in the Plan; (d) an employee organization whose members are covered by the Plan; (e) a direct or indirect owner of 50% or more of the corporation's stock, a partnership's capital interest, or a trust or unincorporated enterprise that is an employer or employee organization; (f) a corporation, partnership, trust, or estate of or in which 50% or more of the voting power, capital interest, or beneficial interest is directly or indirectly owned by the persons in items a-e; (g) an employee, officer, person with authority similar to an officer's or director's, or a 10% or more direct or indirect shareholder, or any persons in items b-f; (h) a 10% or more direct or indirect partner or joint venture of a person in items b-f. Voya is the custodian of the Plan, NFP Retirement, Inc. and Morningstar are the Plan's investment advisors, Purvis, Gray and Company, LLP is the Plan's accountant, and Economic

Group Pension Services, Inc. is the record-keeper of the Plan. Such parties qualify as parties-in-interest to the Plan. Accounts managed by the custodian totaled \$25,755,435 and \$23,067,805 at May 31, 2025 and 2024, respectively. Fees paid to parties-in-interest amounted to \$35,664 and \$24,469, net of revenue sharing credits, for the years ended May 31, 2025 and 2024, respectively. Notes receivable from participants also qualify as exempt party-in-interest transactions.

Note 9 - Plan Termination

Although it has not expressed any intent to do so, LifeSouth has the right under the Plan to permanently discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
