INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Alexandra Lozano Immigration Law 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Alexandra Lozano Immigration Law 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules, as listed in the table of contents, as of and for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

INDEPENDENT AUDITORS' REPORT (CONTINUED)

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of Alexandra Lozano Immigration Law 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Alexandra Lozano Immigration Law, PLLC (the Company and Plan Sponsor, and Plan Administrator), and its affiliates, effective June 1, 2024, Arreglatech, LLC and Salud Total LLC, who are not nonresident aliens, union employees, or leased employees and have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective July 1, 2024, the Plan was amended and restated to include the Company's affiliates, Arreglatech, LLC and Salud Total LLC, as participating employers and make changes to the Plan's provisions as described in the following paragraphs.

Contributions

Participants could elect to defer up to 100% of their compensation as defined by the Plan either on a pre-tax or after-tax basis. Effective July 1, 2024, participants may elect to defer up to 90% of their compensation as defined by the Plan either on a pre-tax or after-tax basis. Employees who have not declined participation or completed a salary deferral agreement as of the date of their eligibility to participate in the Plan will be automatically enrolled in the Plan with a pre-tax deferral rate of 3% invested in a fund designated by the Plan Administrator until changed by the participant. The Plan also provides for catch-up contributions for participants who reach the age of 50 by the end of the Plan year. The Plan provides for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code (the Code).

The Plan provides for a safe harbor matching contribution of 100% of the first 6% of annual compensation that a participant contributes to the Plan. Furthermore, the Plan provides for discretionary profit sharing contributions, and effective July 1, 2024, discretionary matching contributions. No discretionary profit sharing or matching contributions were made for the year ended December 31, 2024. During 2023, the Company determined it was necessary to make a qualified nonelective contribution as a result of untimely enrollment of participants. The Company accrued \$20,125 of other employer contributions included on the accompanying statements of net assets available for benefits.

Participants direct the investment of their contributions into various options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor and discretionary matching contributions, as well as an allocation of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant account earnings, compensation, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral and rollover contributions, and the Company's safe harbor and discretionary matching and profit sharing contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances excluding after-tax deferrals, subject to certain Department of Labor (DOL) and IRS requirements. Notes receivable terms range from 1 - 5 years, or longer for the purchase of a primary residence. Notes receivable are secured by the vested balance in the participants' accounts and bear interest at the prime rate plus 1.00%. Interest rates on notes payable ranged from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon attaining age 59½ or upon termination of service, a participants may elect to receive a lump-sum amount equal to the value of the participant's vested account. Effective July 1, 2024, participants may also elect to receive installments over a period of not more than their assumed life expectancies, and partial withdrawals. Active participants may make hardship withdrawals from their accounts, subject to Plan provisions.

Effective July 1, 2024, if the value of the vested benefits credited to a participant's account is \$7,000 or less at the time of termination, the entire amount will be distributed to the participant without the participant's consent.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee and custodian. See Note D for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments on a note receivable and the Plan Administrator deems the note receivable to be uncollectible, the balance on the note receivable from the participant is reclassified to benefits paid to participants.

Investment Income Recognition

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Contributions Receivable

Contributions from Plan participants and related Company profit sharing and safe harbor and discretionary matching and contributions are recorded in the year in which the employee's participant contributions are withheld from compensation. Any contributions attributable to the Plan year but not received by the trust by the last day of the Plan year are recorded as a receivable.

The carrying amount of contributions receivable are assessed for the need to record valuation allowances for expected credit losses. The valuation allowances are estimates derived from the Plan's historical losses of contributions receivable, adjusted for the Plan Administrator's assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by the Plan. Based on the Plan Administrator's assessment as of December 31, 2024 and 2023, no allowances for contributions receivable were recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

Income Taxes

Prior to July 1, 2024, the Company adopted a non-standardized pre-approved profit sharing plan with cash or deferred arrangement which received an opinion letter from the IRS dated November 18, 2020, stating that the Plan was designed in accordance with applicable sections of the Code. On July 1, 2024, the Company adopted a non-standardized pre-approved profit sharing/money purchase plan with cash or deferred arrangement which received an opinion letter from the IRS dated October 6, 2020, stating that the Plan was designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the opinion letters, the Plan Sponsor believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America (GAAP) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through January 31, 2026, the date which the financial statements were available to be issued.

NOTE C - CERTIFICATION

Notes receivable from participants and investment information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including notes receivable from participants and investments held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee and custodian.

NOTE D - FAIR VALUE MEASUREMENTS

The three levels of the fair value hierarchy, which are based upon the inputs used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets or liabilities (for example, exchange quoted prices).

Level 2 - Inputs to the valuation methodology are observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices in markets that are not sufficiently active to qualify as Level 1, other observable inputs, or inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs to the valuation methodology are significant to the fair value measurement and unobservable (for example, supported by little or no market activity).

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

As of December 31, 2023 the fair value of mutual funds (Level 1) was \$2,070,859. Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds are valued at the net asset values of shares held by the Plan at year end as reported on the active markets in which the investments are traded.

Self-directed brokerage accounts consist of interest-bearing cash.

The common/collective trust is valued at the net asset value of the units held by the Plan at year end. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the trust's underlying assets, less its liabilities. The assets of this trust are further described in Note E. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair values of certain financial instruments could result in different fair value measurements as of the reporting date.

NOTE E - INVESTMENT IN COMMON/COLLECTIVE TRUST

The Plan has an investment in the Invesco Stable Asset Fund - ADPZ Class (the Fund), which is a common/collective trust fund with a balance of \$99,271 and \$-0- at December 31, 2024 and 2023, respectively. Participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance within the Fund on a daily basis without restrictions.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include the payment of investment and administrative expenses by the Plan to the trustee and recordkeeper. Such transactions are exempt from being prohibited transactions.

ADP Retirement Services, LLC (ADP), the Plan's trustee effective July 1, 2024, provides certain administrative services to the Plan, including administrative and systems support services in support of the self-directed brokerage account. ADP receives revenue for this service of three basis points on the average daily balance of the self-directed brokerage accounts to be paid each quarter in arrears. These fees reduced the rate of return credited to the Plan for these investments and were netted within net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

Guideline, Inc. (Guideline), the Plan's recordkeeper through June 30, 2024, provided certain administrative services to the Plan. Guideline received revenue for these services at a crediting rate per investment of .08% of the funds' balances. These fees reduced the rate of return credited to the Plan for these investments and were netted within net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

NOTE I - DELINQUENT PARTICIPANT CONTRIBUTIONS

As required by ERISA Section 2510.3-102, the Company is required to segregate participant contributions to the Plan from its general assets as soon as practicable, but in no event more than 15 business days following the end of the month in which amounts are withheld from wages.

During 2024, the Company did not timely remit participant contributions and loan repayments totaling \$913. The delinquent loan payment of \$248 was remitted to the Plan in September 2024. As of December 31, 2024, lost earnings associated with the loan payment have not been remitted to the Plan. The delinquent loan payment of \$22 has not been remitted to the Plan as of December 31, 2024. Delinquent contributions and lost earnings totaling \$643 were remitted to the Plan in June 2025, at which time the late remittances were considered fully corrected.

During 2023, the Company did not timely remit participant contributions and loan repayments totaling \$99,040. As of December 31, 2024, lost earnings associated with these delinquent contributions have not been remitted to the Plan.
