Opinion

Notes to Financial Statements

April 30, 2025 and 2024

Note 1. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements of Rocky Mountain UFCW Unions & Employers Health Benefit Plan - Retirees (the Plan) have been prepared using the accrual basis of accounting.

Investments - The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions Receivable - Employer contributions due and not paid prior to year end are recorded as contributions receivable. Deficiencies identified through payroll compliance audits are recorded upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Contributions Paid in Advance - Certain participants make contributions to receive benefits under the Plan. Contributions received in advance of the corresponding eligibility period are recognized as deferred income.

Benefit Obligations - Benefit obligations were estimated by the Plan's actuarial consultant using accepted actuarial principles, based on claims experience, Plan benefits and other data as considered necessary.

Employer Contribution Income - Employer contributions are recognized in the period in which covered work is performed, based on the number of eligible participants and the contribution rate currently in effect, as set forth in the applicable collective bargaining agreement. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 2 within the grocery industry primarily located in the states of Colorado and Wyoming.

Note 1. Summary of Significant Accounting Policies (continued)

Commission Credits - The Plan's broker/benefit consultant receives commissions from a healthcare provider in relation to benefits provided. These commissions are returned to the Plan as credits.

Prescription Drug Rebates - The Plan utilizes a pharmacy benefit manager (PBM) who periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable.

Expenses - Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Reclassifications - Certain prior year amounts have been reclassified to conform with the current year's presentation.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through February 10, 2026, which is the date the financial statements were available to be issued.

Note 2. Description of the Plan

The Plan was established May 1, 2011 to provide medical and prescription drug benefits to retired participants and eligible dependents. The Plan is a multiemployer welfare plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Retirees receive benefits provided that the following requirements are met:

- At least 50 years old or totally disabled at termination of employment;
- Eligible for coverage immediately prior to termination of employment; and
- Either eligible (and apply for) disability pension from the Rocky Mountain UFCW Unions & Employers Pension Plan or eligible for active benefits for at least 15 years

Participants aged 65 and over and eligible for Medicare are covered under an insured program with Humana. Surviving spouses may continue coverage on a self-pay basis. Surviving dependent children and new spouses of surviving spouses are not eligible. The Plan also offers participants the option of participating in a health maintenance organization (HMO).

Participants should refer to the applicable summary plan description for more complete information.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

Note 4. Postretirement Benefit Obligations

Postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributable to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and (2) active employees and their beneficiaries after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

As reported by the actuary, some of the more significant actuarial assumptions were as follows:

Mortality rates:

Healthy - RP-2014 Healthy Blue Collar Headcount-Weighted Table scaled back to 2006, with generational projection using Scale MP-2017

Disabled - 110% of RP-2014 Disabled Retirees Mortality Headcount-Weighted Table scaled back to 2006, with generational projection using Scale MP-2017

Discount rate - 5.50%

Medical and prescription trend rates:

2025:

Pre-65 medical - 6.50% decreasing by .25% per year, ultimate rate 4.50%

Post-65 medical - 18.00% for the first year, then 5.00% per year thereafter

Prescription drug - 10.00% decreasing by .25% per year, ultimate rate 4.50%

2024:

Pre-65 medical - 6.50% decreasing by .25% per year, ultimate rate 4.50%

Post-65 medical - 0.00% for the first year, then 18.00%, and 5.00% thereafter

Prescription drug - 10.00% decreasing by .25% per year, ultimate rate 4.50%

Note 4. Postretirement Benefit Obligations (continued)

The trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of April 30, 2025 and 2024 by \$14,974,923 and \$11,832,468 respectively.

The Plan provides lifetime health care coverage to certain retirees and their dependents. For the years ended April 30, 2025 and 2024, retirees contributed approximately 69% and 75%, respectively, of the estimated cost of providing their postretirement benefits.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Changes in assumptions during the year ended April 30, 2025 primarily reflect changes in the claims costs and trend assumptions to reflect expected future experience based on a review of historical experience.

Changes in assumptions during the year ended April 30, 2024 primarily reflect changes in the claims costs and trend assumptions to reflect expected future experience based on a review of historical experience, and a change in the discount rate from 4.75% to 5.50% in order to reflect the interest rate environment as of the valuation date.

Actuarial gains and losses arise from differences between actual experience and assumptions. During the years ended April 30, 2025 and 2024, a net actuarial loss increased postretirement benefit obligations, primarily due to trend changes, updates to claims costs and retiree contributions and other changes including demographics.

The Plan's deficiency of net assets over benefit obligations relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate provided by the current collective bargaining agreements. However, the Plan empowers the Board of Trustees to increase to decrease the amount of self-payments by eligible retired participants and to modify the terms and conditions under which retiree eligibility may be maintained; therefore, the cost to the Plan can be reduced or eliminated prospectively by action of the Board of Trustees.

Note 5. Tax Status

The Internal Revenue Service has advised that the trust established under the Plan is exempt under Section 501(c)(9) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws. The Plan has been amended since receiving its notice of exemption. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United State of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's investments are classified within Level 1 of the fair value measurements hierarchy. The fair values of the mutual funds are determined by reference to the funds' underlying assets, which consist principally of marketable fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value as of the last business day of the period presented.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 8. Related Party and Party-in-Interest Transactions

The Plan has several related organizations, which include two labor unions, a pension plan and a welfare plan.

At April 30, 2025 and 2024, a net total of \$202 and \$2,308 respectively, was due from the related welfare plan. The Plan is owed its share of certain rebates and credits from the related welfare plan, based on actual claims incurred by retirees. Additionally, amounts may sometimes be owed for administrative expenses inadvertently paid by the Plan or on the Plan's behalf.

At April 30, 2025, a total of \$251,190 was due from the related pension plan for monthly premiums withheld from pension benefit checks but not yet remitted to the Plan.

The Plan pays fees and receives rebates or credits under several arrangements with service providers. These transactions are considered exempt party-in-interest transactions under ERISA.

Note 9. Funding Policy

Participating employers contribute \$18.34 per month per eligible active bargaining unit participant as required in their respective collective bargaining agreements, to subsidize the costs of providing health and welfare benefits to eligible retirees.

For the years ended April 30, 2025 and 2024, the monthly retiree contribution rates ranged from \$330 to \$760 depending on the type of coverage option selected. Contribution rates are based on Plan experience and are determined annually by the Trustees.

Note 10. Major Employers

Contributions from two employers accounted for approximately 97% and 98% of total employer contributions for the years ended April 30, 2025 and 2024, respectively. In the event these employers suspend contributions, the Plan would terminate coverage to the employers' participants, as required under the Plan document. The Plan would retain the risk of meeting current fixed administrative expenses until the appropriate adjustments were made.

Note 11. Concentration of Cash

The Plan places its cash with financial institutions deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000 per financial institution. Balances may at times exceed insured limits.

Note 12. Concentration of Plan Investments

The Plan has a significant portion of its assets invested in a fixed income mutual fund. This investment approximated 77% and 78% of the Plan's net assets available for benefits as of April 30, 2025 and 2024, respectively.

It is reasonably possible that changes in the fair value of this fund could materially affect the amounts reported in the statements of net assets available for benefits. If a significant decline in the fair value occurred during the next year, a change in the assumed rates of return used to calculate the present value of postretirement benefit obligations may be needed.

Note 13. Litigation

The Plan may be subject to claims and lawsuits which arise primarily in the ordinary course of its operations. The Trustees and legal counsel of the Plan are not able to predict the probability of any such claims. The Trustees believe any unfavorable outcome would not have a materially adverse effect on the operations or financial condition of the Plan.
