INDEPENDENT AUDITOR'S REPORT

To the Trustee and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Lampire Biological Laboratories, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Lampire Biological Laboratories, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. A more complete description of the Plan's provisions is contained in the Plan document.

General

The Plan is a defined contribution plan which was established August 1, 1998 by Lampire Biological Laboratories, Inc. (the Company and the Plan Sponsor) and restated effective as of January 1, 2016. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees whose employment is governed by a collective bargaining agreement under which retirement benefits were subject of good faith bargaining are not eligible and are excluded from participation in the Plan.

The Company has appointed an individual as the trustee of the Plan. Investments of the Plan are held by John Hancock Life Insurance Company (the Custodian).

Participation

The Plan is designed for salaried and hourly employees who are not covered by a collective bargaining agreement unless such agreement expressly provides for participation in this Plan. Employees are eligible to participate in salary deferrals upon attainment of age 18 and completion of one month of service. Employees can enroll in the Plan on the first day of the month coinciding with or next following the satisfaction of the eligibility requirements. Employees become eligible to participate in Plan matching contributions upon attainment of age 18 and completion of six months of service. Employees can enroll in the Plan matching contributions on the first day of the Plan year quarter coinciding with or next following the satisfaction of the eligibility requirements. Employees become eligible to participate in Plan profit sharing contributions upon attainment of age 18 and completion of one year of service. Employees can enroll in the Plan profit sharing contributions on the first day of the seventh month of the Plan year coinciding with or next following the satisfaction of the eligibility requirements.

Contributions

Participants may elect to contribute up to an amount not to exceed the Internal Revenue Code contribution limitations.

Company matching and profit sharing contributions are made at the discretion of management. The Company made \$93,311 and \$47,776 of matching contributions for the years ended April 30, 2025 and 2024. The Company did not make any profit sharing contributions for the years ended April 30, 2025 and 2024.

Participants may also transfer money from other qualified plans into the Plan as rollover contributions. Rollover contributions were \$-0- and \$66,859 for the years ended April 30, 2025 and 2024.

The Plan recognizes contributions receivable from the employer and participants based on amounts due pursuant to plan provisions and employee elections. These receivables are typically short-term in nature and are collected shortly after the plan year-end. The Plan evaluates expected credit losses using a historical loss rate methodology, which considers past collection trends and current economic conditions. Plan management determined it was not necessary to record an allowance for credit losses as of April 30, 2025 and 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants vest in the Company's contributions as follows:

Notes Receivable from Participants

A participant may borrow no less than \$1,000 at a time. In addition, the loan amount may not exceed the lesser of \$50,000 or one-half of the participant's vested account balance. Loans are secured by the participant's vested account balance. Interest rates on loans for participants are fixed at the prime rate plus 1%. The term of the loan shall not exceed five years unless the loan is used to purchase the participant's primary residence, in which case the term of the loan may be a reasonable period of time, but not to exceed thirty years. Both principal and interest payments on a loan shall be credited to the participant's account.

Payment of Benefits

Upon termination, death, disability, or reaching normal retirement age, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account, or partial withdrawals or installments but only with respect to minimum required distributions over a period of not more than the participant's assumed life expectancy. In general, an eligible participant's account distribution can be deferred until a later date unless the vested balance is \$5,000 or less in which case the balance will be distributed to the participant as a lump sum distribution. The Plan also allows for hardship withdrawals in certain circumstances.

Withdrawals

Participants may withdraw all or part of their pretax contributions for reasons of financial hardship once all distributions and loans under the plan have been exhausted. After reaching age 59½, participants may withdraw their entire vested balance for any reason.

Forfeited Accounts

As of April 30, 2025 and 2024, the forfeited nonvested account balance totaled \$129 and \$895. This account may be used to pay the Plan expenses or to reduce future Company contributions. For the years ended April 30, 2025 and 2024, \$2,786 and \$8,123 of the forfeited nonvested accounts were used to pay Plan expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan maintains its accounting records and prepares its financial statements on the accrual basis of accounting.

Use of Estimates

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities as of the date of the statements of net assets available for benefits, and additions and deductions from net assets for the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

FASB Accounting Standards Codification (ASC) 855-10 establishes general standards of accounting and disclosure of events that occur after the statement of net assets available for benefits date but before the date the financial statements are available to be issued. Subsequent events have been evaluated through February 10, 2026, the date that the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Pooled separate accounts: Valued at the net asset value (NAV) of units by the insurance company. The NAV, as provided by the Custodian, is based on the fair value of the underlying investments held by the fund less its liabilities. Since the NAV is determinable and published and is the basis for current transactions, the Plan has determined that the NAV has a readily determinable fair value and would be a level 1 input.

NOTE 4 – GUARANTEED INVESTMENT CONTRACT

The Plan invests in a fully benefit-responsive investment contract with John Hancock Life Insurance Company. Balances total \$11,362 and \$11,290 at April 30, 2025 and 2024. John Hancock Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is declared monthly. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5 – CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedules related to investments and notes receivable from participants held as of April 30, 2025 and 2024, and net appreciation in fair value of investments and interest for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan), a qualified institution.

NOTE 6 – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan's investments, including pooled separate accounts and a guaranteed investment contract, are sponsored and managed by John Hancock Life Insurance Company, the custodian of the Plan. John Hancock Life Insurance Company also acted as the third-party administrator and recordkeeper, as defined by the Plan. These transactions qualify as party-in-interest transactions.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 8 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 – EXCESS CONTRIBUTIONS

Based on nondiscrimination provisions of the Plan, excess participant deferral contributions of \$12,000 for the 2024 Plan year were recorded as a liability as of April 30, 2024. Excess participant deferral contributions of \$12,000 for the 2024 plan year were distributed in November 2024 to satisfy relevant nondiscrimination provisions of the Plan.

NOTE 10 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 – DELINQUENT EMPLOYEE DEFERRAL TRANSMITTALS

During the 2023 plan the Company did not timely remit certain employee deferral contributions to the Plan. The total amount of delinquent employee deferrals was \$43,651. The Company calculated the related lost earnings and fully corrected the delinquent transmittals, including the remittance of lost earnings, during the plan year ended April 30, 2024.

The Company filed an application under the U.S. Department of Labor's (DOL) Voluntary Fiduciary Correction Program (VFCP) for the Plan year ended April 30, 2023. On August 4, 2025, the Company received notification from the DOL that it had successfully completed the VFCP and that no further action was required.
