Independent Auditor's Report

To the Board of Trustees
Iron Workers Local 25 Health Care Trust

Opinion

We have audited the financial statements of Iron Workers Local 25 Health Care Trust (the "Trust"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and trust benefit obligations as of April 30, 2025 and 2024 and the related statements of changes in net assets available for benefits and changes in trust benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the financial status of the Trust as of April 30, 2025 and 2024 and the changes in financial status for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. We are required to be independent of the Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter

As explained in Note 8, the financial statements include investments valued at approximately \$18,400,000 (39 percent of net assets) at April 30, 2025 and \$17,600,000 (40 percent of net assets) at April 30, 2024, whose fair values have been estimated at net asset value. Management's estimates are based on information provided by the investment fund manager. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Trust's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Trust; and determining that the Trust's transactions that are presented and disclosed in the financial statements are in conformity with the Trust's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that audits conducted in accordance with GAAS will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Trust's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Supplemental Schedules Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedules of assets held at end of year as of April 30, 2025 and reportable transactions and nonexempt transactions for the year ended April 30, 2025 are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplemental information required by the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of the Trust's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Fund Description

The following description of Iron Workers Local 25 Health Care Trust (the "Trust") provides only general information. A more complete description of the Trust's provisions is contained in the benefit plan document and collective bargaining agreements.

General

The Trust is a multiemployer plan established as a result of collective bargaining agreements to provide life insurance coverage and health care, disability, vision, and dental benefits for eligible participants employed in the steel erection industry in southeastern Michigan. Contributions to the Trust are made by employers based on a formula determined by the collective bargaining agreement between the employer and the Iron Workers Local 25 Union. Participants may make contributions in accordance with fund provisions to continue coverage after retirement or during periods of unemployment. The Trust is primarily self-insured but does offer some fully insured products based on certain collective bargaining agreements.

The Trust also includes Health Reimbursement Accounts (HRA) for eligible active participants. For hours worked on or after June 1, 2022, a portion of contributions received will be credited into active participant's HRA and participant submit claims for reimbursement of eligible expenses.

Termination

While it has not expressed any intent to do so, the sponsor has the right under the Trust to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Trust subject to the provisions set forth in the plan agreement and in the Employee Retirement Income Security Act of 1974 (ERISA).

Note 2 - Summary of Significant Accounting Policies

Contributions Receivable and Contributions from Employers

Contributions receivable of the Trust include amounts to be collected from employers for hours worked on or prior to April 30 of each year and amounts collected into the Iron Workers Local No. 25 Service Corporation (Service Corporation) collection account but not transferred to the Trust prior to April 30. The balance due from the Service Corporation is \$3,012,831 and \$3,014,399 as of April 30, 2025 and 2024, respectively.

Contributions from employers are recorded on the accrual basis in the fund year to which the contribution applies except where collection is doubtful, in which case they are recorded upon the receipt of the contributions. Other revenue, such as self-payments, is recorded in revenue when earned. Self-payments for active employees are calculated as the difference between the current monthly cost and the difference between the accumulated contributions bank. Active employees are allowed to make three self-payments. Retiree self-payments are determined from time to time by the board of trustees.

Other Accounts Receivable

Other accounts receivable include rebates owed to the Trust related to prescription claims at year end and a stop-loss insurance reimbursement owed to the Trust.

Investment Valuation and Income Recognition

Investments held by the Trust are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Note 2 - Summary of Significant Accounting Policies (Continued)

Deposits

Deposits represent amounts deposited in advance for benefit payments processed by independent agencies and insurers.

Benefit Payments

Benefits are recorded when paid.

Risks and Uncertainties

The fund benefit obligations are reported based on certain assumptions pertaining to employee demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

Claims Incurred but not Reported

The Trust's liability for incurred but unreported claims is estimated using payments made subsequent to year end in conjunction with historical trend information. Claims can be submitted for payment up to 12 months following the date of service.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Party-in-interest Transactions

During the year ended April 30, 2023, the Trust entered into an inadvertent extension of credit to a service provider and related fund of approximately \$1,800,000, which qualifies as a nonexempt transaction. Interest was paid to the Trust subsequent to year end; however, corrective filings have not been filed as of April 30, 2025. See the schedule of nonexempt transactions.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 11, 2026, which is the date the financial statements were available to be issued.

Note 3 - Trust Administration and Operating Expenses

Iron Workers Local 25 Pension Trust, Iron Workers Local 25 Vacation Pay Trust, Iron Workers Local 25 Training Trust, Iron Workers Local 25 Defined Contribution Retirement Trust, and the Trust collectively represent the "Iron Workers Fringe Benefit Funds." The expenses incurred in connection with the administration of these funds are recorded as operating expenses. A portion of the expenses is paid initially by the Service Corporation. The Service Corporation is reimbursed by the remaining Iron Workers Fringe Benefit Funds for their share in such expenses.

Note 3 - Trust Administration and Operating Expenses (Continued)

Included in the above-mentioned operating expenses are office expenses for administrative costs of the Trust in the amount of approximately \$0 and \$8,000 for the years ended April 30, 2025 and 2024, respectively. The amount due from the Iron Workers Local No. 25 Service Corporation related to self-payments collected totaling approximately \$108,000 and \$242,000 at April 30, 2025 and 2024, respectively. The amount of operating expenses, primarily legal and payroll audit costs, incurred by the Service Corporation on behalf of the Trust and reimbursed to the Service Corporation was approximately \$114,000 and \$43,000 for the years ended April 30, 2025 and 2024, respectively.

Note 4 - Benefit Obligations

Future Benefits

The obligation for accumulated eligibility credits represents an estimate of the Trust's liability for claims to be paid for participants eligible for future benefits based on hours worked through the years ended April 30, 2025 and 2024 and eligibility rules in effect at those dates. The eligibility rules and benefit levels that govern the payment of future claims are subject to modifications at any time by the Trust's board of trustees.

The Trust provides its retired members with the opportunity to purchase health care insurance and death benefits. The related benefit expense is recorded when incurred, and any offsetting member premium payments are recorded when earned and deemed collectible.

Health Reimbursement Account

Health reimbursement account claims, included in the Trust's benefit obligation, result from a benefit added to the Trust during 2023 providing participant reimbursements for certain medical expenses. Reimbursement amounts are based on an accumulated available amount based on a contribution per hour. The obligation for unpaid health reimbursement account claims represents both reported and unprocessed claims and incurred but not reported claims for such reimbursements.

Note 5 - Tax Status

The Trust has received a determination letter from the Internal Revenue Service indicating that the Trust, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Trust has been amended since receiving the determination letter, management believes that the Trust is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Note 6 - Stop-loss Program

The Trust has entered into a stop-loss insurance (reinsurance) contract to limit its exposure to large medical claims. The terms of the agreement provide that the insurance company will reimburse the Trust for medical benefits paid in excess of \$600,000 paid in aggregate for each participant claim during the plan year.

Note 8 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Trust has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Trust's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 8 - Fair Value Measurements (Continued)

The following valuation methodologies have been used to value the Trust's investments:

Money Market Fund and Mutual Funds

These investments are valued based on quoted market prices reported in active markets.

Debt Securities

These investments are valued using quoted market prices and/or other market data for the same or comparable instruments and transactions in establishing the prices, discounted cash flow models, and other pricing models. These models are primarily industry-standard models that consider various assumptions, including time value and yield curve, as well as other relevant economic measures.

Limited Partnerships and Limited Liability Companies.

These investments are valued based on the Trust's percentage ownership of the net assets of each entity or at net asset value per share (NAV) (or its equivalent) based on audited financial statements, with adjustments to account for partnership activity and other applicable valuation adjustments, where applicable.
