Independent Auditor's Report

To the Audit Committee and the Retirement & Benefits Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Georgetown Day School, Inc. 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of May 1, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period January 1, 2025 through May 1, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Georgetown Day School, Inc. 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of May 1, 2025 and December 31, 2024, and for the period January 1, 2025 through May 1, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of Georgetown Day School, Inc. 403(b) Retirement Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Georgetown Day School, Inc. 403(b) Retirement Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Georgetown Day School, Inc. 403(b) Retirement Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such contracts and accounts also have been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these contracts and accounts and the related income and distributions be included in the accompanying financial statements.

Emphasis of Matter - Plan Merger

As discussed in Note 2 to the financial statements, the Board of Trustees of Georgetown Day School, Inc., the Plan's sponsor, voted on October 29, 2024, to merge the Plan into the Independent Schools of Maryland and Greater Washington Multiple Employer Plan effective May 1, 2025. All Plan assets and accumulated benefits were transferred to the control of the Independent Schools of Maryland and Greater Washington Multiple Employer Plan on May 1, 2025. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3) (C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Georgetown Day School, Inc. 403(b) Retirement Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of Georgetown Day School, Inc. 403(b) Retirement Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Georgetown Day School, Inc. 403(b) Retirement Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the period January 1, 2025 through May 1, 2025 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

1. Description of Plan

The following description of Georgetown Day School, Inc. 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 1958, as restated January 1, 2024. The Plan covers all employees, excluding non-resident aliens. Matching contributions exclude employees who normally work less than 20 hours per week and union employees of Georgetown Day School, Inc. (the "School"). Participants must be age 21 or older to be eligible for the School's matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Plan Merger

On May 1, 2025, the Plan was merged into the Independent Schools of Maryland and Greater Washington Multiple Employer Plan and net assets of \$105,470,032 were transferred to the new Plan. The transfer of net assets is presented as transfers to another plan in the accompanying statement of changes in net assets available for benefits for the period ended May 1, 2025. The merger does not impact participant benefits as the benefit provisions were incorporated in the Independent Schools of Maryland and Greater Washington Multiple Employer Plan.

Department of Labor Investigation

In a letter dated March 25, 2025, the Plan Administrator was notified by the Department of Labor ("DOL") that it had opened an investigation of the Plan. The DOL investigation related to previously reported delinquent participant contributions for the year ended December 31, 2023. The investigation extended into transactions for the year ended December 31, 2024, where additional variances and delinquent contributions were identified. See Note 10 for further discussion of delinquent participant contributions. Since the field visit by the DOL on September 17, 2025, there has been no additional communication from DOL. As of May 1, 2025, the Plan has not recorded any accruals related to this matter, as any potential penalties are considered remote.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The School makes a nondiscretionary matching contribution based on each participant's service time with employer. For participants with up to six years of service, the School makes a matching contribution of 100% of the first 5% of compensation deferred. Participants with at least six years of service but less than 10 years of service are matched at a rate of 100% up to 7% of compensation deferred. Participants with over 10 years of service receive matching contributions of 100% up to 8% of compensation deferred. Additional discretionary amounts may be contributed by the School at the option of the Board of Directors. For the period January 1, 2025 through May 1, 2025, there were no discretionary contributions to the Plan. Participants must be age 21 or older to be eligible for the School's matching contributions. The School may, at its discretion, contribute to the Plan on behalf of eligible participants, an employer basic contribution. This employer basic contribution shall be allocated to each eligible participant in the same ratio that such participants' compensation bears to total compensation. For the period January 1, 2024 through May 1, 2025, no such contributions were made to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, School matching contributions, allocations of the School's discretionary contributions and an allocation of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the School's contributions plus actual earnings thereon.

Forfeited Accounts

As of May 1, 2025 and December 31, 2024, forfeited nonvested accounts totaled \$0 and \$42,042, respectively. During the period January 1, 2025 through May 1, 2025, \$24,348 of forfeitures were used to offset employer contributions and \$18,048 was transferred to Independent Schools of Maryland and Greater Washington Multiple Employer Plan.

Plan Loans

Prior to January 1, 2024, participants could borrow directly from the custodian, subject to certain limitations, by using a portion of their Plan account as security for the Plan loan. These loans do not occur directly within a participant's account but rather through a designated custodian account. Outstanding loan balances were \$0 and \$22,068 at May 1, 2025 and December 31, 2024, respectively, and are not reported within the accompanying financial statements of the Plan but serve as collateral against the outstanding plan loan balances. Interest on these loans is paid directly to the custodian. The amount transferred to Independent Schools of Maryland and Greater Washington Multiple Employer Plan was \$14,691.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined daily, is set at the rates commensurate with local prevailing rates, as defined. Principal and interest are paid ratably through monthly ACH transfers by the participant to TIAA. Terms range up to five years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the Plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump-sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, the Plan has excluded such annuity contracts and custodial accounts from investments in the accompanying statements of net assets available for benefits, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, "Annual Reporting Requirements for 403(b) Plans." The investment income and distributions related to such annuity contracts and custodial accounts also have been excluded from the accompanying statement of changes in net assets available for benefits. U.S. GAAP requires that these annuity contracts and custodial accounts and the related income and distributions be included in the accompanying financial statements. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement & Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

Subsequent Events

The Plan's management evaluated events that occurred after May 1, 2025 through February 12, 2026, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of May 1, 2025 and December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investment Contracts at Fair Value (Guaranteed Investment Contracts (Non-Benefit-Responsive)): Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Variable Annuities and Delaware Statutory Trust Funds: Valued at the daily unit value published on NASDAQ. The funds are not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the funds.

Pooled Separate Account: The TIAA Real Estate Account is a pooled separate account for which daily unit values are published on NASDAQ. The account is not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the account.

Access Annuities: Subaccount unit values are calculated daily and are available on the TIAA and CREF website, tiaa-cref.org. The underlying investments are generally valued using market quotations obtained from independent pricing services.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Fully Benefit-Responsive Investment Contracts

The Plan holds traditional fully benefit-responsive guaranteed investment contracts with TIAA and ReliaStar, for which contributions are maintained in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the sponsoring trustees, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The TIAA Traditional Annuity's crediting interest rate is based on a formula agreed upon with the issuer but will generally be between 1% and 3%. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1. Such interest rates are reviewed on a quarterly basis for resetting.

The TIAA Stable Value Annuity provides a guaranteed minimum rate of interest of between 1% and 3% with the potential for crediting of additional interest above the guaranteed minimum if approved by TIAA. The TIAA Stable Value Annuity is immediately liquid to an investing participant for Plan benefit withdrawals and transfers and does not have withdrawal restrictions (except that immediate transfers cannot be made to competing funds pursuant to the contract's equity wash provisions).

The crediting interest rates for the ReliaStar guaranteed investment contract will never be below 1%.

The Plan's ability to receive amounts due is dependent on the issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuers. These events may be different under each contract. Such events include:

1. amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or
5. premature termination of the contract.

The Plan Administrator does not believe any events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or,
4. a material amendment to the agreement without the consent of the issuer.

5. Information Certified

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2025 and 2024. Accordingly, TIAA and CREF, the Plan's issuers of certain investments and as agents for TIAA Trust, N.A., custodian of certain other investments, have certified the completeness and accuracy of the following investments and notes receivable from participants reported as part of the transfer out to another plan in the accompanying statement of changes in net asset available for benefits for the period January 1, 2025 through May 1, 2025. TIAA and CREF have also certified the completeness and accuracy of investments in the statements of net assets available for benefits as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the period January 1, 2025 through May 1, 2025. Additionally, ReliaStar Life Insurance Company, a certifying entity of the Plan, and Lincoln Investment Planning, LLC, as agent for UMB Bank, n.a., a custodian of the Plan, certified to the completeness and accuracy of the investments, cash, and notes receivable from participants held by ReliaStar Insurance Company and UMB Bank, n.a. as of December 31, 2024.

6. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by the issuers, certifying entity, or custodians, and therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. TIAA and CREF receive revenue from investment fund service providers for services it provides to the funds. This revenue is used to offset certain amounts owed to TIAA and CREF for their administrative services to the Plan. If the revenue received by TIAA and CREF from such investment fund service providers exceeds the amount owed for their services, TIAA and CREF remit the excess to the Plan's trust on a quarterly basis. The Plan or Plan sponsor may make a payment to TIAA and CREF for administrative expenses not covered by revenue sharing.

Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the School. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

The Plan merged into another plan effective May 1, 2025 (Note 1).

8. Tax Status

The Plan adopted a volume submitter plan offered by TIAA stating that the written form of the underlying specimen plan is qualified under Section 403(b) of the Internal Revenue Code. The volume submitter plan received an IRS Advisory Letter dated August 7, 2017, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Advisory Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024, one investment represented a concentration of greater than 10% of the Plan's net assets available for benefits.

10. Delinquent Participant Contributions

For the period January 1, 2025 through May 1, 2025 and the year ended December 31, 2024, the School did not remit certain participant contributions to the Plan on a timely basis per the definition of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

During the period January 1, 2025 through May 1, 2025, untimely remittances, as identified on the Schedule of Delinquent Participant Contributions, totaled \$94,056, all of which were remitted prior to May 1, 2025. For the years ended December 31, 2024 and 2023, untimely contributions totaled \$510,370, of which, \$506,133 were remitted prior to May 1, 2025. The remaining \$4,237 was remitted during the period May 2, 2025 through December 31, 2025.

A portion of the lost earnings on these late contributions were paid by December 31, 2025. The remaining lost earnings will be remitted in 2026.

11. Operational Deficiencies

Effective January 1, 2024, the Plan amended its nondiscretionary employer matching contribution schedule. Due to errors with the implementation of the new match, certain participants received less than they were entitled to receive under the new schedule. The Plan has recorded receivables of \$40,549 and \$29,374 related to this omission. The missed amount was remitted by December 31, 2025 and related lost earnings will be paid during the year ending December 31, 2026. The receivable as of May 1, 2025 also includes unremitted matching contributions of \$4,231, which were remitted by December 31, 2025.

Effective January 1, 2024, the Plan also changed the requirements for eligibility for the Plan to include employees working less than 20 hours a week. However, the Plan sponsor failed to notify certain employees that they were eligible for participation. The Plan has recorded a Qualified Non-Elective Contribution ("QNEC") as of May 1, 2025 and for the period January 1, 2025 through May 1, 2025 of \$3,679 to make up for missed deferral opportunities and lost earnings.
