Independent Auditor's Report

Opinion

We have audited the financial statements of Iron Workers Local 25 Defined Contribution Retirement Trust (the "Trust"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of April 30, 2025 and 2024 and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

April 30, 2025 and 2024

Note 1 - Plan Description

The following description of Iron Workers Local 25 Defined Contribution Retirement Trust (the "Trust") provides only general information. Participants should refer to the plan agreement for a more complete description of the Trust's provisions.

General

The Trust was established effective March 1, 2010 as a result of collective bargaining agreements. The Trust is a defined contribution plan that provides benefits to all eligible employees of iron structural employers who have completed one hour of service. The Trust is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Contributions to the Trust are funded entirely by employer contributions, as specified in collective bargaining agreements.

Participant Accounts

Each participant's account is credited with the employer's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Trust.

Vesting

Participants are immediately and fully vested in their participant accounts and have a nonforfeitable right to the balance in their individual accounts.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Empower Retirement (Empower) or its affiliates. Empower is the participant recordkeeper of the Trust; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

Upon termination of the Trust, the trustee shall distribute all remaining assets, after payment of any expense properly chargeable against the Trust, to participants based on the value of their account balances on the termination date.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Trust's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Note 2 - Summary of Significant Accounting Policies (Continued)

Contributions Receivable and Contributions from Employers

Contributions receivable of the Trust include amounts to be collected from employers for hours worked on or prior to April 30 of each year and amounts collected into the IW Local 25 Service Corporation (Service Corporation) collection account but not transferred to the Trust prior to April 30. The amount due from the Service Corporation for contributions collected on behalf of the Trust was \$2,296,619 and \$2,130,879 as of April 30, 2025 and 2024, respectively.

Contributions from employers are recognized in the plan year in which members provide services except where collection is doubtful, in which case they are recorded upon receipt of the contribution.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Trust invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 11, 2026, which is the date the financial statements were available to be issued.

Note 3 - Tax Status

The Trust has received a determination letter from the Internal Revenue Service indicating that the Trust, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Trust has been amended since receiving the determination letter, management believes that the Trust is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Note 4 - Trust Administration and Operating Expenses

Iron Workers Local 25 Pension Trust, Iron Workers Local 25 Health Care Trust, Iron Workers Local 25 Vacation Pay Trust, Iron Workers Local 25 Training Trust, and the Trust collectively represent the "Iron Workers Fringe Benefit Funds." The expenses incurred in connection with the administration of these funds are recorded as operating expenses. A portion of the expenses is paid initially by the Service Corporation. The Service Corporation is reimbursed by the remaining Iron Workers Fringe Benefit Funds for their share in such expenses.

Note 4 - Trust Administration and Operating Expenses (Continued)

Included in the above-mentioned operating expenses are office expenses for administrative costs of the Trust in the amount of approximately \$0 and \$700 for the years ended April 30, 2025 and 2024, respectively. The amount of operating expenses, primarily legal and payroll audit costs, incurred by the Service Corporation on behalf of the Trust and reimbursed to the Service Corporation was approximately \$93,000 and \$0 for the years ended April 30, 2025 and 2024, respectively.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Trust has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Trust’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 6 - Unallocated Contract

The Trust has a benefit-responsive unallocated contract with Massachusetts Mutual Life Insurance Company (MassMutual). MassMutual maintains the contributions in a general account separate from MassMutual general investments. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Trust.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting but may not be less than 2 percent. When establishing interest crediting rates for this product, MassMutual considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer’s general account.

Generally, there are no events that could limit the ability of the Trust to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.
