## **INDEPENDENT AUDITORS' REPORT**

To the Trustees of  
First Alarm Employee Stock Ownership Plan and Trust  
Aptos, California

### **Opinion**

We have audited the financial statements of First Alarm Employee Stock Ownership Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis of Opinion**

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule, Schedule H, Line 4i - "Schedule of Assets (Held at End of Year)" at December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the First Alarm Employee Stock Ownership Plan and Trust (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

**General:** First Alarm (the Company) established the Plan effective January 1, 2009. The Plan is an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** Employees of the Company are generally eligible to participate in the Plan if over the age of 21 and have completed one year of service with 1,000 hours and are not covered under a union collective bargaining agreement. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of the Company contributions for such year.

**Employer Contributions:** Each year, the Company determines the amount to be contributed to the Plan. This contribution is discretionary. The Company contributions can be paid in cash or shares of Company stock. Participants are not allowed to make contributions to the Plan and rollovers to the Plan are not accepted.

**Participant Accounts:** The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with forfeitures of terminated participants' nonvested accounts and Company contributions, if any. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

**Vesting:** Vesting is based on years of continuous service in the Plan. A participant is vested after years of credited service per the following schedule:

**Vesting (Continued):** Also, a participant will be credited with one year of service for every seven years of service credited prior to the effective date of the Plan, January 1, 2009. The value of a participant's account shall become fully vested when the participant attains his or her normal retirement age while an employee, or upon his or her severance from the employment by reason of death.

**Payments of Benefits:** Distribution of benefits shall be limited to a participant's vested account. Upon death, disability, or attaining normal retirement age, a participant or beneficiary may elect to receive the value of his or her account as a lump sum amount payable to the participant or his or her beneficiary no later than one year after the end of the plan year in which the participant dies, becomes disabled, or attains normal retirement age. If a participant's entire vested account exceeds \$5,000 and distribution is due to other than the participant reaching normal retirement age, disability or death, the distribution of such account shall commence during, but before the end of, the sixth plan year following the plan year in which the participant has a severance from employment. If a participant's entire vested account does not exceed \$5,000, the distribution of such account shall be made as soon as administratively feasible after the end of the plan year in which the participant has severance from employment. The amount to be distributed is based upon the account valuation date immediately preceding the distribution. Distributions are made in cash or, if a participant elects, in the form of stock plus cash for any fractional share of common stock.

**Put Option:** Under Federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Company can pay for the purchase over a period of five years with interest. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash. During the calendar years 2024 and 2023, the Company did not re-purchase any shares from participants.

**Voting Rights:** Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

**Diversification:** Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in First Alarm's common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution.

**Administrative Expenses:** The Plan is responsible for payment of administrative expenses. The Company may also pay the plan expenses directly. Administrative expenses charged to the Plan include charges associated with benefit payment processing, recordkeeping and the annual audit fee.

**Forfeitures:** The non-vested portion of a terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures are allocated to each remaining participant's account based upon the relation of the participant's compensation to total compensation of all such participants for the plan year. Stock forfeitures allocated to remaining participants at December 31, 2024 and 2023, totaled 1,831 and 4,089 shares, respectively. No cash forfeitures were allocated to remaining participants at December 31, 2024 and 2023.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures at the date of the financial statements and reported amounts during the reporting period. Actual results could differ from the estimated amounts.

**Risks and Uncertainties:** The plan investments consist primarily of Company common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Dividend income is accrued on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments consists of net realized gains or losses and the net unrealized gains or losses in the fair value of investments bought and sold as well as held during the year.

**Subsequent Events:** The Plan's management has evaluated subsequent events through January 27, 2026, the date of issuance of the financial statements. Management is not aware of any subsequent events that would require recognition or disclosure in the financial statements.

### NOTE 4. FAIR VALUE MEASUREMENTS

The fair value measurement topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1. Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2. Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There was no change in methodologies for the years ended December 31, 2024 and 2023.

The fair value of First Alarm common stock held by the Plan is valued at fair value as determined by an independent appraiser using the asset valuation approach. The asset approach utilized the discounted cash flows related to the existing Recurring Monthly Revenue (RMR) and then determined if the RMR could be sold for a higher price or if there is a market limitation. To value revenues produced by RMR's, a Steady State Model was applied to determine the discounted cash flows derived from each type of RMR. Additional valuation considerations were given and applied for discounts relating to lack of control and marketability. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The valuation process involves plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the 2024 financial statements of the Company. The appraiser prepares a preliminary report which plan management, along with the ESOP administrator, reviews in detail, discusses, and approves.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 5. RELATED PARTY AND PARTIES IN INTEREST TRANSACTIONS**

Certain officers and employees of the Company (who may also be participants in the Plan) perform administrative services related to the operation and financial reporting of the Plan. The Company pays these individuals salaries and also pays other administrative expenses on behalf of the Plan. These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory and administrative exemptions from the IRC and ERISA's rules on prohibited transactions.

The Plan invests in First Alarm common stock which is a related party and party-in-interest transactions.

In addition, the Plan has a number of service providers. Such providers are parties in interest under ERISA. Fees paid during the year for administrative services rendered by parties in interest were based on customary and reasonable rates for such services and are paid by the Company.

### **NOTE 6. FEDERAL INCOME TAX STATUS**

The Plan has received a determination letter from the Internal Revenue Service dated July 25, 2017, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The plan management has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

### **NOTE 7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the plan terms and the IRC. Upon termination of the Plan, Company's management should direct the Trustee to pay all liabilities and expenses of the trust fund.

### **NOTE 8. ADMINISTRATION OF PLAN ASSETS**

The Plan's assets, which consist principally of First Alarm's common shares, are held by the Trustee of the Plan.

The Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan.

### **NOTE 9. EMPLOYER CONTRIBUTIONS**

Each year, the Company determines the amount to be contributed to the Plan. This contribution is discretionary. The Company contributions can be paid in cash or shares of Company stock. The Company made cash contributions of \$305,230 and \$218,760 for the years ended December 31, 2024 and 2023, respectively.
