Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Process Equipment & Service Company, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 1) Description of Plan

The following description of the Process Equipment & Service Company, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, adopted July 1, 1999, is a defined contribution plan covering all employees of Process Equipment and Service Company, Inc. (the "Company") who have one year of service and are age nineteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as Plan administrator.

Contributions

Each year, participants may contribute up to limits set by the Internal Revenue Code and Regulations. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The company has elected to be treated as a Safe Harbor Plan and has committed to making a contribution equal to 3% of eligible employee compensation. The company may also make additional discretionary contributions as approved by its board of directors, up to limits prescribed by the IRS; these contributions are allocated only to participants employed on the last day of the Plan year. Contributions are invested as directed by the participant. Contributions are made as soon as administratively feasible.

Participant Accounts

Each participant account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) Plan earnings and charged amounts of an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1) Description of Plan — continued

Vesting

Participants are immediately vested in their contributions plus allocated earnings thereon. Participants are also immediately vested in safe-harbor employer contributions as well as rollover contributions. Vesting in the Company's discretionary contributions plus actual earnings and changes in value thereon is based on years of service. Employees are subject to vesting provisions in the schedule below and will be vested in increments of 20% per year until fully vested after six years of employment.

Participant Loans

Participants are currently not permitted to borrow from their accounts based on the Plan agreement.

Administrative Expenses

Administrative expenses incurred by the Plan are routinely paid by the Company.

Distributions

On termination of service due to death, disability, or retirement, a participant may elect to receive their vested account balance as a lump-sum payment, or as payments over a certain period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Vested amounts in excess of \$5,000 may be left in the Plan.

Forfeited Accounts

For the years ended June 30, 2025 and 2024, forfeited non-vested accounts totaled \$402 and \$7,172, respectively. For the years ended June 30, 2025 and 2024, \$9,102 and \$0 of forfeitures were used to reduce contributions or pay Plan expenses, respectively.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Valuation of Investments

In compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan values its investments at fair value, except for fully benefit-responsive fixed annuity contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. In accordance with valuing investments at fair value, the net unrealized appreciation or depreciation is presented in the statements of changes in net assets available for benefits.

Payment of Benefits

Benefit payments are recorded when paid.

Date of Management's Review

Subsequent events were evaluated through February 11, 2026 which is the date the financial statements were available to be issued.

5) Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires that Plan management evaluate tax positions taken by the Plan and recognize tax assets (liabilities) for uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The Plan has no uncertain tax positions taken or expected to be taken for the years ended June 30, 2025 or 2024. The Plan Administrator believes the Plan is no longer subject to potential income tax examinations for years prior to June 30, 2022.

The Plan recognizes interest accrual related to unrecognized tax benefits in interest expense and penalties as operating expenses, when applicable. No provision for the effects of uncertain tax positions has been recorded for the years ended June 30, 2025 and 2024.

For the years ended June 30, 2025 and 2024, there were no liabilities related to unrecognized tax benefits.

6) Fair Value Measurement

The Plan's investments, except for fully benefit-responsive fixed annuity contracts, which are reported at contract value, are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6) Fair Value Measurement — continued

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Fair Value Measurements – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds – Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

Collective trust funds – Valued using the market approach NAV based on fair value of underlying investments.

Certain Plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America. Empower Trust Company, LLC is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

8) Fixed Annuity Contracts

The Plan offers a fully benefit-responsive fixed annuity contract through a rider to Empower Annuity Insurance Company of America (“EAICA”) annuity contract. This contract meets the fully benefit-responsive fixed annuity contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under their terms of the Plan. Contract value equals the accumulated cash contributions, interest credited to the Plan’s contracts, and transfers, if any, less any withdrawals and transfers, if any.

The fully benefit-responsive fixed annuity contract held by the Plan is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2025 is 1.45% and for 2024 is 1.33%. The actual average yield earned by the Plan for the benefit responsive fund can be derived by averaging the Plan’s quarterly interest rates. That average for 2025 is 1.45% and for 2024 is 1.33%.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive fixed annuity contracts is dependent upon the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value. Examples of such events include the following:

- The Plan’s failure to qualify under Section 401(a) of the Code;
- Plan termination;
- Premature termination of the contracts;
- Bankruptcy of the Plan Sponsor or other Plan Sponsor events that significantly affect the Plan’s normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. There are no known events that permit the issuer to terminate the contracts with the Plan and settle at an amount different from contract value.

9) **Plan Termination**

Although it has not expressed an intent to do so, the Company and the Plan Administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

10) **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
