Report of Independent Auditors

To the Participants and Trustees of
Drywall Education and Scholarship Fund

Opinion

We have audited the financial statements of Drywall Education and Scholarship Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Drywall Education and Scholarship Fund as of April 30, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence that we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Responsibilities of Management for the Financial Statements (continued)

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Notes to Financial Statements

April 30, 2025 and 2024

Note 1. Description of the Plan

Drywall Education and Scholarship Fund (the Plan) was established as a result of a collective bargaining agreement between the district council and the contractors' association. The purposes of the Plan are to advance higher learning, to advance the drywall industry and the trade through the education of participants and their eligible dependents, and to provide opportunities for qualified and needy eligible participants and dependents to obtain further education in the trade or a post-secondary degree. The Plan is primarily funded by employer contributions as specified in the collective bargaining agreement. The Plan is a multiemployer welfare (scholarship) plan subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In order to be eligible for a scholarship, an applicant must be an immediate family member of an active or currently retired participant. The participant must have a current working card with the district council, work for a contributing contractor, and have three and one-half pension credits in the last five years. The applicant must be a full-time student at an accredited four-year college or university. The applicant must have a high school diploma or equivalent, be in the top 50% of their high school class, submit SAT or ACT scores for evaluation and display financial need. Under current provisions, the Plan offers a \$5,000 scholarship award, paid in two installments, at the beginning of each school semester. No scholarship awards were approved but not yet paid at either April 30, 2025 or 2024.

Applications are reviewed based on the above criteria. The awards are made by a selection committee which is comprised of the Board of Trustees.

Participants should refer to the plan document for more complete information.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting.

Plan Administration - The Plan transitioned from a third-party administrator to self-administration effective in January 2024, although the accounting function remained with the third-party administrator. Costs related to self-administration include occupancy, salaries, employee benefits and other expenses.

Note 2. Summary of Significant Accounting Policies (continued)

Contributions Receivable - Employer contributions due and not paid at year end are recorded as contributions receivable. Employer contributions owed as result of payroll compliance audits are recorded as income upon settlement with the employer. An allowance for doubtful accounts is considered unnecessary and is not provided.

Employer Contributions - Employer contributions are recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rate currently in effect, as set forth in the collective bargaining agreements. Employers are required to remit contributions monthly. Covered employment is primarily derived in the taping industry within a jurisdiction primarily located in Chicago and surrounding areas in Illinois.

Scholarships - The Plan recognizes scholarships upon distribution. Scholarships are disbursed in two parts. One-half of the scholarship is disbursed for the fall semester. Before the spring semester begins, the scholarship recipient must submit their fall grades noting they maintained at least a 2.0 grade point average before the spring scholarship is disbursed.

Leases - The Plan utilizes shared office space as described in Note 6. The Plan reimburses a related organization for its share of lease expense. Due to the immaterial nature of the amounts owed pursuant to the leasing arrangement, as well as the Plan not being signatory to the lease agreement, the Plan did not adopt the provisions of accounting guidance for leases required by generally accepted accounting principles.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through February 9, 2026, which is the date the financial statements were available to be issued.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the participants. Whether or not a particular participant will receive full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at the time and the priority of those benefits.

Note 4. Tax Status

The Plan received a notice of exemption on May 31, 1995, in which the Internal Revenue Service (IRS) stated that the trust established under the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Funding Policy

The Plan is primarily funded by employer contributions. Participating employers contribute such amounts as specified in their collective bargaining agreements. The hourly contribution rate was \$0.08 through May 31, 2024, and \$0.10 thereafter.

Note 6. Related Organizations

The Plan has ten related entities, which include Chicago Painters and Decorators Pension Fund; Chicago Painters and Decorators Welfare Fund; Chicago Painters and Decorators Retiree Welfare Fund; Chicago Painters and Deferred Savings Plan Fund; Painters District Council No. 14 Scholarship Fund; Chicago Painters and Retirement Savings Plan; Chicago Painters and Tapers Cooperation and Education Trust Fund; District Council No. 14 Metal Polishers 401(k) Retirement Plan; Chicago Area Painting Joint Apprentices Training Trust; and International Brotherhood of Painters and Allied Trades District Council No. 14.

The related retiree welfare plan collects employer contributions on behalf of the Plan and subsequently transfers the contributions to the Plan. Amounts due to the Plan for these contributions totaled \$8 and \$577 at April 30, 2025 and 2024, respectively, and are included in cash as deposits-in-transit.

Prior to January 1, 2024, the Plan incurred joint expenses with other related organizations. Certain common operating expenses were paid by the Plan on behalf of these organizations or paid by these organizations on behalf of the Plan. Common operating expenses allocated to the Plan for the year ended April 30, 2024 totaled approximately \$1,007. Amounts due to related organizations at April 30, 2024 totaled \$1,007.

Note 6. Related Organizations (continued)

Effective January 1, 2024, the Plan began sharing facilities, equipment and staff with other related organizations. These operating expenses are allocated to the respective organizations. Common operating expenses allocated to the Plan for the year ended April 30, 2025 totaled \$10,083. The monthly common expenditures allocated to the Plan include a portion of rent paid for shared office space. Amounts due to related organizations at April 30, 2025 totaled \$6,864.

The Plan's shared employees are covered by a multiemployer defined benefit pension plan, a multiemployer defined contribution retirement plan and a multiemployer welfare plan.

As of April 30, 2025 and 2024, the Plan was owed \$375 and \$150, respectively from a related entity for shared legal expenses.

Note 7. Major Employer

Contributions from one employer accounted for approximately 10% and 6% of total employer contributions for the years ended April 30, 2025 and 2024 respectively. In the event this employer suspends contributions, the Plan would retain the risk of meeting current fixed administrative expenses until the appropriate adjustments were made.


