Opinion

NOTE A – DESCRIPTION OF PLAN

The following description of the Keystone/Kemlon Health Care Trust (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the plan Sponsor.

General: The Plan is set up under and subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The mission of the Plan is to provide health care benefits for its participants who are comprised of the employees of Kemlon Products and Development Group, Inc. and Keystone Engineering Group, Inc., (the Sponsor), who have completed three months of continuous service and have elected to enroll in one of the health care plans offered by the Plan.

Benefits: The Plan offers participant-only medical insurance that is subsidized by the Sponsor. For participants with dependent coverage needs or wishing a lower deductible medical plan, additional medical insurance options are available but at a higher cost to the participants. The Plan combines these additional medical insurance options with the Plan's short-term disability plan which provides a supplemental income benefit equal to 60% of a participant's weekly earnings up to a maximum of \$500 for a period not to exceed 26 weeks. The premiums for the short-term disability plan are paid by the eligible participants.

Other benefits made available by the Plan include life insurance and dental insurance. All participants receive life insurance (\$10,000 benefit) at the Sponsor's cost. Each participant may also elect additional life insurance (\$100,000 or \$150,000 benefit) at his or her own cost. The Plan also provides continuation of certain benefits to participants upon termination of employment with the Sponsor through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Self-insured Benefits: Disability claims are processed and paid directly by the Plan, and the Plan intends to continue on a self-insured basis.

Contributions: In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of dental, disability, and voluntary life coverage as well as the cost of any medical coverage premium in excess of the Sponsor's portion. Participant contributions are made via payroll deductions. The Sponsor covers costs of the Plan in excess of the participants' contributions. The Sponsor contributes a discretionary amount to the Plan. The Plan pays premiums to Cigna Health and Life Insurance Company for health and dental coverage. Premiums are paid to United of Omaha Life Insurance Company for life coverage. Participant contributions are based on the cost of coverage elected less amounts contributed by the employer.

Administrative Expenses: The Plan incurs and pays various administrative costs including accounting fees and other costs associated with auditing and filing the Plan's required regulatory reports. The Trustee receives no compensation for his services.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates: The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Premiums paid by either the Sponsor or the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Short-term disability payments are paid by the Plan and are recorded as claims paid in the financial statements.

Investment Valuation and Income Recognition : Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Receivables and Allowance for credit losses: Management has evaluated current market conditions, historical experience and has considered forward-looking internal and external information and economic forecasts. From this analysis, as of April 30, 2025 the allowance for estimated uncollectible amounts on contributions receivable is set at \$0.

Subsequent Events : Management has evaluated subsequent events for the Plan through February 12, 2026, the date the financial statements were available to be issued and is not aware of any material events that would impact the normal operations of the Plan.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE C – FAIR VALUE MEASUREMENTS (continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Common stock: Valued at the closing price reported in the active market in which the individual security is traded.

Mutual funds: Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at April 30 (year-end).

NOTE D – TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and, accordingly, the trust's net investment income is exempt from income taxes. The Sponsor has obtained a favorable tax determination letter from the IRS dated November 24, 1981. The Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The trust has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E – TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants.

NOTE F – CONCENTRATIONS OF RISK

The Plan maintains cash balances in the form of checking accounts with a single federally insured banking institution. From time to time, the Plan's accumulated cash balances at this institution may exceed the Federal Deposit Insurance Corporation's (FDIC) insured limits. As of April 30, 2025 the Plan's total cash balances at this institution were \$1,647,843 in excess of the FDIC limit of \$250,000. The Plan's trustee actively monitors the financial condition of the Plan's banking institutions, and to date, the Plan has not experienced any losses in these accounts.

NOTE G – TRANSACTIONS WITH PARTIES IN INTEREST

Kemlon Products & Development Co. provides to the Plan certain accounting and administrative services for which no fees are charged.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
