INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
United Association of Plumbers and Pipefitters
Local 693 Annuity Plan

Opinion

We have audited the financial statements of the United Association of Plumbers and Pipefitters Local 693 Annuity (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of April 30, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Report on Supplemental Information

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedules of Administrative Expenses and the Schedule of Assets Held at End of Year, referred to as “supplemental information,” are presented for the purpose of additional analysis and are not a required part of the financial statements. The Schedule of Assets Held at End of Year is supplemental information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Supplemental information is the responsibility of the Plan’s management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

APRIL 30, 2025 AND 2024

NOTE 1. DESCRIPTION OF PLAN

The following description of the United Association of Plumbers and Pipefitters Local 693 (the Union) Annuity Plan (the Plan) is provided for general information only. Participants should refer to the Plan document for more complete information.

General - The Plan is a defined contribution retirement plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established on May 1, 1989.

The Plan covers employees working under the terms of the collective bargaining agreement between the Union and the employers, which participate in the Plan. Union officials and employees of the Union may also be eligible if contributions are made to the Plan by the Union on their behalf pursuant to a participation agreement.

Covered employment means employment with a signatory contractor pursuant to the collective bargaining agreement or employment with any employer (including the Union) who has agreed to contribute to the Annuity Plan based on a participation agreement.

Employers' Contributions - Contributions to the Plan are made by contributing employers at rates established by collective bargaining agreements. Effective May 1, 2021 the hourly contribution rate was \$1.00. Contributing employers primarily conduct business in the Vermont. Employer contributions are accounted for as exchange transactions.

Rollover Contributions - With consent of the Trustees, amounts may be transferred to this Plan from other tax qualified plans by participants. The amounts transferred must be set up in a separate account referred to as a Participant's Transfer/Rollover Account. Rollovers for the years ended April 30, 2025 and 2024 totaled \$158,777 and \$-0-, respectively.

Participant Accounts - An employee becomes a participant in the Plan on the day the participant works at least one hour in covered employment. Covered employment means employment with a contributing employer in a category of work covered by a collective bargaining or participation agreement requiring contributions to the Plan. Participants may direct the investment of employer contributions made on their behalf to any investment option offered under the Plan. If the participant has not specified the allocation into a specific investment type, the contributions will be invested in the guaranteed income fund. Each participant's account is credited with employer contributions and adjusted by investment results and expenses. Administrative expenses are allocated to the participant's account. Net earnings or losses are allocated on a daily basis based upon the investment results of the investment options in a participant's account.

NOTE 1. DESCRIPTION OF PLAN (continued)

Vesting - Participants are 100% vested in the value of the employer contributions made on their behalf plus the allocation of net earnings or losses and administrative expenses.

Temporary Workers - Union members temporarily in the area and working under the jurisdiction of the Union may request a lump-sum payment equal to the value of their account after having withdrawn their travel card from the Union for a period of six months, providing they are vested as defined above.

Payments of Benefits - Upon termination of service and a one-year break in service, a participant may (a) continue his or her account in the fund (provided the balance is at least \$5,000), (b) elect to receive a deferred annuity benefit, or (c) elect to receive a lump-sum payment amount equal to the value of their account.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value as determined by quoted market prices. See Note 10 for discussion of investment contract with insurance company and Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Payments of Benefits - Benefits are recorded when paid.

NOTE 3. PLAN TERMINATION

The Trustees expect and intend to continue the Plan indefinitely but reserve the right to amend or terminate it. Upon termination of the Plan or complete discontinuance of contributions, each participant or beneficiary will have nonforfeitable rights to their account, after providing for all of the expenses of the Plan at termination.

NOTE 4. TAX STATUS

The Plan is qualified under Section 401(a) of the Internal Revenue Code and the related trust is exempt from federal income tax under Section 501(a).

NOTE 4. TAX STATUS (continued)

The Plan obtained its latest determination letter on September 9, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5. RELATED PARTIES

Employees of Plumbers and Pipefitters Local 693 perform certain administrative functions of the Plan. The Plan reimburses Plumbers and Pipefitters Local 693 at rates approved by the Board of Trustees of the Plan for direct expenses incurred. During the years ended April 30, 2025 and 2024, the Plan reimbursed direct expenses for salary and benefits in the amount of \$15,032 and \$14,801, respectively.

The Plan also reimburses the Plumbers and Pipefitters Local 693 for various office expenses. During the years ended April 30, 2025 and 2024, the Plan reimbursed office expenses in the amount of \$1,057 and \$535, respectively.

The Plan leases office space on a month-to-month basis from the United Realty Corporation, a Vermont corporation, of which the Union is a sixty-five percent owner. Rent paid for 2025 and 2024 was \$1,595 and \$1,048, respectively.

NOTE 6. PARTY IN INTEREST TRANSACTIONS

The Plan paid certain expenses related to Plan operations and investment activities to various service providers. These transactions are party in interest transactions under ERISA.

NOTE 7. CONTRACT ADMINISTRATION

The Plan has a contract with the IBEW Local 300 Health and Welfare Fund to assist in administering the Plan. The contract provides for a monthly reimbursement to IBEW Local 300 Health and Welfare Fund for employee wages based on a percentage derived from conducted time studies. For the years ending April 30, 2025 and 2024, the Plan paid administration fees in the amount of \$9,972 and \$9,803, respectively.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

For the years ended April 30, 2025 and 2024, there were no transfers in or out of levels 1, 2 or 3.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at April 30, 2025 and 2024.

NOTE 9. FAIR VALUE MEASUREMENTS (continued)

Common Collective Trust: Valued based on the beginning of year value of the Plan's interest in the trust plus actual contributions an allocated investment income (loss) less actual distribution and allocated administrative expenses. Quoted market prices are used to value investments in the trust. The fair value of certain other investments for which quoted market prices are not available are valued based on yields currently available on comparable securities of issuers with similar credit ratings.

Registered Investment Companies (RIC): The registered investment companies' investments are valued at the net assets value of shares held by the Plan at year end and are classified within Level 1 of the valuation hierarchy.

NOTE 10. INVESTMENT CONTRACTS

The Plan has entered into a fully benefit-responsive guaranteed investment contract. The account is credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan.

NOTE 10. INVESTMENT CONTRACTS (continued)

Because the guaranteed investment income contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for plan benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Subsequent events have been evaluated through January 30, 2026, which is the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
