Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

Campus Living Villages 401(k) Plan (the Plan) is a qualified retirement plan adopted by Century Campus Housing Management, L.P. dba Campus Living Villages (the Company) to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was originally effective on September 15, 1990, and was most recently amended and restated effective January 1, 2021. The Plan was recently amended effective January 1, 2022, to implement provisions of the SECURE Act and other legislation. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the legal plan document for a more complete description of the plan's provisions.

Plan Administration: The Plan is administered by the Company's Plan Administrator, who is responsible for the overall operation and administration of the Plan, including interpretation of plan provisions and ensuring compliance with ERISA and the Internal Revenue Code. The Plan Administrator has delegated certain recordkeeping activities to Charles Schwab Trust Bank and other service providers.

Plan Amendments: Effective January 1, 2022, the Plan was amended to implement provisions of the SECURE Act and other legislation. The amendment allows qualified birth or adoption distributions of up to \$5,000 per child, raises the required minimum distribution age to 72, and provides for eligibility of certain long-term part-time employees beginning with the 2024 plan year.

Eligibility: All employees of the Company, except for leased employees and part-time, temporary, or seasonal employees, who have completed one month of service and have attained age 21 are eligible to participate in the Plan. The entry date will be the first day of the month coinciding with or following the date the employee satisfies the eligibility requirements.

Contributions: Participants may elect to reduce their compensation by a specific percentage and have that amount contributed to the Plan on a pre-tax basis as a salary deferral. Compensation for plan purposes excludes room and board. Total deferrals in any taxable year may not exceed the dollar amount which is set by law. Participants who are at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts called catch-up contributions to the Plan. Participants may revoke or make modifications to their salary deferral elections at any time during the plan year.

The Plan includes an automatic deferral feature that constitutes an Eligible Automatic Contribution Arrangement (EACA) under IRS regulations. This feature applies to employees who become participants on or after the EACA effective date (and does not apply to individuals who were participants immediately prior to that date). The Company will automatically withhold 3% of a participant's compensation unless the participant elects a different deferral amount or elects not to defer under the Plan. The automatic deferral percentage increases by 1% each year until the amount withheld reaches 6% of the participant's compensation.

The Company may make a discretionary matching contribution equal to a uniform percentage of participant's salary deferrals. During 2024, the Company matched 100% of a participant's contributions of up to 3% of the participant's compensation.

The Company may also make a discretionary profit-sharing contribution to the Plan, to be determined each year. For 2024, the Company did not make a discretionary profit-sharing contribution to the Plan.

Participants are permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs, called a rollover contribution.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability. Participants may retire early upon attaining age 55 and completion of five years of service.

Vesting: Participants are always 100% vested in all of their plan accounts plus actual plan earnings thereon.

Payment of Benefits: Participants may receive a distribution of the vested portion of some or all of their account upon termination of employment, normal retirement, disability, or death. If a participant's vested account balance does not exceed \$5,000, then their vested account balance may only be distributed in a single lump-sum payment. If a participant's vested account balance exceeds \$5,000, the participant must consent to any distribution before it is made. The participant can elect to receive the distribution in a single lump-sum payment or partial withdrawals.

Participants may receive a distribution from the Plan from certain accounts prior to termination of employment if they have attained age 59½. Hardship distributions are also available to participants of certain conditions representing an immediate and heavy financial need.

Notes Receivable from Participants: Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000 reduced by the highest outstanding balance of loans from the Plan during the prior 12-month period. Each loan is adequately secured by the balance in the participant's account and shall bear a reasonable rate of interest. Principal and interest payments are paid at least quarterly over a term not to exceed five years unless, the loan was obtained to acquire their principal residence. Participants are limited to one outstanding loan at a time.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings and losses thereon.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through January 20, 2026, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted process in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing as asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

Mutual Funds: The fair values of mutual fund investments are measured using the market approach based on unadjusted quoted prices in active markets for identical investments that the Plan has the ability to access at the measurement date. Mutual funds are classified as Level 1 in the fair value hierarchy.

There were no transfers between Levels 1, 2, or 3 during 2024 or 2023. The Plan’s policy is to recognize transfers between levels of the fair value hierarchy, if any, at the end of the reporting period. There were no changes in valuation techniques used to measure fair value during the years presented.

NOTE 5 – GUARANTEED INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive guaranteed investment contract with Prudential Retirement Insurance and Annuity Company (“Prudential”). Prudential maintains the related contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Prudential is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The crediting interest rate is determined under a formula established by Prudential and is reset semi-annually; the rate may not be less than 1.5 percent.

This contract meets the definition of a fully benefit-responsive investment contract and is therefore reported at contract value, which represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Certain events in the contract could limit the Plan’s ability to transact at contract value. Such events include, but are not limited to, (1) the Plan’s termination or merger with another plan, (2) significant withdrawals exceeding 25 percent of the Plan’s contract value in a plan year or 10 percent of the overall pooled fund, (3) transfers to competing investment options that do not satisfy the required 90-day “equity-wash” waiting period, or (4) events such as market disruptions, exchange closures, or regulatory actions that prevent normal trading activity. Prudential may defer or limit withdrawals or transfers under these circumstances for up to six months, as permitted by the contract. Management believes that the occurrence of such events that would limit the Plan’s ability to transact at contract value is not probable.

Prudential may terminate the contract if the Plan sponsor fails to pay required expenses, materially breaches contract provisions, or makes a material misrepresentation, or if Prudential determines that the class of business is no longer commercially desirable (subject to required notice). Upon termination or certain large-scale withdrawals, amounts due to the Plan are generally paid at contract value either immediately or in installments over time in accordance with contract terms.

The Plan’s ability to receive amounts due is dependent on Prudential’s ability to meet its financial obligations, which may be affected by future economic or regulatory developments.

NOTE 6 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Charles Schwab Trust Bank is a service provider to the Plan and, therefore, these transactions and the Plan’s payment of fees qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 – TAX STATUS

The Company adopted a pre-approved defined contribution plan document effective January 1, 2021. The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

NOTE 7 – TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021
