Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bayway Lincoln Mercury, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Bayway Lincoln Mercury, Inc. 401(K) Plan (the Plan) was adopted effective January 1, 1999 to establish a savings and investment plan for the exclusive benefit of the employees of Bayway Lincoln Mercury, Inc. (the Company and Plan Administrator), its affiliated companies, and their beneficiaries. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 1, 2024, the Plan was amended and restated to designate ADP Retirement Trust Services, LLC as the trustee of the Plan. During December 2024, the Plan's assets transferred from John Hancock Life Insurance Company (USA) (the asset custodian of the Plan) to ADP Retirement Trust Services, LLC (the trustee of the Plan).

Basis of Presentation - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States (GAAP). Interest income is recognized when earned.

Estimates - The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for several investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Valuation of Investments - Investments are reported at fair and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating certain investments at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits and the changes in the net investment gain or loss are reflected in the statement of changes in net assets available for plan benefits.

Fully benefit-responsive investments are stated at contract value, which is equal to the principal balance plus accrued interest.

Benefit-Responsive Fund - The John Hancock Stable Value Fund invests primarily in asset-backed contracts that are fully benefit-responsive. These asset-backed contracts have two components: (1) a portfolio of securities or underlying assets and (2) a wrap contract. Pursuant to the contract, the issuer of the contract (wrap provider) undertakes to repay the principal amount deposited plus accrued interest less expenses to fund participant-directed withdrawals, transfers and loans. The crediting rate of the asset-backed contract is a function of the relationship between the market value, yield and duration of the underlying assets versus the contract value. If the positive adjustment for the portion of net assets attributable to fully benefit-responsive investment contracts from fair value to contract value increases, the crediting rate at the next reset date will be negatively impacted and vice versa. Interest rate change is a key factor that can influence future crediting rates because it impacts the value, yield and duration of the underlying securities.

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES
(CONTINUED)

All of the asset-backed contracts held by the stable value fund are fully participating contracts. In a fully participating contract, the asset and liability risks may be transferred from the wrap provider to the stable value fund in the event of a termination or non-participant directed withdrawal, transfer or loan. The risk of this event happening is not probable. The wrap provider may terminate a fully benefit-responsive contract and settle at an amount different from the contract value if the wrap provider of the stable value fund is unable to meet the terms of the contract.

Participant Loans Receivable - Loans to participants are reported as receivables from participants at the unpaid principal balance plus any accrued unpaid interest.

Federal Income Tax - The Company adopted a non-standardized pre-approved profit sharing plan with CODA (the Non-Standardized Pre-Approved Plan). The prototype Non-Standardized Pre-Approved Plan received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Non-Standardized Pre-Approved Plan constitutes a qualified plan under Section 401(a) of the Internal Revenue Code (Code) and is therefore exempt from federal income taxes.

Effective December 1, 2024, the Plan was formally amended and restated in relation to the transfer of Plan assets to ADP Retirement Trust Services, LLC. The amended and restated prototype Non-Standardized Pre-Approved Plan received a favorable opinion letter from the Internal Revenue Service on October 6, 2020, which stated that the Prototype Plan and related trust constitutes a qualified trust under Section 401(a) of the Internal Revenue Code and is therefore, exempt from federal income taxes.

The Plan has been amended since receiving the favorable opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, the Plan Administrator believes the Plan was qualified and the related trust was tax-exempt as of December 31, 2024 and 2023.

The Plan believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of December 31, 2024, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2021 forward (with limited exceptions). Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the statement of changes in net assets available for plan benefits.

Subsequent Events - The Plan has evaluated subsequent events through February 6, 2026, the date the financial statements were available to be issued. Effective September 1, 2025, the Plan was amended to allow participants to make Roth 401(k) contributions. No other subsequent events occurred, which require adjustment or disclosure to the financial statements at December 31, 2024.

NOTE B PLAN DESCRIPTION

The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Participation - An employee is eligible to become a participant in the Plan upon completion of six months of service and having attained the age of 21. Eligible employees may enter the Plan on the first day of each Plan year quarter coincident with or next following the date the eligibility requirements are met. Employees who are residents of Puerto Rico are not eligible to participate in the Plan.

Contributions - Participants may elect to make pre-tax contributions to the Plan in an annual amount up to 100% of their compensation. Contributions are made through authorized payroll reductions. These contributions by individual employees are limited to \$23,000 in calendar year 2024. This limitation is adjusted periodically to reflect cost-of-living increases. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to (\$7,500 for 2024).

Effective December 1, 2024, the Plan was amended to allow participants to defer only up to 90% of their compensation. The Plan was also amended to include an automatic salary deferral provision, which enrolls new or rehired employees at a contribution rate of 5% of eligible wages upon eligibility. All existing eligible participants, who on the effective date of the automatic salary deferral provision are not deferring any amount or who did not make a timely affirmative election to not contribute elective deferrals, were also enrolled at a contribution rate of 5% of eligible wages.

For each Plan year, the employer may contribute a matching contribution that is equal to a percentage of some or all of the employees' contributions. During 2025, the Plan funded employer matching contributions totaling \$534,757 for the year ended December 31, 2024. During 2024, the Plan funded employer matching contributions totaling \$463,296, net of forfeitures, for the year ended December 31, 2023.

Employer Corrective Contributions Receivable - During 2025, the Plan funded corrective contributions totaling \$73,086, net of forfeitures, to satisfy annual compliance and nondiscrimination testing requirements for the year ended December 31, 2024. During 2024, the Plan funded corrective contributions totaling \$100,953 to satisfy annual compliance and nondiscrimination testing requirements for the year ended December 31, 2023.

Investments - Each participant directs the investment of their account into any of the investment options designated by the Plan Administrator.

Participant Accounts - Each participant's account is credited with the participant's contribution, the Company's contributions and earnings attributable to each participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE B PLAN DESCRIPTION (CONTINUED)

Vesting - A participant is immediately fully vested with respect to the portion of their account attributable to salary reduction, rollover, and qualified non-elective contributions plus actual earnings thereon. A participant becomes fully vested in Company contributions and related earnings upon the earlier of: (1) six years of service, (2) attainment of age 65 (if actively employed by the Company), or (3) in the event of death or disability (if actively employed by the Company). Vesting of 20% of Company contributions occurs upon two years of service, 40% upon three years of service, 60% upon four years of service, 80% upon five years of service, and 100% upon six years of service.

Forfeitures - Forfeited employer matching contributions may be used to reduce administrative expenses or to reduce amounts otherwise required to be contributed by the employer, to the Plan. There were no forfeited non-vested balances as of December 31, 2024. Forfeited non-vested balances totaled \$36,571 as of December 31, 2023. For the year ended December 31, 2024, forfeitures totaling \$8,981 were used to offset employer corrective contributions receivable funded in 2025. During 2024, forfeitures totaling \$35,398 and \$3,367 were used to offset employer matching contributions and employer corrective contributions.

Forms of Benefits - Benefits are recorded when paid. A participant whose employment is terminated may withdraw any portion of their interest in the Plan at any time. If the amount payable is less than \$7,000, the participant's account balance will be directly rolled over as soon as practical after notice to the participant into an individual retirement account maintained by an entity selected by the Company. If the amount payable is greater than \$7,000, the participant must give written consent before the distribution can be made. Distributions in excess of \$7,000 can be paid in a lump sum, partial withdrawals, or installments over a period of no more than their assumed life expectancy. A participant may be eligible for in-service distributions of at least \$500 if the participant has reached the age of 59 ½.

Participant Loans - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer between the investment fund and participant loans receivable. Loan terms range from 1 to 5 years or up to a reasonable period of time exceeding five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Interest rates on loans outstanding at December 31, 2024 ranged from 5.00% to 10.50%. Principal and interest is paid ratably through payroll deductions. Participants are allowed no more than one outstanding loan at a time.

Administration - The Company, as the Plan Sponsor, may, at its discretion, pay the Plan's administrative expenses. Any Plan expenses not paid by the Company will be paid by the Plan. During the year ended December 31, 2024, the Company paid expenses related to the annual audit of the Plan and certain third-party administration fees. All other expenses, including (but not limited to) general administrative fees and investment advisory fees, were paid by the Plan.

Plan Termination - The Company has the right under the Plan to terminate the Plan subject to provisions set forth in ERISA. Upon termination, all participants would become fully vested in their accrued benefits as of the termination date.

NOTE D FAIR VALUE DISCLOSURES

GAAP provides a framework for measuring fair value using a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value based upon whether the inputs to those valuation techniques are observable or unobservable. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical financial instruments and the lowest priority to unobservable inputs. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These inputs are summarized in the three broad levels listed below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Other significant observable inputs (including quoted prices in active or inactive markets for similar financial instruments), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets and liabilities include financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

Following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodology used during fiscal 2024 and 2023.

Registered investment companies are valued at the quoted market prices of shares held by the Plan at year-end.

Certain pooled separate accounts are valued at fair value by the asset custodian of the funds based upon the market value of underlying investments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E PARTIES-IN-INTEREST

During 2024, the Plan invested in various funds managed by John Hancock Life Insurance Company (U.S.A.). These investments are considered party-in-interest transactions because John Hancock Life Insurance Company (U.S.A.) served as the asset custodian of the Plan prior to the transfer of all Plan assets to ADP Retirement Trust Services, LLC (the trustee of the Plan). The Plan Sponsor approved of these investment options.

NOTE F PROHIBITED TRANSACTIONS

During 2024, the Company changed payroll processing platforms and as a result experienced errors in some Plan contributions. Due to inadvertent errors involving the payroll platform change, employee contributions and loan repayments totaling \$39,909 were not timely remitted by the Company to the Plan as required by ERISA for the Plan year ended December 31, 2024. Because the Company was inadvertently delinquent in forwarding these amounts to the Plan, these delinquencies are considered nonexempt prohibited transactions under ERISA Section 406. The Company self-corrected for these delinquent remittances totaling \$39,529 in July 2024 and \$380 in February 2026.
