### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Bakers Union Local No. 37 Health & Welfare Fund (the "Plan") was established in 1949 between contributing employers and the Bakery and Confectionery Workers International Union, AFL-CIO, Local No. 37 for the purpose of providing and maintaining medical, hospital, prescription drug, vision, life insurance and accidental death and dismemberment coverage, for employees, qualified members of their family, and qualified dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

An employee becomes eligible for coverage on the first day of the second month following three (3) consecutive months in which he or she works 70 or more hours. A participant may also be considered eligible after having completed 1,200 hours of service for a participating employer. A participant will remain eligible for benefits each month he or she works 70 or more hours. Employers are required to make a flat contribution to the Plan if the participant meets the hours threshold.

Participants should refer to the Plan agreement and any amendments regarding specific provisions of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements were prepared on the accrual basis of accounting.

**B. Use of Estimates**

The preparation of financials statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Contributions**

Employer contributions as reported are contributions made by employers on behalf of employees for the hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

**D. Employer Payroll Compliance Program**

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' payroll records under a separate payroll compliance program.

**E. Tax-Exempt Status**

The Plan is tax-exempt under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i; therefore, no provision is made for federal or state income taxes.

**E. Tax-Exempt Status (Continued)**

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**F. Investments**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Money Market Fund – valued at cost, which approximates fair value.

U.S. Government Securities – valued at the closing price reported on the active market on which the securities are traded.

**F. Investments (Continued)**

Corporate Bonds – valued based on matrices of trades in similar securities or third party pricing services.

Exchange-Traded Funds – valued at the closing price reported on the active market on which the securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Realized gains and losses on sale of investments for financial statement purposes is the difference between proceeds from the sale or redemption of investments and the carry value (normally historical cost) of the investments sold. Form 5500 requires realized gains and losses to be the difference between proceeds from the sale or redemption of investments and the current (market) value of the investments at the beginning of the year, for those investments on hand at the beginning of the year, or the purchase price of investments acquired during the year.

Form 5500 also requires realized and unrealized gains or losses from investments in exchange-traded funds to be reported separately. The different methods of computing realized gain or loss and the appreciation (depreciation) of investments results in differences in reporting on the financial statements and Form 5500.

**G. Benefits**

Benefits reported on the statements of changes in net assets available for benefits are premiums for eligible participants paid during the year.

Benefit obligations on the statements of benefit obligations are based on estimates at the end of the year of premiums for coverage during the year (Premiums Payable). The statements of changes in benefit obligations reports the components of the changes in benefit obligations.

**NOTE 3 - PRIORITIES UPON TERMINATION**

Except as may be otherwise provided by law, in the event of termination, the Plan provides that any and all monies remaining in the Plan after payment of all expenses and obligations of the Plan shall be expended and used for the continuance of the Plan until such monies are exhausted.

**NOTE 4 - ADMINISTRATION**

The Plan is administered by Madison Consulting Group, LLC for a monthly administration fee of \$10.50 per reported participant, plus reimbursements of direct expenses.

**NOTE 6 - RISKS AND UNCERTAINTIES**

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**NOTE 7 - CONCENTRATION OF CREDIT RISK**

During the year ended April 30, 2025, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through February 12, 2026, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
