Report of Independent Auditors

Opinion

We have audited the accompanying financial statements of the Chicago Foundry Workers' Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of accumulated plan benefits as of April 30, 2025 and 2024 (in liquidation), and the related statement of changes in net assets available for benefits and of changes in accumulated plan benefits for the years then ended (in liquidation), and the related notes to the financial statements.

In our opinion, the financial statements referred to in the first paragraph present fairly, in all material respects, the net assets available for benefits and accumulated plan benefits of the Chicago Foundry Workers' Pension Plan as of April 30, 2025 and 2024 (in liquidation), and the changes in its net assets available for benefits and accumulated plan benefits for the years then ended (in liquidation), in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Chicago Foundry Workers' Pension Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter-Basis of Accounting

As discussed in Note 7 to the financial statements, the governing body of the Chicago Foundry Workers' Pension Plan approved a plan of liquidation on May 1, 2010, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting to the liquidation basis used in presenting the 2025 and 2024 financial statements. Our opinion is not modified with respect to that matter.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.


Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Chicago Foundry Workers' Pension Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Chicago Foundry Workers' Pension Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined benefit pension plan covering the eligible employees of employers in accordance with collective bargaining agreements between the Glass Molders, Pottery, Plastic Workers and Allied International Union AFL-CIO-CLC, and Participating Employers in the Chicago area. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Pension Benefits and Participant Vesting

The pension benefits provided by the Pension Plan are established by the Board of Trustees administering the Plan. This Board of Trustees consists of a union group and an employer group of representatives, each having equal voting power.

The Pension Plan provides for retirement income from both a monthly pension benefit and from a retirement annuity program. Effective July 1, 2003 the accrual of benefits under the Plan was frozen and the contribution rate was changed to \$0.40 per hour plus \$125 per participant per month. No portion of contributions is allocated to the retirement annuity program. Effective December 1, 2005 the contribution rate to the pension plan was \$0.40 per hour plus \$400 per participant per month.

Funding Policy

Employer contributions are not being made due to the termination of the Plan.

Plan Termination

Because the Plan was terminated, the Trustees shall make provisions out of the Trust Fund for payment of any and all obligations of the Trust, including expenses incurred up the date of the termination of the Trust and the expenses incidental to such termination and to distribution, and apply any remaining surplus in such a manner that will best effectuate the purpose of the trust and requirements of the law.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The administrative expenses are approved and funded by the PBGC.

Assessed Withdrawal Liability Receivable

The Plan's policy is to recognize a receivable that approximates collections for the subsequent year. The total assessed withdrawal liability at its present value is \$219,042 and \$235,004 as of April 30, 2025 and 2024, respectively. Due to the uncertainty of collectability, the total present value is not recognized as a receivable.

2. Summary of Significant Accounting Policies

The accounting and reporting policies of the Chicago Foundry Workers' Pension Plan (the Plan) conform to accounting principles generally accepted in the United States of America and to general practices within the employee benefit plan industry. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Basis of Accounting

The accompanying financial statements are prepared on the liquidation basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Assessed Withdrawal Liability

The Plan complies with the provisions of the Multiemployer Pension Plan Amendment Act of 1980 (MPPAA), which requires imposition of a withdrawal liability on a participating employer that partially or totally withdraws from the Plan. Under the provisions of MPPAA, a portion of the Plan's unfunded vested liability would be allocated to a withdrawing employer. A withdrawal liability is usually paid in quarterly installments as determined by a statutory formula over a maximum of 20 years. The Plan entered into various settlement agreements with participating employers who withdrew from the Plan and were subject to withdrawal liability assessments. During 2025 and 2024, the Plan recognized withdrawal liability income of \$12,000 and \$12,000, respectively.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump sum distributions, that are attributable under the Plan's provisions to services employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on the employees' pension credits. Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by consulting actuaries and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuation were:

- Life Expectancy of Participants – Rates published by PBGC for 2025 and 2024 under ERISA Section 4044 for healthy and disabled lives
- Retirement Age Assumptions – Earliest eligible retirement age per ERISA Section 4281.12(b)
- Interest Rate– 5.28%(5.50%-2024) for 20 years following valuation date and 4.83% thereafter.

The foregoing actuarial assumptions are based on the termination of the Plan.

3. Change in Actuarial Assumptions

The actuarial valuation as of April 30, 2025 included the following changes in actuarial assumption:

- Interest rate was changed from 5.50% for 20 years to 5.28% for 20 years.
- Mortality rates were changed from using those published by the PBGC for 2024 under ERISA Section 4044 for healthy and disabled lives to rates published by the PBGC for 2025 under ERISA Section 4044 for healthy and disabled lives.

The actuarial valuation as of April 30, 2024 included the following changes in actuarial assumption:

- Interest rate was changed from 5.38% for 20 years (5.09% thereafter) to 5.50% for 20 years (4.83% thereafter).
- Mortality rates were changed from using those published by the PBGC for 2023 under ERISA Section 4044 for healthy and disabled lives to rates published by the PBGC for 2024 under ERISA Section 4044 for healthy and disabled lives.

4. Plan Termination

Since the Plan has terminated, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, general to provide the following benefits in the order indicated.

- (a) Annuity benefits former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit would be payable under plan provisions in effect at any time during the five years preceding plan termination.

Notes to Financial Statements (continued)

4. Plan Termination (continued)

- (b) Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling on the amount of an individual's monthly benefit that the PBGC guarantees. That ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceiling is actuarially adjusted downward.
- (c) All other vested benefits (that is, vested benefits not insured by the PBGC).
- (d) All nonvested benefits.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits and may also depend on the level of benefits guaranteed by the PBGC. The Plan was not expected to meet expense and benefit payment obligations in the Plan year beginning May 1, 2015.

5. Income Tax Status

The Plan obtained a determination letter dated November 14, 2011, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan currently is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, the Plan qualifies under Section 401(a).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of April 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosures in the financial statements. The plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

5. Income Tax Status (continued)

The Plan has filed its' Form 5500 for the year ended April 30, 2018 under the Delinquent Filer Voluntary Compliance Program (DFVCP). The Form 5500 for the years ended April 30, 2019-2024 were filed timely.

6. Employer Withdrawal Liability

C. W. Shumway & Sons was previously making quarterly payments of \$2,156 with a maximum of 20 years. The final quarterly payment was due as of January 1, 2023; therefore, C.W. Shumway has satisfied its total obligation. Batavia Foundry & Machine Co. is making monthly payments of \$1,000 in perpetuity. Brumund Foundry was previously making monthly payments of \$1,000 in perpetuity. The Plan had previously filed a lien representing a legal claim against the physical property located on the west side of Chicago, Illinois. In 2022, Brumund Foundry ceased operations. In December 2022, Brumund Foundry liquidated the physical property including any equipment of value. As a result, the Plan received proceeds in the amount of \$449,966. The Plan approved the release of its lien and relieved Brumund Foundry of any future periodic payments.

7. Plan Termination

As of May 1, 2010, there has been a plan adopted to terminate the Plan. Pension Benefit Guaranty Corporation has been notified of such termination within the meaning of ERISA 4041 A(a)(2). As a result, the Plan submitted its notice of termination pursuant to 29C.F.F.4041A.11-4041A.12. It was determined that the Plan was not expected to meet expense and benefit payment obligations in the Plan year beginning May 1, 2015.

8. Risks and Uncertainties

The actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

9. Subsequent Events

Subsequent events were evaluated through December 15, 2025, which is the date the financial statements were available to be issued.
