**INDEPENDENT AUDITOR'S REPORT**

To the Committees of Construction Industry  
Health and Welfare Plan  
Lexington, Kentucky 40503

**Opinion**

We have audited the accompanying financial statements of the Construction Industry Health and Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations as of April 30, 2025 and 2024, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Construction Industry Health and Welfare Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Construction Industry Health and Welfare Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.



Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.



The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Notes to Financial Statements

#### **1. Description of Plan**

The following brief description is provided for general informational purposes only. Participants should refer to the applicable summary plan description for more complete information.

##### **General**

The Construction Industry Health & Welfare Plan (the Plan) was established for employees of Subscribing Employers in the construction and construction-related industry. The related plans provide medical, dental, accidental death and dismemberment, disability, and group life insurance benefits for participating employees of Subscribing Employers and are facilitated by UMR (formerly Fiserv Health), Contract Administrator. The Plan had an average of 2,019 and 1,627 participating employees for the year ending April 30, 2025 and 2024 respectively. Subscribing Employers adopt individual welfare plans at the member level and the Plan is filed as a multiemployer plan as is defined in applicable sections of Department of Labor (DOL) Regulations. The individual plans are subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Under the terms of the Plan agreement, employees are allowed to transfer eligibility status and credited service to and from other Subscribing Employers provided that the employees remain in the same eligibility class with the new Subscribing Employer and provided that the appropriate contributions have been made for each period of credited service transferred.

##### **Insured Benefits**

The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), and long-term disability benefits. The Plan purchases annual insurance contracts for these insured benefits. In addition, the plan purchases stop loss insurance to actively manage catastrophic medical claims.

##### **Self-Insured Benefits**

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Ultimate responsibility for payments to providers and participants is retained by the Plan.

## Construction Industry Health & Welfare Plan

### Notes to Financial Statements (continued)

#### **1. Description of Plan (continued)**

##### **Payment of Benefits**

Premiums paid are recorded as premium payments in the accompanying consolidated statement of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Claims paid by the claims processor prior to year end or claim payments submitted to the Plan by the third-party claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of benefit obligations disclosed in the footnotes.

##### **Stop Loss**

Claims that were already paid from the Plan that exceeded the stop-loss coverage and are due to the Plan at year-end are recorded as a receivable. Premiums for stop-loss insurance are included in premium payments in the accompanying consolidated statement of changes in net assets available for benefits. Stop-loss refunds for the years ended April 30, 2025 and 2024 were \$2,209,009 and \$2,668,959, respectively and have been netted against claims paid in the accompanying consolidated statements of changes in net assets available for benefits.

##### **Plan Termination**

If the Plan were to terminate, the Contract Administrator would be required to use available funds to (1) pay or provide for the payment of all insurance premiums, service contract fees and other charges required to be paid pursuant to the insurance and /or service contracts (2) pay or provide for payment of all reasonable and necessary expenses in connection with or arising out of the establishment, installation and administration of the Plan, and (3) apply any balance to such other purposes as shall best effectuate the purposes of the Plan. Currently, there is no intention to terminate the Plan.

##### **Contributions**

The contribution rate is based on the rate per hour/month disclosed in the Subscribing Employer's funding policy section of the respective subscription agreement. Contributions are due from the Subscribing Employers based upon the amount of the participant's hours worked in the month subsequent to when the credited service was earned by the participant. If a participant has established initial eligibility and has not accumulated sufficient hours/dollars to pay for a particular month's premium, the participant can fund any deficiencies by a self-pay or escrow bank deduction (if applicable).

### Notes to Financial Statements (continued)

## **2. Significant Accounting Policies**

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

### **Employer Contributions**

Employer contributions reported in the financial statements include amounts relating to hours worked by participants through April 30 and reported to the Plan through May 31 of the following year, plus related liquidated damages that may be imposed. Allowances are made for uncollectible amounts.

### **Benefit Obligations**

Health costs incurred by participants and their dependents are covered by insurance contracts maintained by the Plan. Amounts due insurance companies at April 30 represented premiums due to the insurance companies earned through April 30. Claims payable represents claims processed but not yet paid as of April 30. Estimated liability-claims incurred but not reported represents claims reported to the plan subsequent to April 30 that have service dates prior to April 30. Accumulated eligibility credits at April 30 consist of (1) May and June benefits earned by individual participant's hours worked in March and April, and (2) the escrow bank balance, which will be applied towards future benefits either (a) for the participant in months when the amount of credited service is not adequate to pay for premiums due for elected coverage or (b) as medical reimbursement for those eligible participants which is defined as those who have more than three months worth of eligibility. The participants are allowed to reduce the balance of the eligibility credits up to an amount not less than three months worth of credit.

### **Use of Estimates**

The preparation of financial statements in accordance with the accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Notes to Financial Statements (continued)

#### **2. Significant Accounting Policies (continued)**

##### **Basis of Accounting**

The plan's financial statements are prepared on the accrual basis of accounting.

##### **Subsequent Events**

Subsequent events were evaluated through February 11, 2026, the date in which the financial statements were available to be issued.

##### **Administrative Expenses**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party administrators, the attorney, investment managers and consultants, and auditor. These expenses are reported on the statement of changes in net assets available as administrative expenses.

##### **Recent Accounting pronouncements**

In June 2016, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) No. 2016-13, Financial Instruments - Credit Losses (Topic 326), which is effective for the Plan for the year ended April 30, 2024. This new standard provides financial statement users with more decision-useful information about the expected credit losses on financial instruments and other commitments to extend credit held by a reporting entity at each reporting date. The standard replaced the incurred loss impairment model with a methodology that reflects expected credit losses and requires consideration of a broader range of reasonable and supportable information to inform credit loss estimates. The standard had no material impact on the Plan's financial statements.

## Construction Industry Health & Welfare Plan

### Notes to Financial Statements (continued)

#### **3. Income Tax Status**

The Trust funding the Plan has received an exemption letter from the Internal Revenue Service dated June 7, 1972, stating that the trust was tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the Code) as a Voluntary Employee Beneficiary Association. The Trust was amended and restated to comply with ERISA effective August 22, 1989. The Contract Administrator believes the Trust continues to be operated in compliance with the applicable requirements of the Code and ERISA.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of April 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosures in the financial statements. The plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

#### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

## Construction Industry Health & Welfare Plan

### Notes to Financial Statements (continued)

#### 4. Fair Value Measurements (continued)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

- Common Stocks: Valued at the closing price reported on the active market on which the individual securities are traded.
- Mutual Funds/Money Market Funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Change Commission. These funds are required to publish their daily net asset value (NAV) and to transact that price. The mutual funds held by the Plan are deemed to be actively traded.
- U.S. Government Securities: Valued using pricing models maximizing the use of observable units for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Mutual funds and money market funds below determine fair value using a calculated net asset per share, or its equivalent. As of April 30, 2025 and 2024, there were no unfunded commitments related to these investment. These investments can be redeemed daily with no redemption notice required.

#### **6. Related Parties**

The Contract Administrator, UMR facilitates the collection of premium remittances to the Plan and remits the insurance premiums to the respective insurance companies or their agents; pays or provides for the payments of the Plan itself, for all reasonable and necessary expenses of establishment, installation and administration of the Plan; conducts all transactions with the insurance companies or the service contractors or their agents relative to the execution and administration of the insurance or service contracts; and establishes the rules for the administration of the affairs of the Plan.

The Contract Administrator is compensated for services by administrative and claims administrative fees and consulting fees based on the number of participating employees of each Subscribing Employer and by other fees charged from time to time for services rendered. Administrative fees paid by the Plan amounted to \$1,071,079 and \$896,499 for the years ended April 30, 2025 and 2024, respectively. Consulting fees paid by the Plan amounted to \$5,725 and \$6,645 for the years ended April 30, 2025 and 2024, respectively.

#### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The value of benefit obligations is reported based on certain assumptions pertaining to estimated costs for future eligibility, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
