NOTES TO FINANCIAL STATEMENTS

April 30, 2025 and 2024

Note 1 Description of Plan

The following description of the Champion Discs, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General - The Plan was established on May 1, 1987. The Plan is a defined contribution plan under the provision of Section 401(k) of the Internal Revenue Code (IRC) and was established to provide retirement benefits for employees of Champion Disc, Inc. (the “Company”). Employees become eligible to participate in the Plan following 1 year of continuous service and are 18 years of age or older, as defined in the plan documents. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees, which is made up of key officers of the Company, is responsible for oversight of the Plan.

Contributions - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document and subject to limitations by the Internal Revenue Code (“IRC”). Participants may also elect to contribute to a Roth subject to limitations by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is a traditional safe harbor plan and the Company makes annual safe harbor contributions in addition to any other employer contributions. Safe harbor employer contributions are 3% of each participant's plan compensation. Additionally, the Company has the option to make discretionary profit-sharing contributions to the Plan. During the years ended April 30, 2025 and 2024, the Company made profit-sharing contributions of \$0 and \$370,216, respectively.

Participant Accounts and Vesting - Each participant’s account is credited with the participant’s contributions and the Company matching contributions (if any), as well as allocations of the Company’s profit-sharing contributions (if any) and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the profit-sharing portion is based on the years of continuous service and a participant becomes 100% vested after 6 years of credited service.

Note 1 **Description of Plan** (continued)

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Interest is charged on loans at a rate ranging from 8.50% - 9.50% (prime rate plus 1% at inception of loan). The loans must be repaid within 5 years (unless used to purchase a principal residence). Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - On termination of service due to death, disability, retirement or other reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts - The non-vested portions of participants' employer-derived account balances are treated as forfeitures. At April 30, 2025 and 2024, forfeited non-vested accounts totaled \$39,251 and \$0, respectively. These accounts can be used to offset plan expenses or may be used to reduce the employer matching contributions, if any. For the year ended April 30, 2025, forfeitures amounting to \$25,530 were used to reduce plan expenses.

Note 2 **Summary of Significant Accounting Policies**

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes there-in, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments, other than fully benefit-responsive contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Fully benefit-responsive investment contracts are reported at contract value, see Note 6.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 **Summary of Significant Accounting Policies** (continued)

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of April 30, 2025 and 2024.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Date of Management's Review - The Plan has evaluated subsequent events through February 5, 2026, the date the financial statements were available to be issued.

Note 3 **Party-in-Interest Transactions**

Certain plan investments are pooled separate accounts consisting of shares of mutual funds managed by Transamerica Financial Life Insurance Company Inc. Transamerica Financial Life Insurance Company Inc. is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions by the United States Department of Labor's ("DOL") Rules and Regulations.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 4 **Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at April 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended April 30, 2025, was obtained, by management and agreed to, or derived from information certified as completed and accurate by Transamerica Financial Life Insurance Company Inc, the custodian of the Plan.

Note 5 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable input (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820 are described as follows:

LEVEL 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

LEVEL 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

LEVEL 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Pooled separate accounts: Valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities.

Note 6 Fully Benefit-Responsive Investment Contracts

The Transamerica Stable Value Advantage account is a group annuity contract that meets the requirements for fully benefit-responsive investment contracts, and as such is shown at contract value. The Transamerica Stable Value Advantage account seeks to provide maximum return consistent with a guarantee of principal. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and there is no set maturity. The effective credited interest rate is set semi-annually and effective on the first day of the semiannual period.

The Transamerica Stable Value Advantage investment is a non-tradable obligation of Transamerica. The investment's contract or proceeds cannot nor will not be assigned or sold to another party without the consent of Transamerica. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Transamerica. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable—for example, a significant decline in creditworthiness of Transamerica, the Stable Value Advantage investment may no longer be considered fully benefit-responsive.

The terms of Transamerica's Group Annuity Contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those allowed by the underlying defined contribution plan such as withdrawals for benefits, loans or transfers to other investment choices within the plan. The Transamerica Stable Value Advantage investment account allows a participant reasonable access to their assets.

Since the Transamerica Stable Value Advantage account is an obligation of Transamerica, the occurrence of an event that limits the ability of the investment to transact at contract value between Transamerica and a participant holding the investment is not probable.

Note 7 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 8 Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has not been amended since receiving determination letter.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
