Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pacific Excavation, Inc. Davis Bacon 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Pacific Excavation, Inc. NOTES TO FINANCIAL STATEMENTS

1. Plan Description

The following description of the Pacific Excavation, Inc. Davis Bacon 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's trustees oversee the governance of the Plan.

General

The Plan is a 401(k) profit-sharing plan, originally effective January 1, 2009, covering employees of Pacific Excavation, Inc. (the Company), excluding union or leased employees, nonresident aliens, and employees with job classification of "manager," "supervisor," or "office worker." Participants who have two consecutive months of service are eligible to participate. The Plan's most recent restatement was January 1, 2022. The Plan is subject to the provisions of ERISA.

Contributions

Participants may contribute pre-tax or after-tax (Roth) elective deferrals from annual compensation up to the limits set by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation without escalation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may make a discretionary matching contribution equal to a uniform percentage of each tier of salary deferrals for eligible participants, as defined above. Each year, the Company will determine the amount of the discretionary percentage. During the years ended December 31, 2024 and 2023, the Company made no discretionary matching contributions. Additionally, each year, the Company may make a discretionary profit-sharing contribution to the Plan. During the years ended December 31, 2024 and 2023, the Company made \$40,000 in discretionary profit-sharing contributions. Employees must be employed on the last day of the Plan year, except in cases of death, permanent disability, or retirement, and must have one of year of service in order to share in the allocation of profit-sharing contributions.

For work subject to prevailing wage laws, the Company will make contributions to the Plan to help satisfy the fringe benefit requirements of the law. During the years ended December 31, 2024 and 2023, the Company made \$290,055 and \$315,359 in prevailing wage contributions to the Plan, respectively.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching and prevailing wage contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description, continued

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also vested immediately in prevailing wage contributions made by the Company. Vesting in the Company's matching and profit share contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited services based on the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set to two percentage points over the prime interest rate. The interest rate is fixed for the duration of the loan. The maximum number of Plan loans that a participant may have outstanding at any one time is two. Loans will be considered in default if any scheduled loan payment is not made by the end of the calendar quarter in which the missed payment was due.

Payment of Benefits

On termination of service, a participant or their designated beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account. Annual installment payments are also permitted for required minimum distributions. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. The Plan provides for hardship withdrawals in the event of an immediate and heavy financial need in an amount not to exceed the lesser of the participant's elective deferrals or the amount of the financial need.

Forfeited Accounts

Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and are used to reduce Company contributions. In 2024 and 2023, respectively, forfeitures totaled \$7,054 and \$1,821, respectively, and forfeitures used to reduce employer contributions were \$8,362 and \$-0-, respectively. Total unused forfeitures at December 31, 2024 and 2023 were \$9,138 and \$10,034, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions

Participant and employer contributions are recorded in the year in which they are withheld or the underlying compensation is paid.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market and participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis of accounting. Net change in fair value of investments includes current earnings plus the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses to maintain the Plan are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees for the administration of notes receivable or distributions paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by Plan Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations of Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31:

4. Tax Status

The IRS has informed Ascensus LLC, the sponsor of the volume submitter profit sharing plan with CODA, by an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax period in progress.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. Transfer of Plan Assets

The Pacific Excavation, Inc. 401(k) Plan (the 401(k) plan) is also a 401(k) profit-sharing plan covering employees of the Company, which covers only employees with job classification of "manager," "supervisor," or "office worker." When participants of the Plan transition to one of these job classifications, they are transferred to the 401(k) plan. These transfers are included in the transfer of plan assets line of the statements of changes in net assets available for benefits.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): The Plan's investments are units of mutual funds held within a group annuity contract valued at the net asset value (NAV) of shares held by the Plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC and are deemed to be actively traded.

Pooled separate accounts (PSA): Valued at fair market value based on the NAV of the underlying mutual funds of units held within a group annuity contract. Pooled separate accounts measured at NAV are considered to have a readily determinable fair value.

Common/collective trusts: Units held in the common/collective trusts are valued using the NAV of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding and thus excluded from the fair value hierarchy. Participant transactions (purchases and sales) may occur daily at NAV. All common/collective trusts investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Party-in-Interest Transactions

Certain Plan investments are managed by Principal Life Insurance Company, one of the custodians of the Plan, and therefore these transactions qualify as party-in-interest transactions. Administrative fees paid to Principal Life Insurance Company for 2024 and 2023 totaled \$21,832 and \$17,761, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, the affected participants would become 100 percent vested in their employer contributions.

10. Non-exempt Transactions

For the years ended December 31, 2024 and 2023, there were no delinquent participant contributions. Additionally, late participant contributions from a prior year totaling \$53,673 were not yet corrected as of December 31, 2024. These transactions constitute prohibited transactions as defined by ERISA. In 2025, the Company has taken the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest. The Company has also further implemented a procedure to ensure that all future remittances are made within the prescribed time period.

11. Subsequent Events

Plan management evaluates events and transactions that occur after the statements of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
