Opinion

We have audited the accompanying financial statements of Brick Masons' Health and Welfare Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of April 30, 2025, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

APRIL 30, 2025 AND 2024

NOTE 1 - DESCRIPTION OF THE PLAN

The Brick Masons' Health and Welfare Trust Fund (the "Plan") is a multiemployer health and welfare benefit plan providing hospital, medical, prescription drug, dental, vision and other benefits for eligible participants and their dependents. For eligible participants, life insurance and accidental death and dismemberment are also provided. The Plan covers eligible participants as provided in the collective bargaining agreement between the contributing employers and Local 4 California of the International Union of Bricklayers and Allied Craftworkers, AFL-CIO. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Benefit Obligations

Estimated future benefits based on participants' accumulated eligibility - lag months and estimated bank hour liability were estimated based on monthly premium costs and hours accumulated in each participant's hour bank. Claims payable and claims incurred but not reported are an estimate of the cost to the Plan for claims incurred by the participants under the terms of the Plan through the year ended April 30 but paid by the Plan subsequent to April 30.

D. Contributions

Employer contributions as reported are contributions made by employers on behalf of employees for hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts. Employer contributions are based on employee hours worked at hourly contribution rates agreed to in the collective bargaining agreements.

An active participant who loses coverage because of certain events may elect to continue health care coverage for a temporary period under the Consolidated Omnibus Budget Reconciliation Act (COBRA). A participant must make self-payments to continue his or her coverage under COBRA.

A retired participant, upon the exhaustion of bank hours, may elect to continue health care coverage under COBRA or the Retiree Benefit Plan. A retiree must make self-payments to continue coverage under both options.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

E. Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

F. Eligibility

Employees and their dependents become initially eligible on the first day of the second calendar month after the employee has worked at least 400 hours in four consecutive calendar months or less for which contributions are required.

G. Continuation of Benefits (Hours Bank Provision)

The Plan requires 120 hours of covered employment for continued benefit eligibility. Any hours worked in excess of 120 hours per month are accumulated in an hours bank subject to a maximum accumulation of 600 hours. Based on the 120-hours-per-month eligibility requirement, a maximum accumulation of 600 hours would provide five months of continuous benefit eligibility.

The continuation of benefits under the hours bank provision is available to members for whom current employment is less than the hours required for regular benefit eligibility. Active participants with at least one hour in their hours bank may purchase additional hours, up to the number of hours required for regular benefit eligibility, at \$12.52 per hour for the year ended April 30, 2025 and \$11.91 per hour for the year ended April 30, 2024. The actual liability for continuation of benefits under this provision is for any month in which current employment is not sufficient to provide regular benefit eligibility.

H. Tax-Exempt Status

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

I. Investment Valuation and Income Recognition (Continued)

BNY POST INTERMEDIATE TERM HY FUND LP seeks to achieve a high rate of return relative to the three year United States Treasury yield by primarily investing in a portfolio of short-to-intermediate term, lower volatility, high yield debt and other fixed income securities.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) of investments includes gains and losses on investments bought and sold as well as held during the year.

J. Reclassification

Certain information from the April 30, 2024 financial statements has been reclassified to conform to the current year presentation.

NOTE 3 - RELATED PARTY TRANSACTIONS

The Plan was owed \$45,633 and \$39,776 from various related Plans and organizations at April 30, 2025 and 2024, respectively.

NOTE 5 - CONCENTRATION OF CREDIT RISK

During the year ended April 30, 2025, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

NOTE 6 - PLAN TERMINATION

In the event of termination, Plan assets are to be used first for the payment of expenses and benefit payments incurred up to the date of termination and expenses incident to such termination.

Any remaining assets will be distributed in such a manner as the Board of Trustees determine will carry out the purpose of the Plan, including but not limited to the purchase of existing insurance benefits on a pro-rata basis or the transfer of such funds to a successor trust having the same or similar purposes for the benefit of employees. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of participants.

NOTE 7 - RISKS AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risk in the near term would materially affect the amounts reported in the financial statements.

Benefit obligations are reported based on certain assumptions pertaining to health care inflation rates and participant demographics which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through January 20, 2026, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.


