Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Detroit Symphony Orchestra, Inc. Non-Musicians' Tax Deferred Account Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of April 30, 2025 and 2024 and the related statement of changes in net assets available for benefits for the year ended April 30, 2025 and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Detroit Symphony Orchestra, Inc. Non-Musicians' Tax Deferred Account Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all nonmusician employees of Detroit Symphony Orchestra, Inc. (the "DSO"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides employees the opportunity to contribute a portion of their compensation as a pretax deferral subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants are eligible to contribute to the Plan immediately upon hire unless they are considered an excluded employee.

Certain participant contributions in 2024 and 2025 were paid after the time frame required by the Department of Labor. The DSO will remit the lost earnings related to these contributions to the Plan in 2026.

The Plan provides for employer matching contributions for all participants of 100 percent of the participant's contribution, not to exceed 2 percent of a participant's eligible compensation.

The Plan provides for employer fixed contributions for all participants of 1 percent of the participants' eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the DSO's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary contributions and any income or loss thereon. Vesting in the DSO's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants fully vest in contributions made by the DSO after one year of service, as defined.

Benefit Payments

Distribution of a participant's elective deferrals and any employer contributions are payable upon termination of employment, the incurrence of a disability, or the attainment of age 59½. Participants' elective deferrals may also be distributed on account of hardship or at any time with respect to pre-1989 elective deferrals in an annuity contract. Distributions may be received in the form of a lump sum, partial payments, installment payments, or an annuity amount. Certain amounts invested in the TIAA Traditional Annuity may not be distributed in a lump sum (see *Redemption Restrictions* below).

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document. The DSO must approve any such hardship withdrawals.

Redemption Restrictions

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participant to transfer or withdraw from the fund. Transfers from the Retirement Choice (RC) contract must be paid over 84 monthly systematic payments. Withdrawals from the RC contract are available within 120 days after termination of employment, subject to a 2.5 percent surrender charge; otherwise, they must be paid over 10 annual installments or 84 monthly systematic payments. The remaining contracts under the TIAA Traditional Annuity investment do not have restrictions related to transfers and withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA CREF); TIAA Trust, N.A.; Fidelity Management Trust Company (Fidelity); or their affiliates. TIAA-CREF is a service provider of the Plan, and Fidelity and TIAA Trust, N.A. are custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the DSO has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value except as noted below.

The TIAA Traditional Annuity is a guaranteed annuity account issued by TIAA that invests in the general assets of TIAA. TIAA considers the Retirement Choice Plus (RCP) contract to be benefit responsive. TIAA considers the RC contract to be non-benefit responsive. The benefit-responsive portion is reported at contract value. The non-benefit-responsive portion is reported at fair value. Since there are no specific securities in TIAA's general account related to these contracts, contract value is the best estimate of fair value. Contract value represents principal invested plus interest earned, less any withdrawals and fees.

The pooled separate account is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets, which consist primarily of rental property subject to long-term leases and have been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with risks involved. There are no redemption restrictions or unfunded commitments on this investment. All other investments are valued based on quoted market prices reported in active markets. See Note 6 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the DSO.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 9, 2026, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

TIAA-CREF; TIAA Trust, N.A.; Fidelity; Newport Trust Company; and Ascensus Trust Company hold the Plan's investments and execute related investment transactions. TIAA-CREF has the authority to certify the investment balances and related investment activity on behalf of TIAA Trust, N.A. Ascensus, LLC administers the Plan on behalf of Ascensus Trust Company. Ascensus, LLC, as agent for Ascensus Trust Company, has certified the investment balances and related income as an authorized representative of Ascensus Trust Company. The investment balances and related investment results included in the accompanying financial statements and supplemental schedule of assets held at end of year, other than mutual funds with Fidelity and Newport Trust Company, are based solely on information provided by and certified by TIAA-CREF, including on behalf of TIAA Trust, N.A. and by Ascensus, LLC, as agent for Ascensus Trust Company.

The Plan's investments in mutual funds with Fidelity and Newport Trust Company, LLC totaling \$1,131,231 and \$1,069,912 at April 30, 2025 and 2024, respectively, and related investment income of \$110,586 for the year ended April 30, 2025 were not certified.

Note 4 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated January 1, 2018. The Plan has not individually sought its own determination letter.

Note 5 - Group Annuity Contract

The total TIAA Traditional Annuity balance was \$8,163 and \$8,183 at April 30, 2025 and 2024, respectively. Based on the terms of the contract, a portion of the TIAA Traditional Annuity is considered benefit responsive. The benefit-responsive portion totaled \$8,083 and \$8,105 at April 30, 2025 and 2024, respectively, and is held with TIAA-CREF. TIAA-CREF is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a vintages approach. Under this methodology, TIAA groups the dollars it receives over defined time periods into vintages and determines a crediting rate for the applicable vintage. Interest crediting rates are determined during the accumulation phase of the applicable declaration year. When establishing interest crediting rates for this product, TIAA considers many factors, including the net investment earnings rate of the TIAA assets supporting that vintage, administrative expenses during the time period, and required contingency reserves. The minimum crediting rate for the benefit-responsive contracts is generally 3.00 percent; however, in some recent contracts, the rate is between 1.00 and 3.00 percent.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measure attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Note 6 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

The following tables present information about the Plan's assets measured at fair value on a recurring basis at April 30, 2025 and 2024.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
