Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of UTF Trucking Bargaining Unit 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of the Plan

The following description of the UTF Trucking Bargaining Unit 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

Effective May 16, 2022, the Fresh Direct Bargaining Unit 401(k) Plan was amended and restated. The Fresh Direct Bargaining Unit 401(k) Plan changed its legal name to UTF Trucking Bargaining Unit 401(k) (the Plan).

General

The Plan is a defined contribution plan for the benefit of certain eligible employees, as defined in the Plan Document, of Fresh Direct Holdings, Inc. (the Company or Employer) and its participating affiliate, UTF Trucking, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's Fiduciary Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

In January 2021, the Company was acquired by Ahold Delhaize USA (Ahold). In November 2023, Ahold sold the Company to Getir US Inc. The Company remained as the Plan sponsor.

Eligibility

All eligible United Food and Commercial Workers (UFCW), Local 2013 union employees of the Company and UTF Trucking, Inc. who have completed six months of service and are age 18 or older are eligible to make voluntary participant contributions. Certain employees may be excluded from participation if they fall within certain categories as defined in the Plan Document, including all non-members of UFCW Local 2013.

Contributions

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan Document, up to the maximum limits of the Internal Revenue Code (IRC). The Plan permits Roth elective deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant; these deferrals will increase by 1% on the first day of each calendar year up to a maximum of 5%. Participants direct the investment of all contributions into various investment options offered by the Plan.

Effective January 1, 2023, the Plan was amended to provide for a discretionary Employer matching contribution. The maximum amount that an eligible participant can receive in a discretionary Employer contribution is 4% of eligible compensation, as defined by the Plan Document. With certain

exceptions due to death, disability, or termination of employment on or after normal retirement age, an eligible participant is required to be employed on the last day of the Plan year in order to be eligible to receive the discretionary Employer matching contribution. In October 2024, \$1,415,491 in discretionary Employer matching contributions were funded to the Plan for the 2023 Plan year.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, Employer contributions, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings and losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the vested portion of their account. Participants direct the investments of their accounts into various investment options offered by the Plan.

Vesting

Participants are vested immediately in their pre-tax and Roth deferrals, rollovers, and discretionary Employer matching contributions plus the allocated earnings thereon.

Notes Receivable from Participants

Participants may borrow from their account balance up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance, reduced by the highest outstanding loan balance in their account during the prior 12-month period. The Plan requires a minimum loan of \$1,000. Loan terms range from one to five years; however, terms may exceed five years, as defined in the Plan Document, for the purchase of a primary residence. Each participant may not have more than one loan outstanding at any time and may only have one new loan per Plan year.

The loans are secured by the balance in the participant's account and bear interest rates commensurate with local prevailing rates at inception of the loan, as determined quarterly by the Plan administrator. Principal and interest are repaid through a payroll deduction agreement, except to the extent the Plan administrator determines payroll withholding is not practical given the level of the participant's wages, the frequency with which the participant is paid, or other circumstances.

Payment of Benefits

A participant may elect to receive the value of the vested interest in his or her account in the form of: (a) a lump-sum distribution as of the most recent valuation date, (b) installment payments, or (c) any other forms noted in the Plan Document. Upon termination of service due to reaching retirement age, disability, or death, a participant is considered fully vested. Participants may withdraw an amount at age 59½ if certain criteria are met. In addition, the Plan allows for hardship distributions if certain criteria are met. Account balances less than \$5,000 will automatically be paid directly to the participant upon the participant's severance from employment unless the participant elects a direct rollover.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$53,634 and \$51,787, respectively. These accounts, comprised of uncashed checks, may be used to pay administrative expenses and reduce future Employer contributions. No forfeited funds were used to pay administrative expenses or fund Employer contributions in 2024.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Participant contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. The discretionary Employer matching contributions are recorded in the relevant period in accordance with the terms in the Plan Document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan payments and the loan is deemed a distribution, based on the terms of the Plan Document, the participant's loan balance is reduced, and a benefit payment is recorded. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefits Paid

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Other Income - Revenue Sharing

The Plan has entered into an agreement with Transamerica Financial Life Insurance Company (Transamerica) to maintain an Expense Budget Account (EBA), which may be used to pay Plan-related expenses. The EBA is a plan-level unallocated account held under the terms of the Plan, which may be credited with revenue in excess of the amount of compensation that Transamerica received during the year. As of December 31, 2024 and 2023, the EBA had a balance of \$7,220 and \$6,171, respectively. During the year ended December 31, 2024, additions totaling \$23,828 were credited to the EBA and are reflected as Other income in the statement of changes in net assets available for benefits. During the year ended December 31, 2024, approximately \$23,000 of the EBA funds were used to pay Plan-related expenses.

Net Transfers

In the event that a Plan participant has a change in employment status such that the participant is no longer eligible to participate in the Plan but is eligible to participate in another defined contribution plan maintained by the Company or affiliate, the value of such participant's accounts will be transferred to the other plan when the participant has become eligible as a result of the change in employment status.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company and Transamerica Trust Company, each a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described as follows:

Level 1 - This level includes inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - This level includes inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - This level includes inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust - The fair value of the investment in the common/collective trust is valued at NAV, as a practical expedient, as reported by the sponsoring financial institution. The NAV is determined by reference to the value of the underlying assets owned by the common/collective trust, minus its liabilities, and then divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the common/collective trust will sell for an amount different than the reported NAV. The Plan's common/collective trust consists of the Reliance/MetLife Stable Value Fund, which is composed primarily of fully benefit-response investment contracts. There were no redemption restrictions for this investment, and there were no unfunded commitments as of December 31, 2024 and 2023. The collective trust fund is a direct filing entity.

Interest-Bearing Cash - Interest-bearing cash is valued at fair value, which approximates cost plus interest earned in the cash account. Interest-bearing cash is a non-participant directed investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had no assets that were measured at fair value on a nonrecurring basis as of December 31, 2024 and 2023.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Reliance Trust Company and Transamerica Retirement Solutions, LLC (TRS), the Plan's recordkeeper. Any purchases and sales of these funds qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants, fees paid to TRS, and investment advisory fees paid to Morgan Stanley also qualify as exempt party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant's individual account balance would remain 100% vested.

7. Tax Status

The Plan uses a Non-Standardized Pre-Approved Profit-Sharing/Money Purchase/Cash or Deferred Arrangement (CODA) plan document sponsored by TRS. The IRS has determined and informed TRS

by a letter dated June 30, 2020 that the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has subsequently been amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, the Plan is permitted to rely on TRS' opinion letter.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Risks and Uncertainties

The Plan holds investments that potentially subject the Plan to concentrations of risk, such as investments of the Plan's trustee. The Plan provides for various investment securities, which include investments in any combination of mutual funds and a common/collective trust. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Plan's financial statements. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

9. Subsequent Events

In October 2025, \$1,385,064 of discretionary Employer matching contributions were funded to the Plan for the 2024 Plan year.

The Company evaluated subsequent events through February 13, 2026, the date these financial statements were available to be issued, and determined that no other material subsequent events have occurred that would affect the information presented in the accompanying financial statements or require additional disclosure.
