Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the financial statements of the East Georgia Healthcare Center 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended April 30, 2025, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of April 30, 2025 and 2024, and for the year ended April 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. 1. Description of Plan

The following description of the East Georgia Healthcare Center 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) plan covering all employees of East Georgia Healthcare Center (the Company) except those employees who are non-resident aliens or collective bargaining employees. Employees are eligible to participate in the Plan upon attaining the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants are eligible for the employer discretionary matching contribution after attaining age 18 and one year of service.

Contributions

All eligible employees are automatically enrolled into the Plan and pre-tax contributions are withheld at 3% of eligible compensation unless the employee elects differently. Each participant may make pre-tax contributions of up to 50% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 for the fiscal year ending April 30, 2025, plus up to an additional \$7,500 catch-up deferral for participants who have reached at least 50 years of age by the end of the year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make discretionary matching contributions. For the year ended April 30, 2025, the Company approved an amount of \$.50 for each \$1 contributed by the participant up to the first 6% of the participant's total eligible compensation. Participants are required to be employed as of the last day of the Plan year and have at least 1,000 hours of service to be eligible for discretionary matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, any Company contributions and earnings or losses on the investments in their account and is charged with certain administrative expenses. Participants direct the investment of their account into various investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and rollovers plus actual earnings and losses thereon. For Company discretionary matching contributions, participants vest 20% per year, beginning after 2 years of service and are fully vested after 6 years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their vested account balance. A participant may have one note receivable outstanding at any time. The notes receivable are secured by the balance in the participant's account and bear a reasonable rate of interest, as defined in the Plan document. At April 30, 2025, notes receivable had fixed rates of 4.25% to 9.50% for the term of the note, not to exceed 5 years, unless used for the purchase of the participant's primary residence. Principal and interest are paid through payroll deductions. All notes receivable must be repaid immediately after termination of employment or death.

Payment of Benefits

At the time of death, termination of service, or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in the form of a lump-sum or installment distribution. The participant's contributions may also be withdrawn in certain hardship situations. Participants may withdraw the vested interest in their account upon attainment of age 59½.

Forfeited Accounts

Forfeited non-vested account balances totaled \$51 and \$50 as of April 30, 2025 and 2024, respectively. These accounts are used first to pay administrative expenses and then to reduce future Company contributions. During the year ended April 30, 2025, the Plan used \$3,400 to pay for administrative expenses. Subsequent to year end, the Plan used approximately \$8,300 of forfeitures to reduce the Company contributions recorded at April 30, 2025.

Participant Transaction Fees

The Company pays certain administrative expenses of the Plan that are not paid by participants. The Company does not expect reimbursement for these expenses. Participants are charged a fee of \$5 quarterly for administrative expenses of the Plan related to recordkeeping services. Certain transaction fees for withdrawals are charged directly to the participant.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. Company discretionary matching contributions are considered payable to the Plan upon approval by the Company. Any unfunded participant or Company discretionary matching contributions are included in the employee or employer contributions receivable on the statements of net assets available for benefits as of April 30, 2025 and 2024.

In accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 326, *Financial Instruments—Credit Losses*, the Plan estimated the current credit risk associated with the contributions receivable. After giving consideration to the risk characteristics, historical payment experience, current conditions, and reasonable forecasts, the Plan determined that no allowance for credit losses was necessary and there was no current year activity in the allowance for credit losses.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, except for the AUL Stable Value Account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of April 30, 2025 or 2024. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through February 13, 2026, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule regarding investments held, including investments held and notes receivable from participants at April 30, 2025 and 2024, and the net change in fair value of investments, interest on the AUL Stable Value Account, and interest income for the year ended April 30, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American United Life Insurance Company, a OneAmerica Company (AUL), the Plan's qualified institution.

4. Investments

Plan investments include units of a fully-benefit responsive investment contract managed by AUL. AUL is the certifying entity as defined by the Plan; therefore, transactions in these investments qualify as party-in-interest transactions.

Investments are exposed to several risks, such as market, interest rate, currency and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, etc. It is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Investments in mutual funds are based on quoted market prices for the identical security in an active market (Level 1).

The AUL Stable Value Account is a fully-benefit responsive investment contract and is a general obligation of AUL. AUL maintains the contributions in a general account. The account is credited with contributions and charged for participant withdrawals and administrative expenses. AUL is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value of the guaranteed income fund represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with AUL but may not be less than 1.5%. Such interest rates are reviewed on an annual basis for resetting.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer discretionary matching contributions.

6. Income Tax Status

The Plan uses a volume submitter plan created by OneAmerica Financial Partners, Inc. (OneAmerica), an affiliate of the certifying entity. OneAmerica received an opinion letter from the Internal Revenue Service dated November 22, 2017, which states that the volume submitter document satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the OneAmerica opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

7. Late Remittances of Participant Contributions

For the year ended April 30, 2024, employee withholdings of \$1,426 were not remitted within the appropriate time period by the Company. This transaction constituted a prohibited transaction as defined by ERISA. The Company identified the error and corrected it by remitting the contributions and lost earnings in October 2024.
